Mother denied any specific imminent threats to harm himself, and denied any knowledge of any specific plan or method. Mother agreed to attempt to contact patient this morning to assess his well being, and would contact this clinician again to update.

Provided patient with information for Mecklenburg County Magistrate's office for Involuntary Commitment Process, and encouraged mother if she was not able to reach patient to contact 911/Law Enforcement and encourage a "welfare check" to patient's residence. Mother agreed
