

Starting around April 2021, I start to inundate the US DOJ criminal division's email inbox with communications. I type them some letters, but my main method of communicating is sending them audios. I would send them many hours of audios at a time. For example, one set of audios, that I called `dojUpdateSeries`, consisted of 36 audios I had recorded over a period of a week or more. There was likely 10 to 15 hours of audios total, in that series.

As my situation becomes more dire, I send more and more audios. I do this even after I have figured out that the US DOJ is sponsoring a cover up and sponsoring crimes against me. I very naively send them communications asking for help.

On July 18, 2021, I send the US DOJ an audio called "`aboutMyCondition.mp3`". In this audio, I mention that I am worried that Atrium Health might take away my Adderall, over my having abused it in the past. I tell them that I have got that situation taken care of, that I do not abuse it anymore. I tell them that without my Adderall, I turn into a vegetable, and that I cannot get anything done. This starts at 5:14 on the audio (called `aboutMyCondition.mp3`) and ends at about 7:05.

I realize my mistake, on August 12, 2021, during my next appointment with Atrium. The appointment was a virtual video visit. The conclusion of this appointment was that they are taking away my Adderall and putting me on 20 mg of Olanzapine. Before this, I had taken a variable dose of Olanzapine. I took 5 to 10 mg a day, taking 5 mg pills.

Why do they do this? Why do they take away my Adderall and double or quadruple my Olanzapine? They do this to cripple me. I have given them this idea in my audio, when I tell them that without Adderall I turn into a vegetable. Olanzapine (aka Zyprexa) has a long history,

known very well to Atrium, of causing me cognitive impairment. They take away the medication that helps me the most, and pointlessly jack up the medication that causes cognitive impairment. The US DOJ isn't interested in helping me. When I send them audios pleading for help, they go through them looking for info they can use against me in criminal abuse.

Atrium's notes for this 08/12/2021 visit are full of fraud. Atrium makes claims that I am "paranoid", "psychotic", and "manic". They also reference me perseverating on "delusions".

Within a few hours after this visit was over, I started making some audios for the US DOJ. I title them "lastAudios". I have a screenshot of the timestamp when those audios were created. You can verify that they were created on 8/12/2021 with that screenshot. I had copied them from one folder to the next, if I recall right.

You can listen to these audios, and see that I am very clearly not manic, psychotic, or paranoid. This is flat out fraud. To provide context, I was making these audios for the DOJ to tell them that I'm throwing in the towel. That's why I called them "lastAudios". At the time, it seemed clear to me that any attempts I make, to make my situation better, are only going to backfire. I needed my medication, and if they're taking my medication, that is a step too far.

I am also crying in the beginning of the audio. I talk about how "the people on the other side are helping me". When I say "the people on the other side", what I mean is the people who receive the emails that I send to the US DOJ Criminal Division's inbox. From very early on, it was apparent to me that both Atrium Health and Wells Fargo get what I send to that inbox. I have to speculate as to who else receives what I send the US DOJ.

This crying is part of a recurring thing that has happened during this battle. It is a result of not being able to cope with the reality in front of me. It starts in April and May 2019, as I am talking to my old manager Courtney. During those chats, I am feeling horrific pain, and Courtney will not help me. She continues to lie to me. This creates a drive in me to rationalize this situation, in a way where I am not so worthless.

This drive to rationalize this situation and this condition where I am not able to cope with reality returns hard, after I send my complaint to the US DOJ. I have been massacred with crime. I am in horrific pain every day. They do nothing for me and they sponsor a cover up. Their cover up involves crimes against me. They continue to commit crimes against me and to pound me with abuse, even after I tell them that I'm almost dying in my sleep. I can't take this, so I will tell myself stuff like "the people on the other side are helping me", "the people on the other side have done a lot for me", etc. It is a reaction to extreme trauma and to having been treated as a completely worthless human being for over 3 years

The preceding explanation should help you make sense of these audios. Any professional with any acumen at all should be able to tell that I am completely ok in those audios. I am not manic, psychotic, or any of this other garbage they claim. What I learned here is that I've got to be careful what I send the US DOJ, because they just go through it looking for ways to abuse me. Even after this, I continue to send audios to the US DOJ, begging for help. It seems foolish, but when the United States of America turns against you, I don't know who you can go to for help.

You can see Atrium referencing my cognitive issues with Olanzapine in the documents titled cognitivelssues01.pdf and cognitivelssues02.pdf. Atrium seems to reference this far less than I talk about it. It is very well known among my providers. It is the reason that we went to a variable dose of 5 mg to 10 mg. I would take 5 mg some days and 10 mg on other days. This was to minimize my cognitive impairment and still manage my condition.
