If I had any hope of these hospitals being honest with me, I could get medical treatment and other treatment. What I have right now is you sponsoring criminal victimization of me through them.

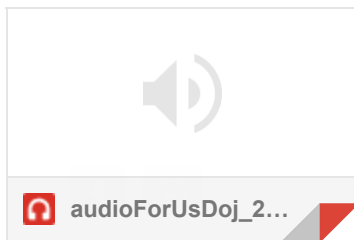

What I wanted to know was what is behind me and others who have an acute psychosis saying these disturbing sounding things. I wanted to know what it is at the biological level.

My hunch was that it had to do with fact that the human brain has primitive structures at its lower parts. We have structures in our brain that resemble a crocodile's brain. We share common brain structures with many primitive animals, and this is why we have a dark side, meaning this is why we have aggressive impulses, why people enjoy violent movies, why some people have repressed sexual desires that are taboo (or have such desires that are not repressed), etc.

It made sense to me that when the brain becomes less regulated and contained that these primitive structures could express themselves in an uninhibited way. What I learned was not far from what I had thought and that I just described to you.
