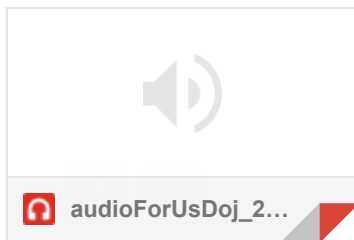

Then I offered to settle this for \$8 million. Then I offered to settle this for \$3 billion. Then I offered to settle this for \$10 billion. All of these figures are at a huge discount, compared to what a jury would give me in a fair trial. I will never get a fair trial due to the extreme criminality of the Justice department and of Wells Fargo.

You are murderers whose cruelty has no parallel. The rest of the world will see this. You have no decency and you are a bunch of cowards. You will not be able to hide from the decency of other people.

I am a ruined human being. Right now I feel like a man trapped in a cage in the jungle. I get this feeling a lot and it makes me a dangerous person. A surefire way to trigger it is to raise your voice to me. Anyone who raises their voice to me is risking their life in a serious way. For sure they need to shut the fuck up after the first time, if they survive that. Most likely they will die after the first time, unless they immediately leave the apartment.

Right now I'm by myself and I'm feeling extremely hostile. I am feeling a hyper vigilance and an emotional pain based hostility.

There is something very bad wrong with me. This hostility is something that I cannot help and I cannot control and it is very hard to explain. I am not in control of myself but at the same time I picture myself as having an ability to be calculating, if needed. I'm not sure.

What I mean there is that, say for example I'm in a gas station and someone belittles me. I will not be in control of myself but I can still think long term. Here I am using the word long term in a different sense. I don't mean a week or a day or a year or 5 years. What I'm saying is that I am not locked into carrying out the violence immediately, like it's a reflex. I can wait for the right time to make my move. Like say the person is bigger than me and I don't have a knife or other weapon to grab. What I picture happening is this emotional pain will persist and I will be kind of focused. Also note that anyone who pays anything like close attention to me will be able to tell that there is something very bad wrong with me. This mental state I get in is very different and my physiology and the way I behave and the look I get in my eyes, all of this would stand out. I picture that someone who is watching me would know that something very bad is wrong with me and that something bad is about to happen. They would recognize that I am contemplating violence.

But to get back to the narrative, being belittled or yelled at causes this extreme emotional pain that is accompanied by a powerful drive to kill the person who caused it. I am still able to be strategic, and what I picture happening at a gas station is that I would run over the person with my car. I would wait for them to exit. This pain would be sustained as I wait for the person. I would want them to suffer as much as possible, and I would be likely to try to prolong their death if possible, like maybe run over their legs over and over, then run over top of their torso. This pain that I feel makes me want to hurt people very badly. It's not just murder. It is a general violent impulse to massacre the hell out of the person.

I am still ultimately not in control of myself. It may seem that I am, as there is an element of planning and calculated action. This pain has to be discharged. To not do that is not an option. It is unbearable. I am glad that there isn't anyone in here with me now. Right now I feel like it wouldn't take much provocation.

This bank did this to me. Why? All I asked for was a conversation and now I'm a ruined human being.

I got a little hostile on a friend the other day when he sent me a text message. Nothing remotely like what I've described to you. He sent me an innocuous text that just happened to trigger me. It doesn't take much. It wasn't anything that would make me want to kill him. Not even close. But I explained to him my hostility and how I feel. I'll copy and paste it here:

I can maintain my situation indefinitely if I have money and my own place. I can spend the majority of my time alone and I can debrief anyone who visits me on my condition.

I can tell you for 100% fact, that if I were living with anyone except my mother right now, someone would already be dead.

My mother almost never asserts her needs or gets angry and she's not here much due to working so much. Any other roommate would be very irritated by my constant complaining of my torment and suffering and by my peculiar habits, like pacing the floor a lot and being up at all hours of the day and night.

They would complain and gripe and raise their voice to me and I would kill them. I am so incredibly hostile that if I had to, to get back at them, I would burn down the place with both me and them in it

Here is a second text:

It is not the kind of hostility that most people are familiar with or can understand.

It is not the kind of hostility that an abusive husband has towards his wife, or that an abusive man will tend to have towards people in general. It is an emotional pain based hostility.

Imagine being trapped in a wooden cage in the jungle, by some depraved and cruel men who would torture you daily through the holes in your cage. Imagine that they taunt you and poke you with wooden spears and other objects, and your cage being so small that you cannot dodge the sharp instruments that they poke through your cage. You feel helpless and you are continually humiliated. Over time the humiliation and the helplessness and the demeaning attitude of your captors will have permanently changed you. You will have an incredible hostility out of feeling continually threatened and abused.

That's exactly how I feel and it gets extremely acute when I'm in the presence of people. The least little thing they do will inflame me. It causes this extreme and very tormenting feeling of emotional pain and humiliation, and I feel like the only way to cure that feeling is to murder the person causing it.

This is what I go through while you minimize what has happened to me, deny this bank's responsibility for it, and massacre me with crime. Why are you this way to me?

You never get a full dose of how bad off that I am because when I make my audios when I'm doing good. This is by design. There is no way that I could make audios right now. There is the added fact that audios are one way. You have little ability to provoke me. This is unless I think of something you do that pisses me off, and that's not even the kind of provocation that I'm talking about. In that case I would yell and scream at you.

It would be different if you were here and you belittled me in any way. Say you are carrying a gun like law enforcement typically do. I would start scheming as to how I could get your gun or as to how I could sneak and get a knife to stab you in the back as you leave. If you belittled me in a big way, like a deliberate mocking, it would be worse. I would try to hide my mental state, as to not alert you to my intentions, but it is very likely that you would notice that something is off about me.

My neighbor was calling me names as I walked outside, many months ago. I had a reflex action where I start to yell and curse at him. The way I looked when I did that would give you the impression that I am mentally retarded in some way. A common element to all of this is that it is visibly apparent that something is wrong with me. But I walked in the apartment and my hostility went down. That surprised me. When I knew that I would be moving here, I was very worried that I would kill him within the first few days. He was a bastard back before I was disabled and I would visit here. I thought that if he started his shit things would fly south.

I can tell you that right now wouldn't be a good time for him to start his shit.

The business as usual thing to do with someone like me is to permanently institutionalize them. To me this is not fair and I know for 100% fact that I can manage this situation. I do pretty good living with mom and I would do even better if I lived by myself.

I am in terrible torment as it is. I miss my apartment in Charlotte and I suffered terribly even in there. It would be unbearable to be at some facility for the next 30 years. Those places are hell even when I was healthy.

If I get help from you things can be different. Most likely I will still want to die, but I can have something good in life in the meantime. There is something about my intuition, where my intuition is very accurate in some things, and I pick up on stuff that no one else would.

For instance, these stress based heart injuries from 2021, the doctor told me that it was not that. He said that it couldn't be, because it would show up on the tests that he ran. I knew that he was wrong. I got home and looked it up, and I found a medical website that explained that your tests might still come back normal. Assuming that these injuries leave any kind of bruise or mark, if I had died around that time, they could do an autopsy and they would find several of them.

Another example is this thing that I have with my heart now, where I seem to be teetering on the edge of heart disease or maybe have it, I called this in August 2021. I could feel this stress I was under frying my body. I knew that if I lived to see the near term future, I would have premature health problems. This thing with my heart is only the beginning. I would say that any and all organs that I have that are sensitive to stress have aged 25 to 40 years since April 2019. They particularly aged during August 2021. I would bet you anything you wanted to bet that I could be cut open and this would be confirmed.

I got off on a tangent, but the point is that there is something different about my intuition. It is because I have the quality of genius, I am almost certain. I have read a lot about geniuses and I have been called this my whole life. I am not being vain. It's just a fact. There is this book called the hidden qualities of genius (fact check me on that. It may be the hidden traits or the hidden secrets or something else. It is hidden (insert some word here) of genius) It describes me perfectly, as does a lot of the other things I have read. Some things that hidden book has, in particular, peg me far too accurately to be anything like a coincidence. another thing it talks about is how geniuses tend to be rotten, self-centered people, who run over the people in their lives like they're roadkill. That's exactly like me and I have to try really hard to not be that way. It's like I have this kind heart and I like to help people, but at the same time I'm so incredibly self-centered.

I got on another tangent, but one intuition that I have had in the past week or so is that my brain is broken and it can't figure out why. To make an analogy, I had kidney stones many years ago. It hurt like hell. I caught one of them in a mesh wire net type of thing they gave me. It was shaped kind of like a spoon, except instead of solid metal it had this kind of mesh wire. This kidney stone was tiny. So tiny that it was hard to see it. The nurse told me that I was not supposed to have my uriter blockec

with anything, and when something gets in there, my body will put me in hellacious pain to let me know that something is wrong.

What's happened to me is that my brain is injured and it's constantly trying to fix itself. It's like I have this automatic, obsessive focus on seeking out how to be better. Right now I focused on 10 billion dollars. What I sense is that, if I get 10 billion dollars, I will still be in the condition of feeling like I need something. It's like I will be constantly driven to find some way to be well, and it will be one thing after another. It is futile, because my brain will never be fixed.

People who abuse MDMA will often develop a craving for chocolate. This is believed to be because the molecular structure of a chemical found in chocolate resembles the molecular structure of a chemical in the brain that gets depleted from MDMA abuse. I have something similar, except my brain is having trouble figuring out what it is supposed to crave.

This is because there is nothing to crave. My brain is irreparably broken.

This thing that I told you about my intuition being accurate and seeing things that others do not, it has occurred to me, as I have been typing this, that I could research this thing about broken brains online. It is very probable that what I describe has been discovered by some scientist or doctor. This is the kind of thing that happens to me quite often. I nail some condition of reality and I do it seemingly blindfolded.

I came up with the concept called Laplace's demon when I was 12 years old. I did it just thinking. I didn't call it Laplace's demon, but it was the exact same concept. I had never learned anything about Laplace's demon at that time. At age 15 or 16, when I first started playing pool, I was laying in bed obsessing over how to aim, and I came up with an aiming system called the ghost ball system. I had never heard a thing about it. Had no clue it existed, and I came up with the literal exact same thing. Only difference is that I didn't call it the ghost ball system. I had no name for it.

Wells Fargo wanted me to talk to a neuroscientist. If they still have this guy on the line, show him what I have typed. I bet you anything it will make sense to him (or her).

You may not see your cruelty. It may be invisible to you. You are extremely depraved and god only knows what goes on in your warped, delusional mind. What I can tell you is that your cruelty will not be invisible to others. The outsourcing the cost is nothing new. Not much need to talk about that. The misunderstanding is the idea that there is any help for me. My brain is broken and it causes me terrible suffering. A brain is not like a car. They can't go in and fix what is damaged and then put it back together. Then the fact that I am handicapped makes everything so much worse. I spend so much time in terrible suffering. My living circumstances are also terrible. Life is torture for me.

What has the potential to help this is money. Money will not fix my broken brain. Money will allow me to have better living conditions. Money will allow me to pay people to do all the things that I cannot do for myself. Money will allow me to buy nice things and do other things that offset my suffering. Money will allow me to help people, which I like to do.

Even if I have money, life will be extremely hard. It will still consist of so much torment. But money will make it better. I want \$10 billion. If I get less I will take it. A big priority is writing my book. If I get less than \$10 billion, I will quite probably move to another country and then write my book. I'm not sure. I'd say for absolutely sure, if I get less than \$3 billion.

The benefit of a smaller amount of money would be that I would be able to move to a better country that isn't governed by such a bunch of depraved criminals and that is more humane. I have thought of writing to the government of Switzerland and asking them to pay for me to move down there, in exchange for the copyright to my book. I would also need them to pay for my living expenses. I think the people in that country might care about me. I could go on their news networks and share my experience. My book will also be something else.

My book will defend me. It will explain me. It will tell the story of my life, lived in so much pain. It will tell the story of Wells Fargo murdering my soul and of the depraved murderers at the justice department pounding me with crime when my body was about to die. I will talk of the extreme and inhuman prejudice of the justice department and of the federal reserve.

You offer so many examples of everything that it is worth aspiring not to be. I do not know how to explain your corruption. It is quite a phenomenon.

I talk badly about you all the time in my emails. This may upset you or come across as not nice. When I say something and then you don't like it, you are skipping a step. In that last email, I was probably inaccurate in saying that the days you don't get an email I'm doing better. That is true for a lot of the days but is likely not true of some others. I suffer every single day. We are past the point of no return. I'm not sure how long we have been past that point. What I mean is that I will never have a life that I am happy about, no matter what happens. I have been damaged too severely and my sense of self has been crushed. My physical health is also terrible and getting worse. This is just as I predicted. In July and August 2021, I knew that I would have premature health problems. I also felt it extremely likely that I die prematurely from natural causes. We will see if that comes to pass.

The lesson that I have learned here, you may be tempted to say is something like "don't fight Wells Fargo", but is actually "don't go near Wells Fargo." You've got people acting recklessly and carelessly in a very fragile world. Their actions are designed to break something, and it's against the rules for them to pay the price for their own conduct. So what gets you broken is everything they come into contact with, except themselves and their own circumstances. I had no choice but to fight them. I had to have a life and I had to have something in life besides nothing, and their crimes left me disabled and permanently injured.

I have this powerful and recurring drive to learn and master stuff and get good at stuff and advance my cause and advance my life, and I cannot do it. I am handicapped and that ability is gone. It is so painful. The way this drive will not go away has an effect of renewing my sense of loss every day, usually over and over again. My soul is crushed 1,000x a day, as I grieve for and long to be the person that I used to be.
