It will be somewhat hard to prove some of his crimes. I have reported a separate crime to you concerning unbelievable criminal behavior on the part of my former employer Wells Fargo. He is indirectly connected to that. He is the perpetrator involved in a subsequent complaint I will soon submit, which involves the production of pornography featuring a then 16-year-old girl, which occurred in the year 1999.

The victim, [REDACTED] friend named Mitzi could give her entire name. I have found Mitzi on facebook, but she does not respond to my messages. I believe [REDACTED] first name is Natasha.

I will be giving several witnesses, and all of them are high risks for you to contact, in my estimation. [REDACTED] "Bo" may be concerned over his involvement, as he was 18. Charlie was not involved, but I do believe there is a good chance that either he or Bo would compromise the situation by tipping off Kermit. The ability for people to send IMs through facebook and then delete them, along with the way things get around in small mountain towns would make it a nightmare, in my estimation.

I believe your best bet is to contact me, as I have far more to say than can be typed here. Then you can make a strategy. I will provide whatever assistance is necessary, including conducting recorded phone calls, where I try to get him to make incriminating statements. I am not happy about this, but this person is extremely dangerous. I have set up a website to share evidence of various crimes I have been subjected to and am aware of. I have a login for you and will give it in the event I am contacted. At current, it has mostly items that pertain to me, but I could share details on this subject as well, in a way that only you and other authorized parties would have access. It is a secure site, with password protected access.

I am reporting these decades old crimes because this man is dangerous. He seeks out women to have sex with constantly, and I am sure that many of these women have children. Repeated brain surgeries have severely impaired his ability to regulate himself or contain his impulses. I have no doubt that, if a proper diagnostic analysis was conducted, florid psychopathy would be detected. Since knowing him, I have observed the following disturbing behaviors and personality traits:

- Unbelievably horrific torture of animals, one of which occurred in my presence and others which he bragged about

- Intense racism

- Self-describing himself as “sadistic”

- A profound, and almost complete, lack of empathy

- Narcissistic devaluing of others and accompanying ruthless and cruel verbal disparagement

- A pervasive and never ceasing behavior pattern of manipulating others, the most frequent targets being women he grooms and lies to on facebook messenger.

- he told me he would “like to have another one”, in reference to the 14-year-old girl from my other complaint. In context, he meant by this that he would like to have sex with another 14-year-old.

- he once told several of us that he would like to make a “snuff video”. He said one had never been made. He says a “snuff video” is a video where “you fuck them then you kill them”

- Sometime between 2006 and 2011, he suggested that he and I should “Rape 10 women”. He seems to perceive me as having a similar pathology to him; I do not.

- Sometime after 2013, he said to me that “me and you need to do something like that”, in reacting to a YouTube clip about Leonard Lake and Charles Ng.

- He told me that he could kill someone and dispose of the body. That this would not bother him the least, and that he thought he was a sociopath.

\*There is no reasonable request you can make that will be denied. There is also no unreasonable request you can make that will be denied. I will help you with any and all crimes I have reported, however I can.

Please reference my other complaint concerning this same subject Kermit Johnson Jr. ("Perpetrator"). I will report the other crimes I am aware of and also the probable crimes I believe he has committed here. I will avoid duplicating information between complaints.

I am aware of a girl who Perpetrator had sex with when she was aged 15. He would have been 21 to 22, and he knew her age. She was given alcohol, and this sexual encounter was under psychological consent. I have very strong reason to believe that he often had sex with girls who were between ages 16 and 18, while the girls were intoxicated. He bragged about "getting the cherry" of a girl named Dorthey Johnson when she was 14.

The focus of this complaint is an incident I am aware of where he made a pornographic video with his then 16-year-old girlfriend ("Victim"). This was in 1999. They engaged in intercourse and possibly other sex acts. It appears that this video has been shown to others. At some point in the previous 13 years, he told me about this video. He told me that Victim lies and says she was not 18. He says she absolutely was 18.

I have recently made contact with Victim and she has informed me that she was 16 years old at the time this video was made. Victim's character and credibility trump Perpetrator's by many orders of magnitude, in my estimation. I have 0 doubt about her account. She has informed me that he has subjected her to ongoing harassment and/or distress, as he taunts and uses her family members for different purposes (including sex for hire on the part of Victim's sister).

Perpetrator has come under my attention because I deduced that he is the source of disparaging lies and/or exaggerated truths that made it to my workplace when Wells Fargo violated my rights. I have reflected and determined that something must be done about him. I view him as a natural disaster that has to be contained. I sometimes regret that he may have had a chance to be a better person, until his brain surgeries ruined his ability to inhibit his behavior.

I met Kermit at age 15 or 16. He was ~ 22. I didn't drive until I was 24 years old. I thus went wherever my friends went, and he was a relative of my friend Charlie. I liked Kermit, and myself and Charlie spent a good deal of time around him until I was about 19. I truthfully would have rather played billiards than hang out and shoot guns, watch movies, and do the other things they liked to do. I was addicted to billiards at that age, but I did like him and he seemed to like me. I witnessed a lot of disturbing behavior. He had a penchant for severely torturing animals. He was also very racist. He was socially inept, and this is part of the reason he chose to target young girls for sexual partners. That they were young and that he could get them intoxicated seemed to put them closer to his skill level.

I started hanging out with him again in around mid-2007. He was making an effort to be a better person. We were very good friends. A series of brain surgeries appear to have ruined him however. He appears to no longer be able to inhibit that bad side of him. His behavior is more egregious than ever. I am reporting these decades old crimes to you (I have another incident where he recorded child pornography), because I have determined that his lack of inhibition makes him extremely dangerous. I have been told by a reliable source that one of his lifelong friends has determined to never allow his children to go around him again. This was after a visit with his family, where this particular friend observed Kermit getting far too friendly and playful with his children. I was told this in such a way as to make it seem this friend believed him to have a sexual interest in very young children. This would not surprise me, and my best guess is that he has had this attraction the entire time I knew him, and been able to conceal it. He has recently started to talk to me again. I have no interest in being his friend, but am playing along as I feel that he needs to be exposed and prosecuted, for the safety of others.

The subject is a never married Caucasian man. He is a former employee of the N.C. Department of Corrections, and currently works "under the table" for his family's Christmas tree operation. He also owns a mobile home he receives rental income from, and he collects Social Security Disability Benefits, under what I believe to be a knowingly false pretense that he is disabled. His name is Kermit Johnson Jr. ("Perpetrator").

I spent a somewhat significant amount of time with him between the years 1996 to 2000 ("Time Period"), by my best recollection. I can attest to 3 sex crimes during the Time Period, and I suspect there are far more. His criminal behavior, I believe, largely consisted of statutory rapes against girls aged 15 and younger. His crimes also included having sex with intoxicated girls who were under the age of 18, to the extent that was a crime during the Time Period. These offenses, to my best knowledge, all happened under psychological consent, save one ("Rape Incident"). I was 17 years old at the time of the Rape Incident.

The crime occurred at a party at Perpetrator's mobile home. The participants in this party, other than the victim, were Perpetrator, myself, Bo, Charlie, and [REDACTED] close friend named Mitzi, who was also Bo's girlfriend (collectively "Participants"). [REDACTED] was well known among all Participants to be 14 years of age.

Perpetrator's plan involved having vodka for the girl to drink. She was taken to his bedroom, extremely intoxicated. I witnessed [REDACTED] on the bed completely naked, looking very dazed and distressed, and also perhaps in a state of shock.

The next morning, Perpetrator confirmed to Bo "it was tight, and I mean tight". [REDACTED] denied to Mitzi that anything had occurred. Many years later, it occurred to me that this was likely her trying to tell herself that this didn't happen in her mind, as a reaction to trauma from being raped against psychological consent. [REDACTED] was not known to lie about having consensual encounters.
