Out of the past 8 months, how many days have you lived in torment and torture because of Wells Fargo's conduct? The answer is 0. That is part of the problem. The answer for me is every single day. Until Wells Fargo's behavior is a problem for the justice department, the justice department will continue their cover ups and their allowing this bank to harm innocent people. 100% of the cost of this bank's conduct is being paid by me. It is the most immoral thing that I have ever seen.

I am now potentially facing another consequence of the Justice Department's cover up, Wells Fargo's crimes, and Atrium Health's crimes. What I need very badly is to get my Adderall back. As part of the cover up, Atrium Health took my Adderall away. They do this to cripple me. They substantiated their decision to take my Adderall away with a fraudulent healthcare record that stated that I was "manic." I am now seeing new healthcare people, and someone being manic is one reason to not give him or her Adderall. Again, I need my Adderall back very badly. If my new healthcare people see those records, it could cause me to not get my Adderall back. These fraudulent healthcare records could affect my ability to get effective medical care for the rest of my life. I am in a very fragile situation, currently, and I will not be able to get out of it if I don't get my Adderall back fast.

I am also facing the potential declining of my disability appeal. My nightmare will be compounded that much more. I needed a brain scan to document my disability. I got one for Wells Fargo's purposes instead. I did this because I was led to believe that I

would get help and a girlfriend if I got that brain scan. After I got it, I got nothing in return.

I believe that you can be better people. I need to get something out of my fight for justice. This crime spree has cost me so much that I need help from the outside to recover me. I ask that you help me and do what is right. I need at least \$100,000 if my disability appeal gets denied. That will fund my life and fund the specialized medical procedures and care that I will need to document my disability. I believe that I may have a hard disability to prove, and that if my records thus far do not work, I will need to get a lot of specialized care from neurologists and psychologists.

What I would like is enough money to fund my own life for the rest of my life. I have calculated that about \$8 million would do it. I think that this is more than fair. I have been damaged so badly. I have lost so much of my potential to make an income and my potential to enjoy life. I suffer every single day.

It doesn't have to be this way, where I am the enemy. I never made myself out to be your enemy; I am just being treated this way for some reason that I'm not sure of. I would like for you and Wells Fargo to reach into your heart. Whatever it was that had you getting me AU girl, go back to that place. What you did there was so wonderful.

I have been rotten to Wells Fargo, after they tried to help me. I have spoken about them in the worst terms. I have also been rotten to the Justice Department, sending the Justice Department audios where I curse them and threaten them. I am sorry for all of this. It is just that you have all done something terrible to me. I would like for us to all be friends and to make something good out of this situation.
