However, the decision to not criminally prosecute Wells Fargo is not consistent with the Justice Department's self-image of being an impartial enforcer of the rule of law. One way to resolve the dissonance that this creates is to rationalize that I am the bad guy. Another way is to grotesquely minimize the damage that Wells Fargo has caused. I suspect that one or both of these has likely taken place.

Then there is the fact that the Justice Department has been shown illegally obtained healthcare records, evidence of a very serious crime. Given that there have been no headlines about numerous people at Wells Fargo and Broughton Hospital being arrested, it looks like the Justice Department has done absolutely nothing about this crime. I believe that it is most probable that those healthcare records were not even confiscated. This is also not consistent with how the Justice Department likes to see itself or how the Justice Department likes others to see it.

I put this headline in to grab your attention to hopefully stop you from mindlessly sending this to Wells Fargo before you even look at it. By the time you receive this, I may have bought a VPN service, so that I can disguise my IP address. It wouldn't surprise me if the Justice Department has some kind of auto-routing set up, so that my stuff bypasses them completely and is sent to Wells Fargo. I see this as less probable for the OIG than it is for the email inbox where I send my other stuff.

You do not have a leg to stand on. You have made a mistake and you need to admit it. The complaint that I will be sending you has more about those healthcare records. I have done some more research as to why people in the condition that I was in say things like the things that I said. I have looked into the underlying biology, and I will share some of that in my complaint.

This narrative Wells Fargo has given you is total bullshit. You need to start viewing the people at Wells Fargo as criminals who need to be dealt with. Your resistance to this is preventing you from addressing the situation with Wells Fargo, which is much bigger than just what happened to me. This assumption that they are respectable, honest business people who wouldn't do what they did to me without good reason is wrong and unwarranted. I want Wells Fargo to fix its business. I want Wells Fargo to turn over a new leaf. This is despite the fact that all I get from Wells Fargo is ruthless cruelty and criminal abuse.

At the very least, you need to read what I wrote, because this same information will eventually be turned over to the media. My story is a bit of a tough one for the media, and my mental illness has gotten in the way a lot, but I am making progress.

I will again reemphasize that it is absolutely absurd that I have to explain my private healthcare records to criminal law enforcement authorities. It is also absurd that Wells Fargo is permitted to keep those records, if that is the case. And of course, the fact that you did not charge the people involved in this crime isn't all that great either. I want these people punished. I particularly want the girl at Broughton Hospital charged and sent to prison. I am tired of Broughton Hospital committing crimes against me. This hospital has committed crimes against me over a time period of now over 20 years. There is no sign of them letting up.

I have little to no idea of what goes on in the minds of the people at the Justice Department who I send my communications to. I have brow beaten the people at the US DOJ to death, and I have done the same to the people at Wells Fargo, for that matter. This can create an effect where people dig in their heels that much more. I think you will feel better if you just acknowledge the reality of what has happened and deal with it.
