There begins to be a frenzy of discussion about psychiatric disorders. Other than the topics of these posts, in many cases one more thing sticks out- these people are lying their asses off. Their mental health problems and claims to suffer from psychiatric disorders are made up.

Quite often, they will directly ask other group members to share their history of mental health problems and treatment for psychiatric disorders. "I take olanzapine....Looking for others who have taken this medication before and can advise."

These people were sent by Wells Fargo. Wells Fargo invaded my privacy and was told that I have been to a "mental institution" for my mental health problems. There have been numerous court rulings that anything that you share on social media, you have no right to privacy for.

They are creating this frenzy of discussion of psychiatric disorders and these solicitations to talk about the medications you take, the disorders that you have, etc., to try get me to chime in and forfeit my right to privacy.

You ought to see some of these bullshit posts. You have people who claim to be paranoid that are actively seeking treatment. "I feel that everyone is out to get me. I think I need some olanzapine." - this is a paraphrase of what one group member said.

The NYT girls name is Emily and she underestimates me to an extreme. I think that when I send my report to her, she will get the picture that I am to be listened to. The case I have for this is very strong and is also quite obvious in many aspects. It is also a pretty sophisticated project.

I used a program that automated my operating system. I programmed it to search for Facebook posts and save the html files in a folder. I wrote a script, and I would run set the script to run right before I went to bed. I'd wake up in the morning to 1,200 to 5,000 new facebook posts saved.

Then I wrote an application that I run on my local machine's web server. That application processes the html files that I saved. It goes through the html files and pulls out the data that I need, and loads it very nice and tidy in a database.

Then I built a UI. In my UI I can load my posts and it looks very similar to Facebook. I can compare my data to Facebooks side by side and I can audit my posts.

Then I wrote another collection of programming scripts that work together with some database tables to do my analysis. I aggregate and segregate data in all sorts of ways, in putting together the tables for my analysis.

Then the final step involves doing statistical analysis and being able to understand it to some degree. I'm honestly about 30% to 50% lost with this statistical analysis. I only took 2 semesters in college. I'm still probably close to par with your typical journalist.

Then after my analysis I write a report where I interpret the data.

I'm getting long winded, but the point is that this project will showcase to the media that I'm a competent person who is worth listening to. Emily from the New York Times compared me to someone who contacted her because he thought that JP Morgan Chase had bugged his phone. She didn't do this in any derogatory way, but this is along the lines of how she thinks of me. I could tell that.
