

## Statements About My Impairment

5:45 – I've had piles of trash in my apartment

6:48 – I get hyperarousal, and there are times when I can't do anything and times where I can do work that isn't productive.

8:40 – I'm still pacing a lot, not pacing as much

9:10 – that since this traumatic stress has intensified, I'm pacing constantly.

9:40 – that my hyperarousal consists of vigilance and irritability

10:05 – I get depersonalization

10:10 – I am always fooled by my symptoms. I think that I'm better for the long term when I feel better in the short term.

10:50 – I had depersonalization last night, for 30 or 45 minutes. It is bizarre to explain

11:32 – In depersonalization have a detached feeling, accompanied by a feeling of hostility or cruelty

12:15 – I have chronic PTSD per John

12:47 – I feel like if you put someone who is a prisoner of war next me in, with brain scans, I would be as bad or worse

13:05 – if I can be totally without stress, that life is more tolerable. I am extremely sensitive to stress. If I get a burst of stress, it takes me from being kind of wrecked, to really wrecked for days

13:38 – I finally got my bankruptcy paperwork in. I missed a bunch of deadlines with my bankruptcy

15:45 – that was an acute stress

16:05 – I was so disabled that I couldn't fill out my exemption forms.

16:15 – I'm too disabled to do paperwork

16:45 – I am going to turn my paperwork in on 2/24/2024. Me driving is out of the question

17:40 – I print out my pdfs. I have 70 to 100+ pages.

18:05 – I'm screaming and calling the courthouse crying

19:01 – I'm disabled and unable to do this

19:20 – you've never seen me like this. I am screaming and crying in the courtroom

25:30 – I tell her that I take 10 mg Zyprexa

26:48 – Zyprexa causes me cognitive impairment

27:30 – if I'm up too long I will have a slight, 1% mania. This is why my speech gets speeded up at times.

28:48 – Zyprexa causes cognitive impairment

28:54 – Zyprexa knocks me out

## Statements About the Crimes

15:10 – I mention being kidnapped

19:59 – I mention a kidnapping (“there has been a collusory kidnapping”)

20:10 – I bring up the petition

20:35 – the time I was taken into custody is 11:43 pm. The time I am delivered to the examination unit is also 11:43 pm

21:20 – I ask about middle eastern man named Silver, who was at the door at the inpatient unit

23:00 – I ask about who entered the times

23:20 – the officer admitted that he didn’t have the paperwork in his possession, by his answers

23:50 – I do the math and explain that the officer would have had to drive over 1,000 mph, in the most extreme circumstance, if this petition is to be taken at face value (11:43:00 picks me up, 11:43:59 arrives at the inpatient unit)

25:10 – I mention the kidnapping again

25:15 – I ask if Atrium dropped the ball

### **25:20 – Kathy changes the subject to “is your medication working?”**

31:30 – I start to talk about mobile crisis- they tell me that I “need to eat a cheeseburger and to read a book, and I’ve had a bad day.” Their internal records have me as being severely paranoid, and a bunch of stuff...an acute psychosis. Mobile Crisis is suspect. I have reported these people to the FBI.

### **32:11 – Kathy asks if I reported the mobile crisis to the FBI**

32:47 – I say that Jenny is the frontrunner of Wells Fargo’s scams. Wells Fargo has her running their scams. She is so eager for the crisis people to come visit me. Jenny says that “Allie went to the magistrate with me.”

34:00 – what is Mobile Crisis counselor is doing telling me that I just need to eat a cheeseburger, and then going to say I’ve got schizoaffective, psychosis, paranoid delusions, that I think my friends are out to get me, which by the way, I have no idea how they characterize my belief that my privacy was invaded as “thinking my friends are out to get me.”

34:20 – I say that Mobile Crisis is involved in this involuntary commitment. We have evidence of on the face of a HIPAA violation, possibly perjury

34:40 – I say this was a kidnapping,

34:45 – the officer commitments a civil trespass by entering my residence against my will, civil battery by placing me in handcuffs, false imprisonment by placing me in handcuffs, and kidnaps me by transporting to the inpatient unit. This is a kidnapping. Every element of the crime of kidnapping has taken place. I am sure that the kidnapping falls under the jurisdiction of the FBI. I am not sure whose jurisdiction the healthcare fraud falls under.

**41:40 – she says I’ve been very talkative**

**43:30 – she cannot say if I’m in an acute psychosis**
