15:52-16:13 “Charlotte is corrupted, completely”, “These people are foaming at the mouth criminals”

The takeaways from these videos are:

1. When I refer to Atrium Health, I call them “foaming at the mouth criminals”.
2. When refer to Charlotte, I say that “Charlotte is completely corrupted”.
3. Notice in the first video, how at 9/16/2020, I have an intuition that my mother and Atrium Health are up to no good.
4. Notice how I say that my hospital is on the line for multi-million dollars for the felonies that she (my mother) participates in.

In reference to items 1 and 2, this is exactly what I told Novant Health during the 9/30/2020 stay. I told them that the people at Atrium Health are “foaming at the mouth criminals” and that Charlotte “has been completely corrupted”. On Novant’s healthcare notes (which are full of fraud), what I say is distorted. They say that I said that Atrium is “frothing at the mouth evil” and that Charlotte is “full of evil”. The function of this deliberate distortion of what I said is to make me appear to be mentally ill.

I have evidence of Atrium Health’s crimes and Novant Health has access to this evidence, through their healthcare information exchange. Atrium Health has, on file, a civil commitment custody order that has the timestamps obviously forged. It is evidence of deliberate fraud. Novant can pull that document in a second.

If I think that Atrium Health is involved in crime and I have evidence for it, this does not make me appear to be mentally ill. If I make a statement that Atrium Health is “frothing at the mouth evil”, then this does sound like something that someone who has mental illness symptoms would say. It is the same with

saying that "Charlotte is full of evil." This is one instance of deliberate fraud among many, that are on these healthcare records.

In reference to item 3, what a coincidence that I have this intuition on 9/16/2020 and then this scam is ran on 9/30/2020. I am very good at figuring out when people are up to no good.

In reference to item 4, notice how the incriminating details of what I say never make it to Atrium's notes. I say that Atrium has multi-million-dollar liabilities for felonies that they have committed. On Atrium Health's records this is stated that "he thinks BHC is against him".

In re these notes saying that I think a Jenny and my mother are working against me, I never made this claim. What I did say is that my mother tries to run my life, that she has done this my whole life, and that a primary way that she does this is to get in touch with the people in my personal life and to do this behind my back. I said that Atrium unlawfully provided my mother with Jenny's number and that my mother has been speaking to Jenny. I have evidence for this too.

Notice how this thing, in Novant's records, about me thinking my mother is talking to Jenny, or as they phrase it thinking that my mother and a Jenny are working against me, never makes it to Atrium's notes. Isn't it strange that my mother would mention this to the people at Novant, but would not reference it in her supposedly panicked communications with Atrium? There are 2 explanations for this- 1: is that this is another incriminating detail that Atrium doesn't want on their notes, and the more likely is 2: they have been sloppy in committing their crimes. They unintentionally created this inconsistency.

On the Novant stay notes, you can control + F for the words "evil" and "Jenny", and it will take you to the parts I have referenced, where what I say is distorted. I had made my document titled "novant-stay-comments.docx" at an earlier date. In that document, I say that I think that Wells Fargo may be involved. At the present time, it is clear to me that my mother, Atrium Health, Wells Fargo, and the US DOJ were all in on this crime, and that this hospital stay and accompanying fraudulent notes was one of the initial steps of the cover up. I also had trouble coming to terms with just what a rotten person my mother is, and how she has raised me for her own purposes, for her whole life.
