I have the rough draft of my complaint attached a well. I hope you can help me hold these people accountable. Thank you.




Please help me and I will do what I can to help you.




### More evidence

I forgot to mention in this last email- **please abstain from immediately forwarding what I send you to the various criminals referenced in my complaint.** This causes enormous problems for me, as I explain in the attachments to the last email.

These are calls that I did not know that I had for a long time. They are with Jenny, the pitiful woman that Wells Fargo hides behind. She later told me that following calls like this she cries herself to sleep.

I have recently become conscious of just what I stand in the middle of with this bank. I do not want to cause any harm that would hurt them excessively and I certainly do not want to do anything that harms the economy.

With that said, if they are to get away with it all, I would like to win somehow. Whether or not I am allowed to win, if they get away with it all, I will not let them also get away with calling me a liar.

I have no idea what they tell you, but if it diverges at all from what I have said it is dead wrong. In the attached calls, you will find yet more examples of my asking for the truth consequence free.

If I had a record of every call I made and every text I have sent, the total of such attempts would be at least in the dozens.

I have also attached the call with Jenny that took place on April 16th. This is one day before the mobile crisis counselors came to visit me, after which they wrote up a fake report that I was having an "active psychosis". Notice how I do not appear to have any such problems on the day before this scam was run. In the 04/16/2020 call note that I stutter due to cognitive impairment from my medications.

I want to thank you for being my friend. I am a firecracker and have good and bad feelings about people at different times, but you very much seem to be motivated to help me.

What's going on now is I am somehow extremely weak. This condition and this battle appear to have fried my body. I have been feeling like I am about to die over and over for days. It may be respiratory failure or a heart condition. Not sure. I just know that my system starts to kind of waver or vibrate and i get weak and/or short of breath. My body and brain seem to think that I am dying when this happens because when I waver too far, I have a feeling of fright or terror. I think my body and brain are right.

Part of the consequence of what has occurred is that I am wary of going to the doctor or going to a hospital. These places are used to abuse me.

At this point, I have no choice. I am going to ask atrium tomorrow about getting a medical doctor appointment or possibly staying in some hospital unit.

I need them to stop abusing me and to treat me to make me better. I have severe limitations. I am unfit to be around people. I am hostile. I am essentially a human being so broken as to be ruined.

There is no prayer of them hiding all that they've done. So maybe if I stay with them in some inpatient place or go to a hospital bed, instead of making ridiculous notes about me, they can talk to me about how to make this better. I can answer any questions they have about what I've said or sent to the media.

I think this needs to be the direction that we take. Everyone has a stake in this and we need to minimize the damage to all involved. I think this can be a constructive thing and that everyone can make it out of this. I am so profoundly damaged that, at this point, I want to avoid any sort of prosecution at all costs. I would rather them settle with me and do something to make it right. We all need to start talking at some point. If they refuse to make it right outside of the justice system, then maybe they should be prosecuted. the problem there is that it will cause me untold emotional and psychological damage and I even doubt if I could physically survive it. The last one is due to recent events where stressors almost literally kill me.

I promise you there is not. If there is, I will sell my pool table sometime down the road and pay you back. It is my most prized possession but I will likely never be able to play pool again.

## Update on my condition

To: "Division, Criminal (CRM)" <Criminal.Division@usdoj.gov>

If you are concerned, my heart injury has healed almost completely. Each time this happens, it seems like they leave a slight lasting effect. If I seemed unreasonable in asking that my account have \$5,000, let me explain. I am suffering extremely. I have to fight with my mother over money constantly, and these fights are wearing me down and also sometimes causing stress based injuries to my heart (any good doctor could validate this, I think. It is called broken heart syndrome). It is possible that I die from one of these injuries one day (I nearly have at least 5 times thus far). The reason I suffer is that a bank with \$150 billion + in cash went on a massive crime spree against me. This bank pulverized me and there is 100+ years in prison to go around. If this bank is prosecuted, it may cause the entire global economy to collapse.

In lieu of the global economy collapsing, I am asking for help. I appear to be getting help. As I am getting help, however, I am having to suffer like there is no tomorrow, fighting for my life and getting injuries to my heart that nearly kill me. I do this by fighting with my mother over sums of money like \$1,200, \$40, \$250, and similar amounts. It seems to me to be unreasonable that I suffer like this over these amounts, amounts which amount to nothing for a bank with assets of roughly 1,950,000,000,000. At the same time it seems very reasonable that I ask this bank for \$5,000 to have this torture relent. After all, we are saving the global economy by letting them off the hook for this massive list of felonies that have left me disabled for life and caused such extreme suffering. Then there is the event that these heart injuries kill me one day, and in that circumstance the media releases what has happened to me. I can almost promise you that this will be a very bad day for WFB. To me life is about balancing our needs with the needs of others. I see \$5,000 as not being anything to WFB but being a huge relief to me.

And that is another relevant point. I'm not asking the us doj for any money. I just know that what I send goes to WFB. They fund the help I am getting.

I want to apologize for that email where I say hateful things and send audios that also speak in unkind ways. I was extremely angry over missing my MRI. I didn't have \$70 for a cab and it caused me monstrous stress trying to drive there. I nearly wrecked and I felt like I was going to have a heart attack by the time I pulled over. My gps had taken me to the wrong place, over something I did accidentally. I am extremely, extremely disabled. This damn near killed me. Again, \$70 I have to come up with as a disabled man who cannot do much of anything, instead of it being given to me by the \$1,950,000,000,000 bank that murdered my existence.

I do not know what is going on. I thought that WFB had shown you illegally obtained healthcare records. They have plenty of these, I can promise you. It may be the case that they didn't show you any. Very suspect things are going on with my healthcare currently, and it strongly suggests a deliberate cover up. I am deeply sorry that I said in one audio that the Doj could be involved in this cover up. I will also tell you that if you are, you likely have a good reason for doing so. We all have limitations and constraints, and I view you as fundamentally good people who mean well in all that you do. I hold nothing against you in any case. It would break my heart, but that's it.

The entire time when I was hurting so bad and being abused so cruelly, I dreamed of the day that the US DOJ would help me. I pictured it as a possibility that the Wells Fargo building I worked at would get raided, and all the people who participated in this merciless abuse and crime would get taken out in handcuffs. But it can't happen, this raiding of the building, and I understand. It was just a nice thought because the day this happened, I would have some dignity.

I want to tell you again, thank you for helping me. I want to ask you to please continue helping me. I will also again tell you that I will help you in any way that I can. It may be that the way that I help you is by helping Wells Fargo somehow. I will know when you tell me. I overestimate my abilities at times, but I do often think that I could fix this situation for everyone. It would involve cooperating with you, WFB, and the rest. This whole thing could become public knowledge with not much damage to anyone and even be a good thing.

I am as honest as I know how to be in my dealings with you. Anything that anyone is skeptical about I can prove, if given the right expert to speak to me, be it an M.D., or someone else. M.D. could verify my heart condition. If you doubt for a second that any of these crimes occurred, get one of the best investigators from the F.B.I. to look at my evidence and come talk to me. Unethical behavior on Facebook - I can prove it. Every last bit of it, I can prove.

I don't know what's going on and I have no idea what to do. I have some kind of deficit that prevents me from handling this situation the right way. I cannot make sense of it. Please have mercy on me and understand that I'm doing the best that I can.

I'm getting a tiny bit of traction. I have prepared a monster sized amount of stuff for the media, as I have been sending them messages, audios, etc. If I can capitalize on this traction, it will likely snowball very fast.

Every last crime I allege did in fact occur. I have repeatedly said this. If you have doubts, you maybe should think about the scenario where these crimes did occur. That is the reality that we may be facing in the public eye. I'm just making a suggestion. You know what's best for you.

I thank you again for the help you have given me. I do believe that you have done things to help me. I am very frequently in constant, terrible pain and distress. I am terrified much of the time. This situation is something I cannot make sense of and I don't know what's right or wrong here. I just know that this hell I'm living needs to get better, not worse. I know that Wells Fargo's behavior was vicious and terrible and inexcusable, and I am still suffering to this day. It is as if Wells Fargo's needs dominate everything else. There is no room for me or anyone else.

I went to the e.r. for my heart injury. All my tests came back normal and the doctor said that he saw no signs of a heart injury. I told him more about my problem and he said I need to see a cardiologist. I fact checked the doctor, and some of what he said about heart injuries is wrong. I am having repeated stress based injuries to my heart, end of story. A specialist is what I need. This last injury seems to have healed. I feel like I'm going to die every time I get one of these.

This situation is terrible and should have never happened. Terrible situations that should never happen are life's signature move. It does it to you constantly. I mean well in all that I do and try to see the well meaning of others, so please excuse my constant rollercoaster of being happy, then mad, then begging for help. I am suffering like you cannot believe and this is horrific.

If Wells Fargo is in the media for its demonic behavior, it needs to not go on the aggressive. I want to have something where both the company and me are better off, and my gestures of kindness and mercy tend to backfire and/or get me nowhere. If I say that I want something good and they respond with a massive offensive, slinging mud, propaganda, defaming me, this will throw a wrench in it. We need to not throw a wrench in any constructive outcomes that may happen. If the economy tanks, it is a result of this banks behavior not mine. I tried to work it out and will keep trying. They need to meet me halfway. They will just have to admit they done something wrong.

I will sign and abide by any nondisclosure agreement that is proposed. I will do whatever is needed. My only concern is that my life doesn't tank.



**If you are wondering why I keep emailing about this and why I cannot seem to stop thinking about it, it is because I feel the weight of the devastation I have been dealt every day. I feel the weight of the nightmare the rest of my life will be if these people are not made to make it right. It is crushing and terrifying. I cannot begin to try to explain how bad this feels.**

My reporter hasn't said anything in the past 2 business days. My complaint is long and detailed, and it is probably taking her some time to read it. I get the feeling that she is going to bail from this story. I have an air tight case, but it takes some reasoning and some putting the pieces together. For some reason, I get the feeling that what these reporters want is something that is more settled (investigative journalism is a misnomer in that case).

My next option after the reporter is to make my investigation portal public and try to make it go viral. I may put it on another url and/or a bigger server. I may also have it delivered by a cdn. Bigger server/cdn will keep the site from crashing. I will try to get a lawyer and some other things from the attention that I get. I am fighting for what remains of my life and I will fight hard.

I have repeatedly said that there are possible outcomes for this situation that are a good thing for everyone. If I get media attention, I may likely try to engineer one of these possible outcomes. You will see how it works.

Part of the problem is that I don't know Wells Fargo's next move. I do not know what kind of mindset they are in. I sincerely hope that they are in a mindset where they would take the opportunity for a good outcome. However, I get the feeling at times that they are more prone to go on the offensive, and to continue digging in their heels. They seem to really have trouble admitting what a terrible mistake they have made (not being able to admit mistakes has been a huge factor in how we got to where we are. It's a common thing with probably everyone involved). I don't want to come out with a gesture of goodwill and have them go into reality denial based attacks.

We will see. And thank you again for AU girl. You did a very good thing there. I ran her away by needing her more than she was available (she's a workaholic and has next to no time for me). She didn't seem to get how disabled I am, and what that would mean for what would be asked of her. It was so nice to have someone thinking of me. I hold open the possibility that she was another scam. You can never be sure. I'm about 60/40 favoring the she's not a scam hypothesis.

Ignore the font styling. My phone did that and I don't feel like fixing it (not sure that I even know how).

## **Update on my situation**

The reporter from the LA Times declined my case. She gave spurious reasons. The real reason is that I have a mental illness. Of this I am very certain. I had contacted her saying I have evidence of fraud and other serious crimes. Then she finds out that I am the subject of these crimes. Wells Fargo was correct in calculating that no one would believe me because I am mentally ill. I am a 4th rate citizen in the eyes of the world. My life has been destroyed and I will not make it. Please stop them from murdering me.

I am not sure why you do not reply to my emails. This is normally a very rude behavior (not replying is a tactic that has been used against me countless times. It's because I do not matter and people can't wait to show me that I don't). If you are shunning me because you have saw illegally obtained healthcare records, this is very wrong. I spent every good hour I had writing my complaint and organizing and building my evidence. I did this despite the fact that I had an open and shut case in March 2020, and actually even before that.

In October I sent you what I had, which was a very detailed complaint. In this complaint, I reference a life where my mental health history is used against me. I reference that I wanted to escape this life where I am cruelly disparaged by people who use my mental health history against me. Unbeknownst to me, by the time my complaint hits your inbox, you've already participated in just that. You've done this with a criminal bank.

I can forgive you for this, if my forgiveness means anything to you at all. What I need is for you to make this bank make it right. I am paralyzed with stress and psychological paralysis for most of every day. If I have 2 or 3 good hours in one day, I am doing good. Often I will only have one hour of good time in a day.

Everything I cared about is going to be lost. So much has been taken already. If something were to happen to my mother right now, I would have no place to live. I would be homeless. I can't cook. I can't do much of anything. It is hard for me to even check the mail. I used to take 1 to 2 showers a day, on average. Now I take 1 every 3 or 4 or even 5 days, because this is also hard. I am severely injured. I cannot clean my house hardly at all. I have cleaned less than 5x in the past 2 years. My paid cleaners are shunning me. Why do they shun me? Because Wells Fargo has spread a bunch of filth that got back to them.

This is what happens to me because I asked this bank to tell me the truth with no consequence to the bank. I initially asked Jenny, because I thought it was only her and Tunny (I gave Tunny multiple chances too). Why can't a bank that has \$150 billion in cash afford to tell the truth? Why can't they just tell me that they were behind it, instead of hiding behind Jenny? They could tell me that it was them, and if I keep it up they will have me kidnapped and massacre my life. Then I would know the consequences and could make a better decision.

In April of 2019, all I know is that I am having an argument with my friend and that this argument has been going on for 1.5 years. I have some vague notion that maybe this is somehow a liability for Wells

Fargo, but I don't know what. To me it's all Jenny.

Maybe I was overly preoccupied with this. That was their criticism. I don't see it that way. But if I was, how does a preoccupation warrant this? How can any of the blame fall on me?

If the point of this is for no one to know a thing, I can stop telling people. If Wells Fargo sends me some money (this is what I need, at minimum, and I need it very badly), no one will necessarily know that it came from them. I have discover bank and others who have civil tort liabilities for their abuse of me. If it is unavoidable that people know it came from WFB, then I can say I'm not allowed to disclose this or that it was over a privacy violation.

I will never be able to put what has occurred behind me. I cannot put it behind me because it has injured me permanently and I feel the horrific effects of this injury every single day. At the moment, I am paralyzed watching my life be taken from me, as I am helpless to do anything about it.

If I don't pay this tax bill that they are trying to impose on me (I don't have \$200. When I listed my actual property years ago, my bill was \$13 + a \$5 late fee), they will come and sell my stuff at a tax auction. I will have to get their estimate corrected.

I cannot tell you the hell this is to deal with in my condition. I am paralyzed and it murders me to fill out paperwork. It murders me to have to call and talk to people. It murders me to have to drive to the post office.

I have a feeling of being paralyzed and having to watch my life be stolen. It is a constant threat of losing my stuff, while I sit here helpless.

Please make them make this right so that I don't have to deal with this hell. I need money to hire an assistant to be my agent and handle things like this for me. Either that or a I just give Mecklenburg county a pile of cash that is good enough to last 20 years. Maybe there is another option, but this hell I am living is terrible and needs to be made to stop. They did this to me. Make them make it right.

They have everything. They do as they please. There is no privilege they do not have. They can spare some of what they have for the man that they have cruelly murdered.

My demeanor towards the people on the other end of this changes. I'm sure you notice this. Part of the reason is that I don't know what's going on or what drives your behavior (the main behaviors I have to figure out are why is this being forwarded to Wells Fargo, why you do not reply, and what is the role of AU girl).

I was able to get about 1.5 hours worth of work done on my website today (the one where I plan to post learning courses). There is a chance that I peek out another 15 minutes before I go to bed. If I had enough money to fund me for several years, I could maybe make enough videos to make a living in the years that follow.

I get angry and feel dejected when I think that you have been prejudiced by my healthcare records. For sure Wells Fargo has them. If they have shown them to you or not is in question. I think you can understand this. I'm sorry for any negative effects my attitude has had on you.

There seems to possibly be a negative construal of me, my behavior, and my motives. That I said some disturbing things 21 years ago doesn't mean anything. I have to engage in gamesmanship and deception to catch Wells Fargo in unlawful behavior, but this is the way that anyone catches people. I tried settling this honestly a million times.

If you are consulting with anyone from the mountains, concerning me, you are for sure getting inaccurate info. I've already said that these people are out to run me into the ground. All of the negative things that these people will say, these just confirm the accuracy of what I have told you. The things they say are not reflections of reality. I will say again that the source of truth is me. I am conveniently left out of the conversation.

My behavior adds up to honesty and to having a very kind heart. That's the accurate take on me. It takes hard work to not see me as kind hearted and honest.

Right now I am terrified of what may happen to my life. I want to settle this in a way that works for me and works for everyone else. What has been done to me is terrible. If I had some money, I wouldn't have to worry about my life collapsing. I could also find a girlfriend. AU girl seemed perfect, and I will miss her if I find another one.

In my estimation, I should get at least \$30 million out of this. This is discounted from what I consider a fair figure of \$100 million. This is for my suffering, past, present, and future, and also for the lost potential that my life used to have.

Right now, however, I will take whatever they are willing to offer. I will take it even if only \$5 million or even if only \$1 million. They need to consider that I will need enough money to fuel me for a long time, possibly my entire life. I am severely handicapped. This is on top of my terrible suffering.

Whatever you and they need me to do, I will do it.

I ask that any agreement I sign contain no restrictions on my personal life. By this I mean no restrictions on where I am allowed to move to, who I am allowed to talk to, and things like this.

But in terms of non disclosure agreements, never talking to the media, etc. I will do whatever. I will ultimately do whatever in any context. You may not realize this (speaking to U.S. DOJ), but I am scared of you. This is not because you've ever did anything wrong to me. You overall come across as kind and caring people. It is just that, in the process of trying to live a quiet and nice life, I have found myself potentially in the middle of the global economy, and in the mix with the most powerful people on earth.

I am a very powerless person, and I am aware of all that can be done to me by people that outweigh me a trillion times over. I never, ever, wanted to be in any kind of intense discussion with The United States of America.

In re Wells Fargo, I speak so horribly about them at times. What I can tell you is that my attitude is easy to change. I would not look down on them so much or say such things if I weren't suffering so profoundly. I ask that they do something for me to make things right. There was a time when Wells Fargo and I were great friends. Things were easier then for everyone, and maybe we should go back to that.

I think that all of my talk about you being prejudiced and hearing rumors is incorrect. I need these people to make it right. I am suffering so extremely. I sent Atrium an offer earlier. The LA Times probably has no interest in me and probably never will. If I do get the ball rolling with them, I will do my best to think about you and Wells Fargo.

Wells Fargo has tried to help me, with AU girl and things like this. I have responded by being unfair to them and saying grotesquely horrible things about them. This is wrong. What drives this is that I am never sure that I am getting any help. It could all be a scam. The other much larger driver is that I suffer so unbelievably and they could take much of my suffering away by making it right. This whole time I have been suffering and it is on and off terror.

I say that I don't want them criminally prosecuted if I can get some relief outside of that. I mean it when I say it and I'm also factoring in that it is easier for the other side. It seems like the win-win way to go for everyone.

Wells Fargo's latest concern seems to be that I should take them to court if I want some settlement. They seem to be deferring me to the business as usual process.

I do not mean this in a derisory way at all, but the business as usual process is off the table. That the whole point of how things are being done. The business as usual process, when someone commits a crime spree like this and leaves an open and shut case, is to criminally prosecute the individuals and entities responsible. Once they are in jail and their crime spree is curtailed, the victim can come after a settlement.

What happens next in this case is the whole globe melts and the chances for prosperity for the entire world are likely to almost vanish.

I am mentally ill. Lawyers won't take my case because they don't believe what I say. They would believe it if these people are prosecuted by the authorities. Such a horrible victimization deserves a criminal prosecution. But again this is not an option.

I obviously don't feel comfortable taking WFB to court anyways, due to their ability to rig the process behind the scenes. I don't want to think in these terms. I want to see them in a much better light. Seeing them in a better light is warranted, but because of what I have suffered, I feel totally powerless and I feel like I'm playing a game that I cannot win

The fair price for what has happened to me is the end of the economy as we know it, as well as an enormous sum of money, as well as something like a dozen people or more people going to prison.

In lieu of this, I'm asking that we do things a little differently than the business as usual. Everyone agrees that we cannot do the business as usual. I desperately need help.

I have felt terrible for a while now, over my griping about AU girl not having enough time for me. I am very sorry. I am suffering horribly and I find that I often behave as a rotten human being.

You and Wells Fargo did something wonderful there and I thank both of you from the bottom of my heart. I want you to get full credit for what you have done and I am deeply sorry if I have ever been ungrateful. I am crying as I type this.

I think it is possible, at times, that you have heard that i committed some horrible crime. I promise you that I have not, and every situation that might be construed that way I can explain.

If I am accused of some horrible crime, please hear my side of the story. Send the F.B.I. to my apartment to investigate me. Polygraphs are pseudoscience but I will take one of those (or two or ten). I will give them permission to search everything that I own on an indefinite basis. In the last one, all I ask is that they do not deprive me of my electronics. I live in torment much of the time and my computer, iPad, etc. are my main sources of comfort. I don't want my stuff sent to some lab that I get it back in 6 weeks or 6 months. I will also sign whatever they need to get my records from Verizon and spectrum internet. I'm not sure if I'm subscribed to anything else that would have useful data about me, but if there is they can have it.

Send the best of the best to catalogue every molecule of my existence. All I ask is that my side be given air time and that efforts are made to verify my side, just like there is for everyone else.

In a process of cataloguing my existence, you will not find perfection or anything close. You will see that this man typing this right now has done wrong in his life. But I want you to hear my story and let me show you how honest I am and how hard I tried, and after that, I want to see the bastard who is so cold blooded that he could not look up to the kind hearted man that I have become, and that I have been for so long.

For full disclosure, I did end up contacting the media again. I reacted out of my pain and this fear about my life. It was a mistake. I am nixing this completely, effective today. I have suffered terribly as a result of my decision to work at this bank. It was such a good job for so long. It fueled my new life. But in the end, it was the worst decision I ever made. That's the ending of the story we have at the moment. My life is destroyed and I am permanently handicapped.

I don't know what the deal was with AU girl. I cared so much for her. I thought I was getting help. I would rather die than live the life I have before me. I need you to help me very badly. If they make it right, they will be the good guy again. My new life will go on and it will go on in a way that I can be happy about.

If they had a plan with AU girl, that I would have a life with her, whatever they had planned would be a good ending for me. I don't want a life where I am dependent on her for money and my livelihood. I would rather have an option where i can live independently if she decides she doesn't like me anymore or if I need to leave her for some reason.

With that said, anything is better than what I have before me. I will take what they can give.

I am very concerned about how my character is perceived. I have been nothing but honest and genuine with everyone involved. I have tried very hard to do right by you. I have tried very hard to do right for so many years. I am a very good person.

I ask that you please see the good in me.

I will attach a conversation with the owner of a children's ministry in Pakistan. You will see that I donated to this woman's ministry for needy children. 2 churches I contacted about her turned her down. 1 church had the excuse that they "are just a small church and cannot afford much." I can't remember the other churches explanation. It is maybe halfway in the chat that you will see my screenshot of my donation. 1 person facing serious financial problems gave more to her needy children's ministry than 2 churches and this woman's 120 Facebook friends combined.

She befriended westerners, primarily from the US and Canada, and asked them for money. If you look at these peoples Facebook walls, they purport to be religious fanatics with all the memes they share. When the rubber meets the road they are tightwads that report her for asking for money for her hungry children, for whom she risks her reputation, it not her safety or her life, to teach about Jesus.

She got kicked off FB for good the last time she got reported. I never got to send her any more money. She had sent me videos of her 40 children eating the chicken and noodles dish my \$63 bought. also sent me videos of them singing. It made my day. Warmest Regards,



I really need atrium to help me. I need to get some meds to be filled. You will see that I'm slowly coming around to doing this your way. I want to help you, as I can see that this situation is creating stress for you, and most likely very intense stress. It is taking me time to adjust, and I still have terrible feelings about this. I got angry yesterday and that's why this all came out. I will do better next time. I still believe it is possible that you help me. I can see that your needs need to be taken care of first, if that is ever going to happen. If you do not help me, I will do my best to adjust to the life that will result. It will be a life that will be extremely hard to live, but I will do my best.

I believe that the best way for me to look out for me is to look out for you. That's what I'm seeing and I'm genuinely sorry for all of the stress that this situation created.

Atrium redirected me to a crisis line and I hung up. I think they may have done this deliberately. I hung up because I thought it was an error. Due to my condition, it will be too taxing to call them again today. I will likely not have the willpower. I will call them Monday and I need them very badly to refill my meds. My mother will be coming up here to drive me to get meds. I don't have a working car anymore, so I need to have them ready for me on the day she comes. We can wait while they are filled, but she will not be able to drive back. I am eligible for a refill on the 18th or 19th.

I'm re this death talk, I was not speaking of self harm. I have felt that the stress of my situation is going to cause me to have a heart attack many times. Going to the ER accomplishes nothing. They tell me that I am fine and then I have a hospital bill that I cannot pay and that adds more stress. I currently have no plans at all for self harm and do not think that will ever happen. I had this heart attack feeling several times this past week. It is this stress I am under, and this is also why I am losing weight. I've spoken of self harm before, or at least thoughts of it, but that's not going to happen.

I need very badly for my life in Charlotte to go on. I ask that you please do any and everything you can to help that. It would mean the world to me and I am going to look after you.

This is a very sad ending for me. I am not going to pursue this anymore, not in any way. I have no choice. I so badly wanted and needed help. I have been in pain for hours, with shell shock, but I have not emailed you, as I usually would have. I need my medicine from Atrium. I am going to call them Monday. Please see that I get it.

Now my main goal is to get social security ASAP. That's my only hope. I am so incredibly sad. If there is anything the people on the other end can do, please do it.

I think AU girl may have misunderstood me. I don't know if you play my audios with her. What I was saying about her is that I want to ease her suffering. The way she works is she will not tell you what she needs. She finds it hard to tell you what she needs. So the way to ease her suffering is to be very good at picking up on what she needs without her telling you. Then you do what she needs you to do. To her it may seem like magic that you know what she needs, and it will be something she really appreciates.

I care about AU girl so much. I am crying as I type this. I value and appreciate her as a person.

I'm having memories of making these last set of audios, and I had said some strange things. I don't know what I was thinking, but whatever it was it's not what it sounds like. I could never hurt anyone.

I have no choice but to give this up. The people on the other end decide what happens, and they are far more powerful than me or anyone else in the world for that matter. There is intensity behind your actions. I had tried to get things to go faster, by reaching out to the media and things like this. I am just going to get crushed with anything that I do to try to help myself.

It is utter and complete cruelty what has been done to me. I wish I would have known what the right thing to do to get help was, if there was such a thing. I am handicapped in dealing with people in a way that I cannot help. I think I made people mad over this brain scan. Whatever the case, I am done, and I am terribly, horribly sad about this outcome. I will never get over this because I will suffer for the rest of my life. You can move on though.

I want to state, one last time, all that I have done:

-I killed myself to be the best employee I could be for Wells Fargo.

-I took on the hardest work in my Dept and worked miracles

-I trained and mentored something like 20 or more analysts over the years that I worked, teaching them about credit and about my office's work

-I managed up to 12 to 16 analysts who did my work, so that the Dept didn't have to pay me or anyone else overtime

-I continued to do all of this, as my department turns against me and treats me with hurtful and cruel stigmatization, and as the management that is in place makes it harder and harder to do the great work that I was known for

Then this happened and I tried to settle it the easy way so many times. I end up reporting it all to you. In this process:

-I have told you every single action I have taken or will take, for your benefit. I tried to look out for your interests

-I got this brain scan, which cost my aunt \$250 and will cost me \$750. It took an extreme effort and sacrifice to get this. I went through enormous stress in this process.

-I told you about Facebook possibly having something to do with you over what happens there. I did this because I was concerned about you. I wanted you to be able to avoid anything that happens as a result. I saw us as a team and was trying to help get a good outcome for everyone.

-I have been a big man and acknowledged my role in all that occurred. I have apologized for all of my inappropriate behavior, and for my role in what occurred.

-I have offered to help Wells Fargo

-I have thought about ways that we could make this a good thing, if it ever came to light

-I have made a promise that was extremely hard to keep, and put forth enormous effort to keep it

In this process with you, I have acted in good faith to the best of my ability, as I have suffered extremely.

My incessant communication was out of my need for my suffering to end. This was hard to deal with, I am sure, and I am sorry. I could not help it. I have done my absolute best.

And so this is it, the sad and painful ending. I cannot tell you how much I hurt typing this. Please do what you can to make this easier on me. You win, just like I wanted you to win the whole time. I wanted me to win too.

I am adjusting to what is happening. I am suffering like you cannot believe. What is happening is I am not going to get anything out of this. I have been horrifically victimized and left disabled for life, and no one wants to help me.

If I get disability approved, that will buy me time and I can keep my life in Charlotte. If I do not get approved I will have to file an appeal. I ask that you please do whatever you can to let me keep my life in Charlotte in the short term. The stress of this is killing me. Once I get disability, I can work on having whatever kind of life I might be able to have. I will probably have to move to section 8 housing, once my apt lease is up.

I need a trier to help me by getting me medicine. My mother will be here to take me to get meds on the 19th. If I can get scripts written I can get them filled on that day.

I will leave you alone once my life in Charlotte is secure and I have disability, I will leave you alone. What has been done to me is terrible, and I cannot believe the utter cruelty with which I have been treated.

What is happening is I am being crushed. It is so cruel that I cannot believe it. I thought I was getting help with AU girl and I wasn't.

I never meant you any harm and I wanted things to work out for Wells Fargo too. Maybe you never meant me any harm either, but I have been demolished by this fight and by the actions of the people on the other side.

Please give me a sign that my life in Charlotte will not tank. I am asking for extremely little. I will be getting a disability decision soon. In the next 10 days most likely. If that comes back approved, I won't even need your help.

My communications are all over the place, and what is going on is I am coming to terms with the fact that I'm not getting help like I wanted. Anything I do to advance my cause forward gets me crushed. I will just live with this horrible suffering.

It was a mistake to work for Wells Fargo. It appears to be a mistake to have contacted The United States Department of Justice. There is not much justice to be found in this fight. I believed that you would help me. It was what I counted on the entire time I was fighting.

On the other hand, this situation has likely caused you terrible stress. I am sorry for that. I meant no harm. I have meant no harm this entire time. Whatever you have done to help me, such as AU girl, if she's not a scam, I appreciate it. I wish so bad that I would get that back, if it was for real.

It's time for me to close this chapter and move on. I am crying as I type this and I cannot believe how terrible you people are. I will likely still dream of the day that you magically change your mind and do

something for me. I will probably do so for the rest of my life, as I suffer this hell that I live. My savior will never come, but I will dream of it anyways. At least help me like I am asking. At least help me keep my life In Charlotte until I get disability coming in.

What is ahead for me is that my teeth with fall out. They are starting to go that way and I will not be able to afford the expensive procedures to get them fixed. I will have very little in life and I will die having never known what it's like to be in love.

If they can also at least pay me the \$1,000 that this brain scan cost me, that would help me.

Thank you again for anything that you have done or can do to help me. I do hope you see what a good person that I am. I have tried so hard to be a good person.

The day is coming when I'm no longer in your inbox. Please please just keep this nightmare of my life tanking from happening. I just need to buy time until I get disability.

I am being crushed. I need my medicine so that I can try to save my life in Charlotte. If I lose my apartment, I will just accept it. I will not take any rash actions that might cause more cruel and ruthless abuse.

I worked my whole life, killed myself, so that this could happen to me. I overcame everything, including my dysfunctional family and also including the blood that runs through my veins. Now I am handicapped for life. I will live in terrible pain. I will not be able to pay the rest of the \$1,000 that this brain scan cost me. I wanted a brain scan that would be helpful for disability, but I got one for Wells Fargo instead.

This is what I get for working so hard for this bank. They make a bad hiring decision with a senior leader, and I pay the price with the life I worked so hard to build.

I fought back because I was angry and also because I was handicapped for life. Getting justice out of this was the only chance I would have to have anything. I am breaking down in tears and I will cry over and over again for the rest of my life.

I am left in the dark about what to do to get help, as I suffer unbearably. I don't even get a return on my emails.

It was a mistake to work for this bank and this is a mistake that I will never recover from. I will not get a second chance. I will not be able to start all over another time. This mistake left me severely handicapped, so severe that I cannot get better.

I never asked for anything more out of life than what I was willing to work for. I have not asked for much from you and this bank, in this process. I was willing to accept very little. Now I cannot work and I will get nothing. God I am sad.

They could have told me the truth, like I asked, and paid me, instead of funding this crime spree that left me disabled for life. I never even asked for payment.

But why I am even talking to you? If there is anything you can do to help me get disability please do. I am speaking to the most powerful people on earth. Please use your power to help me. Please do something for me.

Sorry to be so blunt. I don't mean to be rude. It is just that I am suffering extremely and am on the verge of collapsing. I've been trying to get you to help me for 10 months. I wanted you to end this hellish stress and suffering.

I will send you the audios that explain my behavior in that appointment when I am well. I still have one more to take. It is 3 audios or a few more long. If it is a concern to you, my audios will explain.

I really need atrium to help me. I was not out to get them in that appointment. I just got pissed off all of the sudden and brought up this topic. I was trying to explain that what is wrong with me is that I am handicapped and cannot make my own way in life. This is the point that I have been trying to get across.

This "pep talk" approach does nothing to address this reality. There is no pep talk that will cause me to no longer be handicapped and cause me to have the ability to make my own income and manage my own life. Going to the ER does nothing. When I leave the ER, I am still handicapped and unable to fend for myself in life. I am still not able to make a living income. I am still powerless to stop my life from tanking.

The difference is I have another hospital bill that I cannot afford to pay, and that will create more taxing tasks in my daily life. What I need and have needed is to get money to compensate me so that I can fund my life. I am powerless to make my own money, because I am handicapped.

I am getting long winded, but the point is that I was trying to explain this to atrium. They talk to everyone else on the other side of this, and so maybe they can explain it to you better than I can. The problem was that as I do that, I start to feel hostile about what has occurred. That's why I brought that up and it mushroomed from there. I was not out to get them.

I have taken one action after another to try to prod people into helping me. I've been doing this for 10 months. Over and over. I need this suffering and stress of my life tanking and of my helplessness that results from my being handicapped, I need this suffering to go away. I can't take it.

As I suffer, I have to sit and wonder why it is that I am not getting help. No one will tell me what I need to do to get help. Every concern that I can think of, I address it. I tell you of the dire nature of my circumstances. I try to get the media involved to see if that can make things go faster. I tell you that you can blame it on me that there is no criminal trial. I explain that my family is lying about my abuse and has been. I emphasize that I am honest. I try one approach after another with you.

As I am doing this, I tell you what I'm up to, so that you are in the loop. It is your situation and it is my situation, and I try to work together as a team. As I take this approach, my suffering goes on and I am baffled as to what I need to do and what is holding you up and why you won't help me. I on and off get mad, over my suffering, and I end up screaming at you.

If you are getting weary of hearing about my suffering, I am also getting weary of telling you about it. I have wanted the day to come that I do not have to tell you about it, because I am being helped. That day never comes and so I am consumed with this situation and figuring out how I am supposed to get help. If you would have helped me end this stress of my life tanking because I am handicapped, you would not be receiving these communications.

I've wanted to speak to you directly for a long time. You could just tell me what I need to do. I am good at understanding the instructions of others. I am also sharp and talented in thinking of ways to address or get around any road blocks. I could help you find a way to help me. And you can believe me, that I will do what you say.
