I am going to get approved for disability. My medical review has been completed and my status is that a local office is reviewing me for non medical criteria. What this means is that the medical people have correctly determined that I am disabled. Non medical is a guaranteed pass.

It appears that, possibly, someone on your end has done me a favor. SS process usually takes much longer and they deny people left and right. If that is the case, thank you very much.

The more I think about it, the more the case seems to be that my audience on the other end of this is kind of big, bigger than I originally expected it to be, and that my audience includes extremely powerful people. That's why I believe it is possible that this is what has occurred.

The lady at DDS says that it will take about 2 weeks for the local office to get to my decision. I hopefully will start getting payments not long after that. If I do, my life in Charlotte will be saved for at least the short term. This is an enormous comfort for me. It means a lot if you have played any role.

I am extremely weakened. I hope to get my strength back, meaning that this fatigue that I have recently had will go away. This horrible stress that I am under keeps doing something to my heart, but whatever it is, it seems to always be temporary. At the moment though, I am extremely weak.

I need atriun to get me some medication refills. I need my olanzapine 5 mg tablets, 60 quantity, and I need adderall 20 mg 60 quantity. I need them to be eligible to be filled on 8/18/2021. I can call and have them filled that day, then my mother will be here on the 19th. She can take me to pick them up. My car is broken, and this will be the only time that I have a ride to the pharmacy this month. That's why I need my meds now.

If you could also pull the strings behind the scenes in any way to make sure my life in Charlotte lasts until I get payments coming in, that would be extremely helpful. My mother is going to kill me if she doesn't help me here at the final stretch. This is the kind of thing that she does, and it is murder trying to reason with her. If I have to go back to the mountains at this point, it will absolutely destroy me.

I will send you the audios about this appointment with Atrium soon. I may make them over. I am crushed and heartbroken that you appear to not be going to help me with them making it right. My life will be very sad and painful. All the promise my life once had has been taken away, and I will not get any of it back.

I killed myself working and working on myself for 21 years, so that I could be demolished for no reason at age 38. I asked this bank to tell the truth and have a conversation, completely consequence free, after it did me a terrible wrong.

You have had mercy on this bank, and I wish that you would have mercy on me. I had AU girl, and that made me so happy. Then you took her away. I apparently did something to offend you. Whatever it was,

I am a disabled and dying man, living in terrible pain and fighting for my life. I wish that I would get a pass on my behavior, and you let me keep AU girl and whatever life you were going to give me with that.

But I'm not going to press that. I am crying as I type this. But thank you again if you had anything to do with social security. Also thank you for any other help you have given me. I will die having never known what it is like to be in love, but I won't have to die in the mountains. At least I have that.



I promise that this can be handled. I need to be involved. The whole thing has gotten way out of hand. It is heading towards a disaster. If you contact me and put me in the process and in the loop, I can work with you to make this ok.

Right now, what we have is me being a terribly suffering disabled man. This terribly suffering disabled man is getting pounded with more than he can take. This is counterproductive because this disabled man has limits for how much he can suffer, and the behavior that results can not be optimal for our situation.

I am contemplating going to the inpatient unit on Billingsly road. I am not fit to be in the emergency room upstairs. I need to go to observation.

I need you very badly to help me. If I am made right here, it will work out for everyone. I can keep secrets and I will do whatever you need me to. There is no reason for anyone to believe what I have claimed anyways.

If I am made right and do not have to face the end of my life every minute of every day, I will be much better able to control myself.

I am willing to be institutionalized for life, if I can get any amount of comfort at all. If I could get sent to some facility, and have all my expenses for food, etc. paid for, and also get a disability check, that would be enough. I would just need to be able to have books, my iPad, my iPhone, and be able to use my computer. I would also need to be able to sleep and wake when I want, and have my diet and my eating times be up to me. I would like it to be a replica of my apt in Charlotte as much as possible. I am not fit to go out to places.

This may sound insane and I may sound like I'm asking for something special for me. On the former, this is an alternative to the end of my life (as I or anyone else knows it). On the latter, I have endured an extremely bad set of events and these events have injured me very extremely. There are roadblocks to me getting justice, and this isn't fair to me. I have heard of people who are a liability for Washington getting a room to stay in at the White House, for instance. I need an outcome that is good for me too.




I am a man of my word, and if you will just have them fill my adderall, I will drop this, I promise. I need to be able to fight for my life in Charlotte. I've got to apply for rental assistance and I've got to appeal SS decision.

I am a brutally damaged, destroyed, and handicapped man. I am all of these as a result of a terrible crime spree that hit me from every angle. I will live in terrible pain for however much longer that I live, if something doesn't change.

If atriun can work with me on my medications, there is some hope there. I am able to get a lot more done when I take extra adderall, and if they would up my dose to at least 60mg (I really need 80), I think I could possibly make my own living. I've asked for this for years. This extra olanzapine seems to repress my hyperarousal symptoms to some degree. I think that + more adderall may be the solution.

Someone needs to do something to help me, that is for sure. But please just have them fill my adderall. In the short term that will help me keep up my fight for my life in Charlotte. I can talk to them about increasing the dosage later. I will call them tomorrow about getting a script sent over to be filled.
