I probably threw that piece of mail away, not knowing what it was). I had a balance of over \$3,100. I've ordered a bunch of soylent shakes and also \$36 worth of beef jerky. Still have over \$3,000 left.

I ask that you please please please help me. I am so severely handicapped and I suffer so intensely. I will never make it unless you help me. It would mean so much to me and I am a good person.

AU girl emailed me to say happy birthday. I miss her.

I keep thinking of ending my life. I'm scared to death of this sodium nitrite. I can't get over the fear of some toxic reaction with the chemical. I'm worried it catches something on fire or that it burns my skin. Then there is the chance of surviving. I have an intuition that I will be one of the ones who react by violently vomiting. I am of a sensitive and delicate constitution, and this is how my body works. I want my suffering to be over so badly.

I wish so much that I lived in Belgium or that I could go to Belgium and be put to death. With this pentobarbital you go unconscious in seconds and die in about 30 minutes. What a dream that would be and how delighted I would be when I feel myself rapidly falling into a deep sleep. I would know that my suffering is over.

I'm getting overly detailed and giving too much info. Please please please help me. I cannot describe how much and how intensely I suffer.
