I am moving back to the mountains today. My mother and her friend Charles are packing up my stuff and have been most of the day. I am unable to pack stuff and help with the move, due to my condition.

I ask that you please cease criminally victimizing me. I don't know what I'll do in the mountains, but maybe I can start a new life there. I need my medication back and maybe the people in the mountains will give it to me. I understand that this situation with the bank is a big problem for you, but I never did anything wrong.

I think what I need to do is get on my feet in the mountains and then use that as a way to save up more money to go somewhere else. This is extremely ambitious for someone as handicapped as me. It is more likely that I die, I think.

I thought about Wells Fargo first thing when I woke up today. Thought about Wells Fargo all day and will think about Wells Fargo while I'm in bed tonight. I think about Wells Fargo because of this terrible handicap that I have and because my life is and has been crumbling. It is crumbling and I am handicapped because of Wells Fargo's abuse of me.

I am getting nothing out of this. That is the clear picture. It is heartbreaking and a horrible injustice that will likely kill me. It is pointless for me to focus further on getting help from you. I am out of reporters and I think the thing to do is to drop this fight for justice. I'm almost certainly going to die as a result, but no need to prolong things any further.

If there is something that I need to do to make you stop victimizing me, please tell me. I wish so bad that we could work together. If I could be part of the conversation on your end, we could make things easier for us both.

I have emailed you with my suffering repeatedly. I needed you to help me. You were the one I planned on getting to help me from the beginning. You had teased me with AU girl, and this made me stick with you hoping that I could get help from you. I seemed to come very close to getting help with her and whatever you may have had planned there.

I will try to email you less. I will try to cease emailing you altogether. If I die, I will send you one final email and audio. I will use Google's timed mail feature so that you get the email after I am already dead. I think you might regret something or be shocked if and when I die. I will send you those audios to reexplain and summarize why it is that this situation caused me to die. When you listen with fresh ears, you may understand better, and maybe you can prevent people dying in the future.

If people ask me what happened to me, I will tell them that Wells Fargo had me kidnapped, then Wells Fargo massacred me with crime, then I turned Wells Fargo in to the DoJ and the DoJ sponsored a cover up + criminal abuse of me. I find it hard to deal with anything other than the facts. If you need me to do something else, please contact me. We can work out a way to handle this.
