I was going to make you an audio but I am getting very weak. I put the chances that I get this in the media in the next month to two months at 20%. I have some new schemes that may work and some previous schemes in the pipeline. I had planned on giving up on the media completely if I couldn't make any progress, and I may still do that. In that instance, I would revert to a roughly thought out plan I have to get national attention on this through my own means, to do it more organically. What has happened though is that I have thought of some new schemes that sound promising.

I have offered repeatedly to help Wells Fargo in return for Wells Fargo helping me. I have given this offer when asking you for help. I can no longer offer this. What appears to be happening is my body is dying. I am getting very weak on and off, every single day. I have this feeling that I need to lay down and die. It is strange, but I can tell that my body is talking to me. My body seems to know that it is going to die, and I can sense the relief that I would have if I die. I very strongly feel a drive to give in to this feeling. It's like it is time for me to die. There is something different about me and how my intuitions work.

This is the result of the constant, horrific stress that I was under for so long. It was all that I could do to keep up my fight, by October 2020 when I had sent my complaint. A horrific struggle of constant, unbearable pain. What I needed was for the US DOJ to take some of the stress and burden of this fight off of my back, and to get me some relief. Instead, the US DOJ massacres me with more crime. My hellish struggle not only continues, but gets worse as I am under attack by more vicious crime. In a 4 week period in July and August of 2021, I lost 30 pounds from stress alone. I could feel my system being fried during this period, and I knew that I would face premature health problems as a result.

My struggle went on for a long time after that, until I finally got some relief from the social security administration, in June of 2022.

I got a letter saying that I would get \$1,581 a month. That was a huge relief and relief of not much more than that would have kept my body from prematurely dying, had I got it in 2021. This would have been nothing to Wells Fargo. I asked for \$5,000 multiple times and this would have been a lifesaver. When you're Wells Fargo and you commit a slew of felonies, it is too much to ask for you and to pay \$5,000. I'm not trying to brow beat you but this is the reality of the situation that we have.

My evidence and evidence analysis folders now have well over 500 documents of different file formats. It may be over 1,000. I am not sure. I have spent nearly every useable hour that I have on this for years. Of this 500 to 1,000 files, many are exact duplicates. I have some of the stuff stored in more than 1 folder, with each copy being the exact same file. My evidence analysis files are a lot of the same evidence rehashed in a new or slightly tweaked analysis. I still have a mountain of stuff, even when you account for this .

You have all done a terrible wrong, many terrible wrongs. You can still make something constructive out of this. As of now, I have very little capacity to help you make something constructive out of this, however. It is a shame because I had so many ideas. I need an enormous sum of money. That's what's in this for me. I would also like for the people involved to be punished, but that may be too much to ask

and I'm not sure I could endure the court trials. If you would help me I would try. In re an enormous sum of money, there is likely no amount that would make me happy and there is certainly no amount that would make things right. There is no price that can be put on what I have suffered and what I have lost. I think \$3 billion is a more than reasonable, and a very modest request, in reality. I want to get some money and move to another country.



My arm went numb for at least 45 minutes last night. I have been very weak and short of breath. I've told you this before. It is an ongoing thing and the day is coming.

I cannot afford medical care and I need medical care for this. I need this bank to be made to make it right with me. I have been so severely damaged. I felt my system being fried during this battle, and I correctly anticipated that I would have premature health problems.

You could have stopped this. If you would have helped me when I asked you to get me \$5,000 to relieve my stress, that would have worked. A few months in a row of \$5,000 would have given me time to heal. If this sounds outrageous to you, you are from another planet. I'm asking for a \$2 trillion bank to give me \$5,000, to save my life after it injured me and left me a disabled, dying man.

The rightful cost of these crimes is to prosecute the bank and tank the global economy in the process. Is it worth \$5,000 to keep the entire economy of planet earth running? Given that it is running at my expense, at the cost of me being denied justice, is it too much for me to ask for \$5,000?

Relative to my condition as this battle progressed, I was still fresh in January 2021. You could have saved me from this massive damage to my body and mind. Now we have reached the point where there is no good outcome possible for me. My health is deteriorated to an extreme and it continues to deteriorate.

The right thing to do would be for you to help me, but I'm getting pissed as I'm typing this. I just deleted about 27 sentences where I tell you off. I'm not sure about this being in the media. My offer to settle for \$3 billion is more than fair. I could move to another country and make my life count. I like the United States and I would hate to leave, but it is necessary.

You should have taken me up on my offer to help Wells Fargo, back in early and mid 2021. If I were fresh, I could fix their business. It would take a period of years, I think, probably 3 years or maybe 4, but I could do it. Now I'm in such condition that I will be unable to help them. I am most likely at the end of my life.

What this bank needs to do is work with its regulators and do some capital raising. The fed has capped its balance sheet, and this is hampering them from fixing their business. The other thing that is hampering them is that they want to go on like nothing is wrong. The game plan is to post a profit next quarter, each and every quarter. Then, of course, they pay dividends. Fixing this business and posting a profit, business as usual, are likely mutually exclusive options. For sure it will take far too long, doing it that way. The damage to its reputation, by the time it is fixed, will be enormous. The weeds have grown for far too long in this bank.

They need to get the fed to lift this asset cap, so that they can raise equity capital. Wells Fargo and the Fed can have an agreement and make a plan as to how the asset cap loosening will be for the purposes of raising capital, and not for the purposes of acquiring new customers or taking on additional revenue producing assets (loans, etc.). They can use this equity capital to renovate their business.

Step 1 is to go throughout the entire business and find every business practice that is even marginally unethical. They need to weed out all cutting corners. All of these are scandals waiting to happen.

Step 2 is to fine tune each business, each business process, and each point of contact with the customer. From what I've read, Wells Fargo's banking app for smartphones crashes very frequently. To use that as an example, if it were me, I'd have the whole app rewritten from scratch. I'd hire the best in the programming biz to do this. Have it written using test driven development. You want a perfect app that has 99.9% uptime or better. If it is written well from the beginning, fixing it when it breaks will be easy. The goal is a perfect experience for the customer.

The last sentence in the preceding paragraph relates to a broader thing that I have noticed about Wells Fargo. Wells Fargo does not seem to focus on the customer having a perfect experience and Wells Fargo generally doesn't seem to value competence or realize how important competence is. A lot of shoddy work and shoddy business practices seem to come out of Wells Fargo.

So that would be step 2. Perfect and fine tune every process. Make the customer experience consistently flawless. Mine your customer complaints for ideas of how to improve.

Step 3 is to innovate and broaden the product offering. Focus on how you can meet a more diverse set of customer needs. This will beef up your revenue and your customer base. It will also beef up your profits and your cash flow. Your shareholders will experience price appreciation that more than offsets the dilution of equity resulting from your capital raising.

Here is what this bank has going for it- it has a 170 history and an accompanying reputation that was built up during this same period of time. Over these many decades, it has built up a massive customer base and built up thousands of locations to serve its customers. These are the raw materials for the greatest company ever to exist. A 170 year history cannot be bought. It is a competitive advantage that has to be acquired the hard way, and a business with this advantage has the upper hand, as long as it plays its cards right.

If you come to the table with a grand vision to use as you renovate and then optimize this business, you will have the best bank in the US. You will likely be recognized as the #1 company in America.

I just typed this, kind of winging it. These are some of the thoughts I have had about this bank and what it needs to do. I forgot to mention step 0, which is to get rid of (meaning satisfy) all of the outstanding obligations to customers who have been harmed. This seems to be a big part of the regulators concerns, and if it were me, I'd be sick of looking at this list of customers at about 10 minutes into my tenure. If I had to take a loss for 1 quarter, or 2, or 3, it wouldn't matter. These obligations would be off my desk ASAP. I would be looking for ways to automate the resolution process.

I'm going to keep trying to get this in the media. For that outcome, one of my next projects is to do some analysis materials for wrongdoing the bank has done outside of me. This includes wrongdoings to congress.

My reason for doing this is that I predict your next move, if this comes to light, is to character assassinate me (or at least attempt to). I'm going to have to preempt you on that. I can tell you right now that any character assassination attempt at me will fail. If not in the short run (I don't even see you winning there) for sure in the long run.

It would be so much easier if you would be my friend like I asked you. We have a mutual interest in resolving this situation, and I'm not a bad person at all. Then you continually treating me as a man with no dignity has destroyed my sense of self and made it a taboo for me to be happy.

Im good at some things and not too good at others, and I think I could help you smooth this over with the public. That sounds insane to you, probably, but I think it can be done. If I have to report this to the media and get it in the public eye that way, you can expect a hellacious beating. You are very powerful people and may end up beating the hell out of me some more, but this will do nothing to the fact that you're going to get creamed. Your behavior towards a kindhearted man who did you no wrong is despicable.

I sensed, in the beginning, that smoothing this over with the public would be a task that we had to handle, and I offered to help you with that then. My concern then was that I was disabled for life and I didn't want to lose my new life in Charlotte. That's what I wanted, and I was willing to do whatever it took. I also expected a lot of money. I have believed the whole time that no amount of money can make me better. There is no price that I wouldn't pay to go back in time, and there never has been.

Wells Fargo, and perhaps the US DOJ too, has left the planet, it appears, in not accepting responsibility for what it has done to me. These people appear to be denying or trying to deny that I have PTSD or that I ever had PTSD. That's the sense that I get. In this, as a part of it, they are probably holding on to something about the DSM criteria not seeming to precisely match my circumstances. I could speak a lot for why this is not an issue and why this is not the way to think. I will save that for later though.

The next thing they appear to be doing is saying that, even if I have PTSD (or whatever condition that I do have), they did not cause it. This is silly in a million ways, but I will try not to beat you up about it.

We are in a very familiar situation, the situation where I am completely right and my facts are the game winners. It ends up this way almost every time.

What I want out of this situation is \$3 billion + possibly seeing some people punished. After I get that, I can talk to AU girl on my own and see what she wants and what I want. It is likely that I choose to move to another country, quite possibly just me alone. I have lost everything in this victimization and in this battle. I seem to not be welcome in the United States, no matter how hard I try to do right. I can move somewhere else, where people don't know me and where most people don't speak English, and then I can live and die in peace.

If you want to settle with me now and can do so without making any news that would put a spotlight on me, please do it. I will take something much less than what I've talked about recently. If you have to hide what you are doing, I will take smaller payments over time, small enough for you to hide. I will still need something pretty big, because I have serious health problems currently + more that are more serious on the way. I will likely never be able to work again. i am completely safe if i live alone and can control wher people are around me. i can maintain that indefinitely. i also appear to be safe living here with my mother only. shes almost never here. this situation still scares the hell out of me, at times.

I like AU girl a lot, but if shes still an option to consider, no way in hell she could live with me. we'd have to have separate houses and Id have to debrief here on how to be. it would be extremely hard to make it work, but we could do it.

it is kind of hard to explain this feeling that I get. it is not an anger based rage, not the way that people without severe PTSD experience anger.

i feel as if i am man who has went to war, and has been captured in a jungle, and been put in a wooden or maybe a bamboo cage, with no shirt and no shoes. picture yourself in such a situation, and keep imagining as i continue to explain. picture yourself being this man, and your captors being sadistic men who like to torture you. picture yourself having fought a brutal battle, before being captured.

Now picture these men ganging up on you, around your cage. picture them taunting you cruelly, while they stick you skin with arrows and knives, through the holes in your cage. picture them ramming small logs with sharp ends through your cage, just to torture you. picture them getting endless delight from your suffering and your humiliation, and this going on for years.

how would you feel, after years of this, everyday when you see your captors coming back to torture you? you would feel worthless and humiliated. years of this would have left an imprint on your brain. this is no longer something you feel, it is something that you are. in this state, you would feel kind of tender and you would be in incredible pain. im speaking of your emotional condition, though the feeling i am trying to describe has a definite physical component. when i feel it, i can feel it in my brain, somehow, and if i recall correctly, i can also feel it in at least parts of my body.

the way out of this pain is not for your captors to leave. what you would instead be driven to do is to reclaim your worth from your captors. this pain and sense of worthlessness that you feel would compel you to want to murder them. thats what would go through your mind every time they come to taunt you, and you would so desperately crave that relief. Your pain would be so horrific and so unbearable. you wouldnt be angry, in any sense that you would recognize in your former life. it would be a new kind of rage. for me, it is best described as a strange kind of intense hostility.

i am not in quite that dire a condition on an ongoing basis, but when I see the slightest sign that Im being treated as less important by someone, i start to become that man who is trapped in the cage in the jungle. i am very quickly overcome by this pain based hostility and i feel that i must murder the person who is treating me as less. this feeling is such that i feel it would rapidly intensify if things escalated.

thus far, ive had very scarce instances of this, since living with my mother. the big factor there is that 1, shes never home, and 2, shes a pushover. she never asserts her needs and she almost never gets the least bit angry. there have been a few times where she got a little angry and i knew that i would go off the deep end very fast if things escalated. i would feel it coming on very strong. i made sure things didnt escalate. there have been other times when i had some grievance, and i had to exert my self control and not bring it up, because i knew that if the least little bit of fight got started, things would very fast become a disaster.

there have been 1 or 2 other times where I felt like murdering someone other than mom. i can remember one where i felt it very powerfully, but the person left as soon as I felt it. it was a coincidence of timing. the person didnt sense my hostility.

i have cried as i typed this. you have ruined a human being for no reason. but you have some goal or something that powerfully drives you. whatever that is, it doesn't matter. you need to make it right with me. what you have done is horrible, though i understand that you never meant to do it. i also understand that it may not make sense to you, how you did this, but i promise you that you did.

i need you to act fast so that we can get a settlement before this goes to the media. if my media person responds, i will move forward as fast as i am able. i will be marching towards doom, but the current nightmare i am living is a motivator and i dont seem to get anywhere with you.

The first time he did it, I was outside and I felt myself getting hostile. I had an involuntary reaction (it seems involuntary) where I yelled at him. If a professional or even a layman saw what I did when I yelled at him, it would be obvious that something is wrong with me. I have this reflex like reaction and I appear as if I'm mentally retarded.

He did this again several more times. He would yell at me when I'm taking a walk. I sort of built up a tolerance where I don't get so hostile. I'd call him a rapist and say things to him about him being on the sex offender registry. If he caught me at the wrong time it might be dangerous, and if he came in my house and said those things it wouldn't go over well. I'd be probable to try to kill him. He'd likely get away. I'm clumsy and can't run fast. But that's an example. I'm not totally out of control of myself. The landlady talked to him and he's toned down his name calling.

The big danger is with people living with me. I know for 100% fact that I can manage this problem if I am allowed to live alone. I also have to be careful about where I go out to, and it's not a good idea for me to go to other people's houses. Right now my car is broke, but even if it wasn't I would almost never go out. If this isn't enough to cause someone massive damage, what is? I have been massacred by people that outweigh me by more than 200,000,000 to 1. These people are unconstrained in their behavior, allowed to commit any crime that they wish. At the same time, I'm bound by the law. In fact, I'm beyond bound by the law. Any time I see signs that someone is treating me as less important than them, I very quickly get hostile. I feel like I want to murder them. It has happened pretty rarely, with the exception of mom, and the people tend to not do anything to further provoke me or they leave. If it escalated, I fear that I would not be able to control myself and that I would murder them.

I know for 100% fact that if I lived alone I could maintain this situation indefinitely. No one would ever be in any sort of danger. Living with people is very dangerous for me. If I lived with someone other than my mother, almost certainly someone would already be dead. My mother is not here much at all and she doesn't get mad or assert her needs much at all. Any other person would be irritated at me over my peculiar living habits, my constant pacing the floor, and my being up at all hours. If I had a girlfriend living with me she would eventually start hyperventilating and going apeshit. All women do that. In either case, the minute people start yelling at me and going off in my house, they are dead. It is not something I can control and relates to this extreme pain and feeling of tenderness that I feel. The pain is unbearable and the way out is to murder the person causing it.

This will be accompanied by the same people having huge insights into me and the kind of person that I am. More audios on the way

I'm making you some audios on my new computer. It's such a beast and it opens up new possibilities for my fight against Wells Fargo. I made about 5 audios this morning, starting at about 6:45 am. I had to quit on number 6. I got too tired. I'm going to pick up and finish number 6 tomorrow. Then I have more to make. They're kind of long. Ranging from maybe 14 minutes to maybe 18 minutes a pop.

I suffer like hell. It is constant torment. I do not like living and I'm not sure that I ever will. I had a sort of good time making these audios. I need at least \$3 billion to make life even remotely worth living. I will take less if I end up with no other option. \$3 billion is pennies on the dollar.

I am writing a book. It will detail my hard lived life and my being cruelly murdered by Wells Fargo and the United States of America. And that's what you've done. You have cruelly murdered a kindhearted man for no reason. The story that I tell will scream of heartless, cruel murder, and the story that I tell will be the complete truth.

I have suffered the kind of murder that you survive. It is the worst kind of murder. You have murdered my soul. When you are exposed for murdering my soul, you will face consequences. Not everyone is as cruel as you. If I go you will go with me. This bank will have to begin the process of winding down, to close its doors for the last time.

I don't mean to be pedantic or to take on a holy than thou art attitude, but it is a terrible mistake to not listen to me and to not take everything I say as the complete truth. I think it can be easy to think less of me. I have self-control problems, and this is kind of obvious in my behavior. I may not seem too competent because of this and other things. You also may have been influenced to see me as some sort of dishonest person. This is another terrible mistake. Everything is exactly as I say that it is. I'm trying to save you and I'm trying to save me.

It may sound insane to you for me to ask for billions of dollars. This is not at all unreasonable and if I had a group of experts to opine they would unanimously agree, and they would also agree that this is pennies on the dollar.

At any and all times where you do not see things as I describe them, you need to find out why. You need to question yourself or look at this from another angle. Reaching out to me is the best solution. I am a decimated human being and am likely to scream and cry on the phone.

My healthcare records are not going to get you anywhere. I keep coming back to those because I feel like they have prejudiced you. I have sent you an explanation of those. What may also need to be mentioned is that my behavior during that hospital stay was not atypical for someone having a mental breakdown (for which the technical term is psychosis). My childhood had a role in how my symptoms manifested, but I am far from the only one to say disturbing and extreme stuff. It is very typical.

If you want, you can verify this. Have Wells Fargo illegally obtain the healthcare records of another 5,000 patients from that hospital. That hospital does as it pleases and so does Wells Fargo. This shouldn't be hard to do.

In those records, look for the patients that were having a psychosis, particularly those that had a psychosis as a component of a manic episode. The hospital staff may not always be thorough in documenting what the patients say, but you'll find plenty of examples.

I picture you justifying this criminal massacre by saying that I'm a "psychopath" and making these horrible characterizations of me. You may justify this based on my healthcare records. If you look it up on WebMD, it will not list saying disturbing and extreme things as a symptom of bipolar disorder. This is not a problem because the audience that my medical records are intended for are people who have no need to look up the symptoms of bipolar disorder on WebMD. They have years of education and specialized training, and almost all of them have a good bit of experience.

We have entered into a complete farce. We have a bank and a bunch of law enforcement people attempting to practice medicine and justifying the criminal massacre of a disabled man based on the conclusions that result from this ridiculous exercise that they've undertaken.

Do you really think you know this better than the more than a dozen medical professionals who have saw those records before you did? I'd like Wells Fargo to give me an example of a job that requires education, training, and experience. These people seem to have the notion that just anybody can do any job, and that's what got them into this mess. Bill Vanhoy is not qualified to run a credit department. He's also not qualified to practice medicine or to be a psychologist. As far as I know, NO ONE that works for Wells Fargo is qualified to practice medicine, and if some are, my medical history is none of their god damn business.

Here's what I needed-

-I needed Wells Fargo to be an employer.

-I needed Atrium Health to be a healthcare provider and to protect my privacy.

-I needed Broughton hospital to stop committing crimes against me. I also need them to have a security protocol for their release of information department.

When all of this didn't work out, I needed the United States Department of Justice to be a criminal and/or civil law enforcement agency. I don't need them taking over my healthcare. I need them to take this airtight case, that I built during a period of extreme and unbearable suffering, and hold these people accountable. I was so disabled that it took me 7 months to write my complaint, and when I sent it it wasn't even halfway done. 5 minutes of proofreading would get me 2 to 4 hours of pure hell with my symptoms. I even made a web portal for you. I mean it's on a silver platter.

I don't get what I need. I instead have the whole god damn world looking at my healthcare records, as if there is anything there for them to see and as if they are at all capable of interpreting or understanding them. These people at the Federal Reserve are the most extreme and cruel bigots I've ever met. I mean it defies reason and I don't even know how to describe it. It's probably the case that the people at the US DOJ share this same extreme prejudice.

In my audios I have spurts where I get mean and demeaning towards you. I also call you bigots and criminals on Twitter. You people have really pissed me off. I used to think that you are my friend. The point of this is that I will change my tune, at least slightly, if you will just help me. We've reached a point of no return however, and you can forget me being happy. You can forget any possibility that I go for as much as one single day where I do not think about this situation. It will dominate my life and I will always look forward to the day that I die.

I can also tell you that the chance that you get found out, concerning your cover-up and other crimes, is a least 95%. You will not get away with this. You will have to answer and it will reflect terribly on you.
