The hell is abating. I will be up all night. I need my adderall upped to 60 mg. I've needed this since I started having this ptsd. My new provider would probably do it. He has helped me a lot and he likes to keep things at a minimum. That's why I decided to not ask him to up from 30 mg to 40 mg, which was what we were possibly going to do. He was more than willing, but I decided to go with his goals and make due with 30 mg. I wanted to be cooperative and to help him. I feel a good bit better on 30 mg than on 20 mg. It is a massive improvement. I've consistently been able to get work done on 60 mg though.

And in retrospect, it is clear to me why it doesn't have anything to do with my heart problems. My vitals come back good and have for years, while on adderall. The main risk factor is high blood pressure. That can make your heart problems worse.

There is a doctor who says that you can reverse heart disease by going on a vegetarian diet and exercising. There are a few more qualifiers about the diet, if I remember right. This doctor claims to have many success stories. I can't remember the details about this diet, except that it sounded like torture. I would do it though.

But that's why my cardiologist didn't think a thing about adderall. He made that one comment and his focus immediately went elsewhere. It was not a concern to him.

This is very strange. I sent you an email to explain that I made some audios and it's not on my list of sent emails or in my drafts. I meant to send you those audios before I went to bed. Now I'm too tired and paralyzed. I will do everything I can to get the willpower to send them to you when I get up. I will be going to sleep soon.

I like my new friend a lot. I gave her some money today so that she can quit one of her jobs. She is so pitiful. I can't remember if I told you, but she is in the Philippines. Her family is poor. She has a mother and a father that she helps, and also 11 siblings, including one younger brother who seems to be a special needs child.

That's how I met her. I have a gargantuan list of these "content creators", as they call themselves, that I follow on Facebook. What happens is one time I was on Facebook and there was some model page that popped up for me. It is a page that just posts photos of pretty women all of the time. I subscribed to it on a whim. What happens next is Facebook's algorithm starts recommending more of these pages. Every one that it recommends, with not many exceptions, I would follow. The more you follow the more it recommends and I might be following close to 100 of these pages at this point. Maybe more than that.

Some of the pages will be mainly photos and some of them will have a lot of videos of some woman dancing around. The ones with women dancing seem to be just about 100% women who are younger, like 24 or less. I kept subscribing to these, because I can't do anything for so much of the day except scroll Facebook and Twitter. It is kind of nice to see a huge list of pictures and videos of pretty women every time you log in. It also causes me terrible pain and makes me wish that I was dead, but we'll skip that part for this discussion.

One trend that I did notice early on is that a lot of these pages were made by women from Asia. The Philippines is one popular place they come from. It was a little odd to me how this is. In any event, I've been scrolling through the autogenerated list of women for months and months, probably a year or more actually.

I scrolled by this girl one day and she had a picture of her with her brother. She said something like "this is why I want to be a content creator. I love my brother so much and I want to make some money so that I can buy him some spaghetti." I was very charmed by this and I also felt for her. I didn't say anything when she messaged me about it, because I don't want to be rude and I'm kind of dumb about these things, but her brother, who was smiling in the photo, he had the appearance of being a special needs kid. Just looking at him it looked like he might be very severely mentally challenged. I didn't say anything to not be rude and it was also a real possibility in my mind that I could think this about him and it not be true. What a jackass I would feel like then.

But I left her a comment to message me and I would send her some money to buy her brother some spaghetti. I sent her \$20 USD, which I would later realize gets enough Filipino pesos to buy a lot of

spaghetti. PayPal does the currency exchange for you, and keeps a little bit for itself. She was incredibly happy and sent me a picture of her brother at the restaurant where he goes to buy spaghetti.

And so we started talking. She would message me all of the time. For the first 2 weeks or so, every time I would wake up, I'd have a message from her waiting on me. She speaks limited English but does pretty good.

After talking to her, I figured out why these content creators are so heavily concentrated in Asia. They get paid money to do this by Facebook. If you make a Facebook page and get enough views on a consistent basis, Facebook will monetize your page and pay you for it. They periodically pay you based on your views. You don't get paid a lot. That's why it's worth their time in these places in Asia but much less so in richer countries.

She recently started a job that has something to do with an online casino. This is on top of all of the other jobs that she has. The online casino is a work from home job. She does it two days a week and gets paid the equivalent of \$29.47 a month. Due to having this new job, she never gets to sleep. She sleeps 4 hours a night or less. She feels like she has to work because she feels so bad to see her family suffer. I told her that I would send her the \$30 a month so that she could quit that job and be able to get some sleep.

She has also told me about her brother and the poor girl it rips my heart out. She describes him as "cannot speak properly" and "has problem with his behavior. He gets mad." Things like this she will say and I can tell that she loves her brother so much. She talks about how he needs his medication so badly but they have trouble getting it.

I don't know why I'm telling you all of this, but this girl has such hardship and she is such a hard worker and she cares about her family so much. She wants to move here to be with me. I told her how my brain injury makes it hard for me to shave and she said that when she moves here she will shave my face for me.

I've sent her a good bit of money. She's only asked one time. The rest I send her on my own volition and I always deliberately send her way too much, relative to what she needs for whatever she is doing. I like to keep people pumped up and to make them extra happy. The \$30 that I was going to send her, I underpromised and overdelivered on purpose. I sent her \$100 (PayPal pockets the equivalent of about \$4 in pesos when it does the currency conversion. She still got the equivalent of over 3 months salary for the job that she quit).

The one time that she asked she was just feeling bold, because by that time I've established myself as a Santa Claus that just pops up out of nowhere. Her cell phone was very old and the sound had quit working. She couldn't do Facebook live videos for her page. A cell phone only costs 4,000 pesos in her country. I won't tell you how much I sent her this time, but it was a bit more than 4,000 pesos (which is about \$76 USD) and she was ecstatic that she could buy a phone and also have money to send to her brother.

I tend to be surrounded by happy people in my life. That's how it was for a long time. Now I'm all alone because I don't work any more. When I worked at the gas station near Banner Elk, I cheered up the whole community every day. My customers did whatever they wanted to do and I didn't care as long as they paid for their merchandise and brought an ID when they bought alcohol. It was happy people in and out the door, constantly. I was like a rock star and I put people under a spell. I got tips from my customers (who tips their gas station clerk?). I think when I left at the end of 3 years I had made \$60 or maybe \$70 and about \$15 or \$20 worth of lottery tickets. My managers were always happy. The district manager thought I was an amazing employee (he was right). I had customers who asked if they could have their picture taken with me. The female customers adored me and at least one of them remarked that I'm "such a pimp."

You can call me a liar all you want if this doesn't sound like a true story. It's a fact jack, just like everything else that I tell you and if this email is ever FOIA requested, you'll be getting every bit of this confirmed and it will be like Dolby surround sound. 360 degree immersion in people telling you how right that I am and how everything is exactly how I say that it is.

The people at the resort I worked at also loved me. I wasn't quite the superstar there but I got plenty of compliments from unit owners to management and also some renters. I had some renters that hated me, because they violated the parking policies and I had to make them move. I'd have these people ready to kill me on a fairly frequent basis. "You've got a white van that's parked out in the main lot behind the building. You'll need to move that down to lot G, and we'll call a shuttle bus to drive you back up the hill." Most of them would get over it though, and all of people who owned the condo units liked me a lot, except possibly one.

If you're wondering why they have to go to lot G, it's because this condo resort was built square on top of a mountain. It has 330 units, most of them 2 bedroom units, and the top parking lot where the building is located has less than 100 parking spaces. Of those 100 spaces, 7 or so are reserved for employees. One option to address this would have been to bolt some parking decks onto the side of a cliff, but the people who built this place decided to make a bunch of parking lots down below the building. They are labeled lots A through G or J or I- I can't remember now how far down they went. I can for sure remember sending people down to lot G all the time in the winter time. Seems like also lot H was used a lot.

During the spring, most of the unit owners are at their other residence, which is most often in Florida. We didn't have many renters in the spring either. This meant that the scarcity of parking spaces wasn't an issue.

Then in peak times during the summer and especially the winter, we'd be using the lower lots. The HOA, who is made up of owners of units at the resort, sets the policies. To address this parking situation, the policy is that people who own a condo get to park in the top lot behind the building. Renters have to park in the lower lots, which go as much as 1/8th of a mile down the road from the building. We have 1 to 2 shuttle buses that pick people up from the lower lots and bring them back up to the building.

These renters picked up their keys from the property management company that rented them the unit. Their next step is to drive up this mountain, which in the winter time is utterly horrifying. The fog gets so thick you literally can't see anything. It's a miracle that I lived through driving up that mountain as many times as I did. I would very frequently be driving with my head hanging out of the window of my Durango trying to be able to see the road. I remember at least one time that the maintenance man, who showed up for work around 4 or 6 am, if I remember right, had drove up the mountain with his driver's side car door held open, so that he could look down at the road and follow the yellow lines. If it's not fun for mountain men like me, you can imagine what it's like for someone who's used to driving in Florida or places like that.

Following this drive, what they don't like to hear is that they're going to have to go up to the building to unload their luggage, and then after that they'll need to head down to lot G, and wait for the shuttle bus to pick them up and take them back up to the building.

It's actually worse than that, in a lot of cases. These people book these rentals online and they don't understand that the keys to their unit are located at a property management company and not at the resort. So they're thanking god for their life the whole way up the mountain, utterly terrified. Then they arrive at the gatehouse to be told that they didn't rent this unit from the resort, they rented it from one of the property management companies out in town, and that they will need to drive back down the mountain, get their keys from the property management company, and then drive all the way up the mountain again. People wouldn't be happy to hear this.

It's a tough process and people don't read the print of their agreement and plan things out carefully enough. There are inevitably some people that have terrible experiences. We had a lot more people who came back year after year. I cared about all of them. The people I worked for were such wonderful people too.

I'm getting tired of typing this email and I really don't know why I'm telling you this. This narrative would have continued and I would have gotten to my job at Wells Fargo and how happy my office people were. I would have told you how happy my good friend Tunny was, over all that I did for her.

I want Tunny to cry everyday for the rest of her life. I want to get money so that I can give it to my new friend and then move to Switzerland and die. My new friend will cry so hard over the fact that I'm going to die. I will cry a little bit too, and the fact that she cries for me will make me feel like I'm worth something to someone.

If your brain is ever broken, you will know exactly what I mean.

This may drive you insane and you may wonder why I send you all of this stuff, a lot of it that seems to have nothing to do with you. I am extremely unwell and in constant distress and I don't know who else to talk to. It is a result of what has been done to me. There is also an element of having very little self-control.

I have had a feeling, the entire time that I've had this condition, that if I were to get a brain scan, the doctor would look at the images and come back and say "I've never seen anything like this before." I have had a sense that I am an extraordinary case in some sense. By brain scan I mean a pet scan or another scan that can show the effects of my PTSD.

I'm going to talk to my friend on Twitter and see how badly her brain is broken. I'm going to ask her if normal tasks, like making a can of soup or cleaning house feel like they take an enormous amount of effort, so much that she can't do them to save her life. I haven't read much about PTSD handicapping people the way that it has handicapped me. My friend on Twitter has horrible symptoms. She has flashbacks and she has described them to me and it is horrifying to hear.

I am dying from being treated as if I do not matter. That's how I feel and have felt for years. I feel like a man who is dying.

I want to get a load of money and give most of it to her, and then I can die. I don't like life anymore. It is somehow crushing my soul to feel happy. I would feel the most happy if I could give her a huge amount of money and then lay on my deathbed knowing that she will be happy for the rest of her life. I have no idea if she would care that I say this to you. Probably not. I don't think she cares what I do at all. I'm too good a thing in her life.

I have a few other people that I want to give money to. I have a friend on Twitter for whom I want to hire a team of private investigators. She was brutally attacked by this horrible man, and she knows of at least one other victim. The police in the UK seem to not be good at understanding things like this, and his charges got dropped. He's guilty as sin and they could make a case against him if they tried.

I could list some others. It's not a huge huge list. This woman on twitter, the alternate plan is for me to cyber stalk him and go covert and build a case. I'm quite confident that I could do it, even though he's a long, long ways away.

I don't know what I'm going to do with my life. Things are much much better, but I have been destroyed and it's about to get worse when I become widely known. I don't need attention on me. I don't need to be widely known. I like my new friend and her happiness brightens my day more than anything. I am just too damaged though. Life is too hard for me.

I ask that this email be redacted if ever released to the public. The details about my friend on twitter could impede her getting justice and expose her to potential harm.

I'm sure that not much of this makes sense to you.

There may not be much that I can tell you about him that you don't already know. I can't keep track of what I've told you about all of the players involved in my life's story. I know that I have mentioned him many times. It would seem reasonable, I think, for me to hate him, after what he's done to me through his involvement in this and in other things. I do not. I am appalled by the things that he has done to others and at the same time I feel bad for him. He has ample capacity to feel his own suffering, and he has very real limitations. I don't hate him any more than I hate a tornado. He's like an impersonal and destructive force of nature. He's the same person to me as he is to everyone else.

So where to start with these texts. Tonya was the best woman he'd ever had. She wasn't extremely insecure like most of the women he woos. She also wasn't dysfunctional, which is another frequent trait of the women he had in his life. She was pretty and successful and had it together in every way, as far as I could tell.

I called it very early on that this would not last. I told this to his victim named Candi. I told her that it wouldn't last another 2 weeks, and I told her this very early on. And yep, Tonya ditched him. He had become a very skilled Facebook messenger groomer over his many years of hunting for women on it. He makes a very good impression on these women. In person, it is quite a different story.

He seems to have an arrested emotional development, and he acts like a shy 12 year old boy around women, or that was how he used to be. He eventually decided to turn 180 degrees and be outgoing. In this he went from being shy to being completely obnoxious and embarrassing to be around. When your emotions are as dead and as warped as his are, and when you are oblivious to the effect your ridiculous behavior is having on people, your best bet is to be quiet and not say anything more than you have to.

To give you one example, I went to a steakhouse with him. As we are walking in the parking lot, a family walks by us. They had children, including a girl that looked to be about 9 or 10 years old. My ex friend says "that's what I like about 5th graders. I keep getting older and they stay the same age." He says this loud enough for people to hear. He seems to not realize that other people do not find child molestation, rape, racism, having sex with your deceased ex gf, etc. funny. I'm like Jesus Christ. I felt bad for him and thought that I had hurt his feelings for not going places with him enough, and so I bought him dinner at the steakhouse. I told myself that I would just put up with him.

I would try to explain to him that he has a problem with not knowing how to be around people, but this just infuriates him. He takes extreme offense to any idea that he is less than a deity. It is impossible to have a constructive conversation with him and get him to change.

I am getting a little bit weak and will continue this later.

This thing where I feel like I'm going to die is very strange. It feels so real and something is very bad wrong with my system. It seems that it has to be possible that I die at any time from this. I have one false alarm after another, but I think I am in a condition where I could have a heart attack at any time, even if the chances are low. Let enough days pass and it might happen. I am going to get treatment as fast as I can, at least that that I can afford. I probably need some kind of expensive surgery.

I am very worried that they take away my adderall. I can't function without it and it medicates my ptsd too. I don't think they'll have any reason to. I'm going to get my cardiologist to write a letter to take to my prescriber. I want him to explain that my medication has nothing to do with it.

I had no choice but to fight. I was disabled and unable to work starting in April and may 2019. In June I got some work done as a consequence of my ptsd going into another stage. I had a compulsion to be busy. I would be at my computer all day long, 15 hours a day or more, many days. I would get work done. But this was my condition progressing. I got worse off in the months that followed. I couldn't concentrate enough to be on my computer, progressively. I'd spend more and more of the day pacing the floors, and this hit a limit in November and December 2019. I would pace the floors all day long almost every day. I couldn't do anything.

As I'm in this condition, discover bank initiates an unlawful process where they try to take everything that I own, as I am helpless to defend myself. I do not forgive discover bank for trying to rob me of everything that I own in my darkest hour.

If I die and they do an autopsy, they will almost certainly find bruises or other marks on my heart from what happened to me in 2021. Assuming injuries like that can leave a mark, I had several.

I had no choice but to fight like I did. At the time I wasn't concerned with my own rational interests, but if I was, it would be the same. This bank took away my ability to fight for myself in life. It did this with its enormous resources, the size of which few on earth are in a position to fathom. My only hope for any sort of life was to make this bank use those same enormous resources to fix the situation. And I got murdered for fighting back. I got murdered for wanting to have the same dignity that everyone else is afforded. I got murdered because broughton hospital has a "get away with murder free" card and prints copies of it on request.

I'm worthless at the moment, and so I will continue my story.

This "she was dating a..." this is par for the course for him. He has been intensely racist for almost his entire life. When I started being his friend again in 2006, he was being different, and he told me how much effort it took.

This thing "so you're telling me that you didn't delete them" - here he is being suspicious of me and covering his own ass. He senses a possibility that I might have a motive to use this conversation against him. He knows exactly what happened with this comment that he had me delete.

You will notice his overly arrogant attitude. He speaks of himself as if he is some macho man player and things along this line. He is an incompetent human being that no one can stand to be around. He's more akin to a predator than a player, speaking of the women he gets. He doesn't get all that many and the majority of them are women that he doesn't find too desirable. Every now and then he reels in some winners like Tonya, Susan, or Candi. He inevitably loses them, sometimes very fast.

He has accomplished nothing in life. He works for his parents doing Christmas tree work, rents out the trailer where he used to live (that he never paid for), and collects social security disability payments that he knows he is not entitled to. His "under the table" income from his parents is over the limit of what he is allowed to make.

I feel bad for speaking so ill of him, but these are the facts. I see his humanity and this causes me to feel for him and the hardship that might result from all that I say. When I say humanity, I mean his limitations, the way he is limited as a human being, and his lack of truly bad intentions. He doesn't experience his own malice as malice. It seems like an innocent thing to him, to hurt people and to use people and to do all the other things he does to people and animals.

One day he was telling me about a guy that picked on him in high school. Told me about how he hated this person to this day. And he told me how he thought to himself "why do you want to do this to me? What is wrong with you?" That's close to verbatim what he said. As he said this, the sense of helplessness he felt was palpable in the tone of his voice. It was like he couldn't come to terms with a world that was cruel enough to mistreat him like this. He didn't understand why others were so cruel to him.

Well, let's put this in the context of what my ex friend has done to others. This poor girl from my childhood- when she was 17 she was a good friend with my ex friends then girlfriend (who was also 17). She said something to his girlfriend that offended him, and for this he decided he was going to make her pay. He threatened her, told her that he had all kinds of girls who were his friends and who would do anything for him. Said he'd have them beat the shit out of her every time she turned around. To avoid this fate, she was to never offend him like this again, and he made her give him 70 of her CDs (music disks) and a bunch of her other belongings.

When he told me this, it ripped my heart out. This poor girl. She has been mistreated by so many people for so long, and she had next to nothing. It kills me thinking about it now. Those CDs were probably 80% of everything this poor girl had accumulated in her entire life, at that point.

When he was about 25, he arranged a party at his parent's house. They were gone on vacation. All kinds of people were invited to this party. His whole purpose for this was to get a specific man to come to this party, so that another specific man that he had prearranged could beat him up. This second guy had some kind of grievance with the first guy, and he was apparently a tough guy of some kind. So they had the party and the first guy got beaten. I can't remember the details. I didn't attend this party. I just heard about it.

When he was 30, he had a girlfriend who was just barely 16. He quickly escalated this relationship, including filming them being intimate. Many years later, he contacted this girl's at that time husband and was taunting him about how he had tapes of her without her clothes on and doing all this with him. She retaliated and told him about how she was only 16 in those videos. He quickly destroyed them. Following this, he told me about it and how she "lied" and said she was only 16, when she was 18. At the time he told me this, I didn't think about it too much, but later on I thought about this critically, and he was consciously lying to me. This was 10 years or more down the road from the time he made it, and it was the very first time he had told me about this video. He had a reason for keeping this a secret from everyone, even his closest friends, for so long.

I mean this guy has been terrible, to one degree or another, to so many people. But what strikes him is how cruel the world is to him, which he doesn't understand.

That's a long-winded explanation of what I mean when I see his humanity. In his own mind, he feels every bit as innocent as he was on the day that he was born. He feels his own suffering and even when he means people harm, he means no harm. That's a strange thing to say, but that's how it is.

To explain what I mean, if, for example, this woman's husband got mad and pursued him legally for these taunts, and it blew up into something big, where he's going to go to prison over this tape with this girl, what would he think?

I'll tell you what he would think. He would complain and not understand why they are doing this to him, where they act like he is some sort of bad guy. He would say that he never wanted to hurt anyone. He wouldn't understand why they have to be so aggressive and cause all this trouble. It would feel like such a brutal circumstance for him, for him to lose so much. He'd be taken aback by how cruel the world continues to be to him, when he's such a nice guy.

But when this poor girl, who has nothing, who is so humble, and who has been treated so terribly by everyone, when she offends him, she has to sacrifice to him like the deity that he is, or he's going to make her pay.

In re "all that many", the last time he gave me his Facebook password, he had something like 50 to 110 women that he was talking to. I can't remember which it was. I told Candi and sent her screenshots. She was amused. For many years she was not amused by what he repeatedly did to her.

Candi and Susan, not knowing about one another, both thought they were working on a potential marriage. He talked to both of them in these terms. In my conversations with others, I referred to them as soul mate #1 and soul mate #2. Tonya was soul mate #3, and he instantly cut his first 2 soul mates out of his life. Or at least he blocked them on Facebook, so that they couldn't comment on his whirlwind romance with Tonya or on anything else he puts up.

His last long term girlfriend named Rhonda had made a public Facebook post where she says things like "I didn't know that I was dealing with a freaking psychopath", "he just has to find something to kill..", I can't remember the rest of it. His family threatened to hire a lawyer if she didn't take it down. She also remarked on how he made one of his girlfriends torture some girl with a stun gun.

This "he just has to find something to kill" - what she's referring to here is the psychological rush he gets from torturing and killing animals and presumably people. I do not think he has ever killed any person. I've seen him be cruel to people in ways that might be fairly described as torture, and he is for sure sadistic.

When I was his friend in my teens, it always bothered me very badly the way that he would swerve to hit animals when he was driving. He wouldn't miss a single one. Was usually possums. I'd see the fear in their eyes and it was so horrible. One time he came across some animal, I think it was a possum, that was injured, and he had his little dog named Festus in the bed of his truck. He put the injured animal in the bed, so that festus could terrorize it while he drove the rest of the way home.

I witnessed him torture a cat in a way that is absolutely horrific. I mean god how terrible it was. Me and my friend sat in his living room and we just kept cringing in horror over the sounds this cat was making, talking about how he is going to go to hell for what he does. The cat was on the porch in a cage. He shot it with blowgun darts repeatedly, and then tortured it with the end of the blowgun. I can't remember the next horror following that, but he and my other friend that we called Bo affixed the cat to a tree with duct tape and shot it, after they were through with it.

He was famous, if that's the right word, among those who knew him for his torturing of animals. That was when I was a teenager. He was known for that and for sexually pursuing underaged girls. As he got older, I assumed that he had ceased this behavior of torturing animals, but he had not, at least not completely. A friend told me that he went hunting on one occasion, and had shot a deer. The deer didn't die, and my ex friend buried a hatchet in its head and dragged it up a hill, with the animal still alive as this is occurring.

There was a time after he had his first or second brain surgery when he was thought to have a potentially fatal complication. This would require more surgery. I was on the phone with him while he was on the hospital bed, and he was satisfied, as he contemplated the possible end of his life. What had him satisfied with his short life and what he'd done in it? I can't remember everything, but it was a short list and I can remember the first item- "I've killed about everything that you can kill."

And that's another notch on his belt. He has done all kinds of illegal hunting. I know nothing about it, but, for instance, he had a video of him catching and killing alligators, and a friend of mine told me that this video could get him 7 years in prison. But it still strikes me, the way he gets this much satisfaction out of killing animals, such that it's like the main entree of life.

Wells Fargo wants to claim that they wanted to find out if I'm "dangerous." On top of being ridiculous and a made up, reverse engineered, lie, it adds to the irony that this is the ultimate source of information they consult. You've never met a more dangerous man in your life. The only thing that has held him back all these years is that he is scared of prison and he is scared of an eternity of hellfire. And he's not exactly scared enough of either, based on his unending crimes and things like how he wanted to make a "snuff video" and sell it in Mexico. That was near the time that I first met him as a teenager. He was dead serious. Not joking at all. Near the end of our second round of being friends, he told me that there was only one thing that stopped him from being a serial killer when he was young. I can't remember what that one thing was, but I've never met anyone else, in my entire life, who has said anything of the sort or who can remotely relate to this.

This situation is the most ridiculous and the most inconvenient and the most terrible situation conceivable. There is nothing that will be good enough for me. The best thing is for me to die. I would be happy if I could die and leave my new friend some money. It would be a joy to think of, as I take my last breath. I mean I am destroyed. I suffer so much and my suffering will never go away.

I've been researching this handicap that I have. It is a little not typical and I thus far haven't found a neurological disorder or any other type of disorder that has my specific symptoms, but I'm getting a better idea of how my brain is damaged. My handicap, to be specific, is that I cannot process a given cognitive load without great strain and hardship. My brain has been weakened and simple tasks, or even thinking of simple tasks, amount to an enormous or impossible to take on cognitive load. There are dozens of cognitive processing resources that you use in a given day. Some individual tasks may involve 20 or more, just in one task. My attention is profoundly impaired, also my executive function, and as far as I can tell, I think that nearly every cognitive processing resource that I have is severely impaired. I'm going to talk to a neurologist. I need to document this for social security. I've got to make sure that they don't try to send me back to work, which is a good way to get someone killed. I am so extremely grateful for the social security administration and DDS. I won my second appeal. Only 13% of applicants who are denied on their initial app win their appeal. The rest have to wait 1 to 2 years to see an administrative judge. I got my file from the local office in hickory. I saw their documentation for how they made their decision. It is a very tough process and they did right by me.

This neurological damage that I have is a very severe handicap. Social security likes objective documentation, and I need to get either a brain scan or a set of neurological tests. You can forget me ever being able to make a living again, although I would do a lot better on an increased dosage of adderall. I'm going to try for that. In my research, I found out some stuff about how it makes sense that this would help my handicap. This is not a surprise, because it has been the one thing that helps me the entire time, since may 2019. People say this ridiculous crap that I'm "addicted." That's a strange word to use, but sure.

I'm addicted to not letting my whole life collapse and get worse and worse, right in front of me, as I am helpless to do anything about it. I'm addicted to not losing everything that I own to a credit card company. They would have taken it all, and I need my money. I need my cell phone. I need all of what I worked so hard for, and most of all, I need my bed. I need my bed because I need a place to die. I'm addicted to not suffering like a terminally ill person all day everyday, for 273 days straight, like I did when the cruel murderers at the justice department had their shameless and indecent underlings take away my medication, the only thing that helps me, for daring to challenge Wells Fargo's impunity, for daring to make such a challenge to an agency that advertises its mission as being about the rule of law.

You are addicted to all of these same things that I am addicted to, you just don't know it yet because no one has did this to you. If you became handicapped from a brain injury and your whole life was collapsing right in front of you, day after day, minute by minute, as you are helpless to do anything about

it, you would do whatever you could that would help you fight back so that you could save everything that you ever cared about and that you worked your whole life for. If you were suffering like a terminally ill person, so much that being under the tire of a moving semi truck sounded better and better all of the time, and you suffer like this every day, you would do whatever you could to get your medication back so that you don't suffer like that. The upside to being terminally ill is that you die. Your pain is over one day. Not so for me, after my medication is taken away. I just suffer day after day after day after day, on and on, it is endless.

I am getting agitated and will have to cut this off for now.

I'm feeling bad about my worker in Pakistan. He's always sending me sales pitches and telling me how bad he needs money. He lowers the price quite often. On the round of work before this last one, he told me to just name my own price and send him the work. He said he'd work for anything and came from a poor family. I couldn't do it. I took his last quote that he gave me before the one where he said he'll work for anything. Told him that I would pay him that, gave him half the work, and told him that I'd be back when I put together the other half. By the time that I had the other half ready, I decided that I would take the very first quote he gave me, before he started lowering the price. That quote, I assumed, was a little ambitious for him.

And I told you wrong. I remember now. I couldn't put the work together and he kept telling me how bad he needed work. So I paid him for the work upfront and told him that he could do it when I was able to put it together. The total he quoted me was \$24. I paid him \$10 one week and then \$10 more the next week. Then when I had the work ready for him, he owed me the work and I owed him \$4. I told him that after he was done I would pay him the \$40 he originally asked for. So he owed me the work and I owed him \$20.

He's been desperate again, and I'm running out of money fast. I need a lot of very expensive medical tests and treatment. It's going to put a massive dent in me very fast, in the near term future. I sent him a lowball offer and he was more than happy to take it. I decided that I would up what I paid him by 20%. So I told him that. That's been about 3 days ago. He was extremely happy, but I've been thinking about this, and he is getting paid next to nothing. I had to think of how much time that it would take me to do this, and I mean this poor young man is working himself to death. So when he gets back to me with the work, I'm going to bump him up again.

It's an odd thing, but this is how I am. He was happy, very happy, to take my lowball. Then I upped his pay and sent him the work and he thanked me profusely. It seems like a win/win from every direction, and I think a lot of people would just go with it. For that matter, I'd say half or more of people wouldn't have upped his pay 20% like I did. But I want him to get something for his work.

He will be overjoyed to get more money, when he gets back with the work.

My little woman is starting a small business with the money I am sending her on the 12th. I care so much for her and I hope that I don't end up ripping her heart out. I'm such a difficult person. I ask for so much out of life and it is terrible what this can do to people.

The story with my ex friend keeps going and going and going. I sent you an audio where I seem to be boasting about "the world" being "0 and 300,000" at getting stuff by me. When I said that, I was making a point about this ridiculous notion that a 20 year old woman is conning me or that a 20 year old woman could con me. I didn't mean to brag like that and bragging wasn't the point.

I have now deleted twice, overly long explanations of what I'm getting at. The world isn't 0 and 300,000. The world has scored some points, but I figure them out in the end. The other point, my overly long descriptions detailed how I figure people out, up to and including stalkers and pathological killers, and how I, in general figure out people, and how the idea that a 20 year old woman is going to con me is just foolish.

For now, I feel like saying that I'm sorry for this situation. It's like the perpetual end of the world hanging over people's heads and I can imagine this getting just exhausting. It's a terrible, terrible situation. The fact that I am a human being is a real problem for us. I'm full of suffering and anger and all sorts of other things that provoke me to fight with this situation. If I were some kind of AI machine, things could proceed more logically and rationally. I can't stand this. Things were so good in November 2017, before this happened. Now things can't get good again, ever.

-for one example, I have done this with you. I send you audios where I am begging for help and where I also give you information about what I'm doing. I do this as you are engaging in ongoing crime against me. The information I give is useful for anyone who seeks to criminally victimize me, and I give it to you anyways. I trust you for no reason. I believe in your humanity and that you care about me, also for no reason.

What I mean when I say that I don't see the viciousness in others, I'm speaking of the more benign kind of viciousness that almost everyone has. Viciousness is never really benign, but you have to distinguish this from the viciousness of different types of violent people, like murderers and power hungry men.

What I am speaking of is a slight viciousness, that is nowhere as pronounced as that of those types of people. It is the nature of people to do things like to be dishonest, or to put up a facade, or to deliberately screw over other people, or to stab people in the back, to be pushy and aggressive with their goals, and to in general be out for their own interests in life and to play dirty when they have to or when they can get away with it. I do not have this variety of viciousness, and this can make me blind to its existence in others.

What's funny is that sometimes this naive attitude will bring out the best in people. They can tell that I don't sense their viciousness and the viciousness of others, and they will be somewhat amused by this. At the same time, it's like my desire to be fair with them and to see the best in them inspires them to be a better version of themselves. They will be fair with me and keep screwing over everyone else. It's like they only play dirty in life because they feel like they have to because of everyone else. I can't think of a specific example at the moment, at least not one that I can narrate and explain, and this is just because I'm feeling lazy. It is a very familiar experience. It's etched in my mind, independent of any one specific instance.

The not trusting people component comes out in my interactions with others, at least that's one place. I am wary of giving people information that can be used against me. There are a few other elements of this lack of trust. This thing about giving people information can be a symptom of paranoid personality disorder, but I don't think that's the case with me. It is me, again, being rational. I'm wary about giving such info, that can be used against me, because people will reliably use it against me. I am someone who has been opposed by something not far from everyone that I have encountered in life. If they haven't opposed me yet, that don't mean that they won't ever. I pretty well understand why I am opposed so consistently and with such a lack of inhibition. It's not a mystery at all. It is a difficult circumstance to have in life, however.

Then there is the fact that, when I meet someone, if the first thing that I do is to tell myself "one day, not too far from today, I will be a massive liability for this person", I'm going to be right not all that much less than 100% of the time. Why do I want to give information that can be used against me to someone who is going to be facing prison time because of me? What are the chances that they capitalize on this information?

-this may not make sense, given what I have told you. I have told you things like torturing animals, horrifically, torturing people, wanting to make a "snuff" video, making an illegal movie featuring his 16 year old girlfriend, crimes against children, and the list goes on.

The bit of text that I quoted at the top, this is in reference to our second round of being friends. I believed that he had changed. Especially in those first few years, he was acting like a totally different person, and it was convincing, because it was genuine. It wasn't who he was as a condition of being, but it was who he was, as a result of trying very hard to be a good person. I didn't fully get the difference between these two for a long time. I had an attitude of hey, we were all straight outta hell in one way or another, back then, and I've sure changed and I'm glad he's changed too.

He thought the world of me. He could tell that I cared about him, and I was loyal and would go out of my way to help him. He thought that I knew everything. He told others that I was his "spirit guide." He would go out of his way to help me too, out of this high opinion he had of me and how much I would do to help him. I may be the first person that he spoken of in the most positive terms when speaking behind their back. He is very, extremely two faced. Has been his whole life. Talks about people like they're pieces of shit, after he is overly nice to them to their face. But he would defend me, when others would run their mouths behind my back. That's an odd thing to do, for him.

The first problems started to happen when he took on his "new personality." And this is very painful to think about. He had such potential and it was such an effort that he made. What has now become of him is terrible and also heartbreaking. But I will continue. His new personality was obnoxious and it started to be hard to be around him in public. Me and our mutual friend, a girl named Kelly, would plan how we could dodge him and not let him know that we were out. This was as individuals and also as a group. There is no containing him, once he gets around. Your only option is basically to put up with him. I had hoped that I could steer him into a better direction.

My hopes were for nothing, because these brain surgeries ruined him. He had one after another after another, and these surgeons would always tell him stuff like "I'm looking at these last readings, and I'm very confident that I've found where the issue originates." He was trying to get rid of his seizures. In about 2005, he had started having seizures all of the sudden, and he hated them. Had to have his drivers license taken away. He had his first surgery, and then had a seizure within no time of getting home. He'd immediately start looking into getting another one, after each one failed. Some doctor would say some bullshit like what I told you, he'd get the surgery, and then before he even got on the plane to go home, he'd have a seizure.

These surgeries ruined him. The first effect, that started to set in after the very first one, was to turn him into what I call the "uncensored old him." His racism returned and it would get worse as time progressed. His new personality took on a whole new level, and it was really a pain in the ass, the way he would act in public. I

wanted version 2 to come back again, and I thought that I could somehow help him. I was also very worried about the consequences of pissing him off, as time went on. Another factor is that I felt bad for him. Those 3 things are why I continued to be his friend.

The subsequent brain surgeries made the old him more and more uncensored, and they also handicapped his mind. He's nowhere near as handicapped as I am, and he's not handicapped in the same way as me, but these surgeries damaged him. He is extremely forgetful, and he has a very hard time controlling himself. He will sometimes speak to you, and what he says is literally him directly spilling his uncensored private thoughts. These are things that he normally would have wanted to hide and things he would have never said to anyone. When he does this, I can see exactly what is happening. It is one sign, among many, that his brain doesn't work anymore.

- this is also related to the story about my ex friend. He got a lot by me, in my second round of being his friend. He was being a genuinely better person, for sure, and this was particularly true in the beginning. As time went on, he was also pretending with a lot of it. I didn't realize just what I was dealing with, for so long, because of this.

This woman Susan, for instance. This is an extremely pitiful woman, who has a history of repeated, severe domestic violence victimizations. She is also a multiple times rape victim. She comes across as so sweet and so humble. She had some man she was afraid of, and my ex friend would tell me about how he was going to protect her from him. He'd use the typical man's "throw him to the alligators" type of language. He would tell me how disgusted he was with this guy and his violent behavior and abusive attitude and how despicable it was for him to make this poor woman feel afraid.

A year or two down the road, when he throws me under the bus, and I end up talking to Candi, I saw how much compassion he really had for this poor woman. Candi eventually got in touch with her. I told Candi about her and how my ex friend was stringing both of them along in parallel. This was a shattering of Candi's illusions and she seemed to have trouble accepting it. She didn't think that I was lying, but she wanted to hear it from Susan. So she contacts Susan, who tells her the exact same thing that I told her as well as some more details that I didn't give. Candi contacts my ex friend to confront him.

Among the things he had to answer for was how he had engaged in a sex act with Susan, during the same time that he was wooing Candi. From what I heard of Susan's account, she described it as something that she gave into, out of shock and disbelief. She had told herself that "his brain surgery had done something to him, and brought out something predatory." She basically tried to tell herself that there is an explanation for this, that this isn't the person she has known and who has been so kind to her. As she went into denial, she reluctantly gave in.

My ex friend responds to Candi by making the most awful accusations against Susan. He spoke in terms of her being a sex maniac, with no virtue. Said that she begged him for a sexual experience and that he finally gave in. He gave, as evidence of his fidelity towards Candi, the fact that he never had sex with Susan, when he could have at any point that he wanted to, because Susan is of such pathetically easy virtue and is such a fiend that all he had to do was ask.

This was one among many examples I would see, as I talked to Candi and she relayed what he said back to her, of the most ruthless and heartless manipulation you can imagine. I never fully realized just how completely without concern for these women that he was. Someone with either a heart, a soul, or a conscience, could not be this way to anyone. I thought back to how he had spoken to me about how he felt about Susan, and what instantly stuck out was how he was speaking in exactly the same terms that I would have. He was mirroring my own attitude and my own values. He got this by me, how the whole time he was being an actor.

He didn't completely hide his dark side, but he hid enough of it to fool me. And "his dark side" is not the most accurate way to describe it. It is more accurate to say his true self. This darker version of him was who he was around the clock. Even after everything he had said and done in my presence, I never perceived him to be someone who could be as heartless and as cruel as he was to these poor women.

I am a self-centered person in a lot of ways. I am self-centered to an extreme, in a lot of ways. What sticks out about him, though, is how the other person doesn't matter at all. He is totally unconcerned about them and their needs and the damage that he is going to cause them. I'd say that most likely, he is conscious of this. He knows that he doesn't care about the other person, and that he's just using them for his own ends.

He got this by me because I am naïve and because I trusted him. I have a quality of naïveté, where I do not see the viciousness in people. I overestimate their desire to do right and their concern about their conduct, and the underestimate their tendency to be unfair to others. I have had trouble trusting people a lot in my life, and on the flip side, I have trusted people that I shouldn't.

Jenny got one by me, in conning me out of a link to my Facebook profile. Here it was me trusting Jenny, which is among the worst mistakes I have made and ever will make. And this is what I find about not trusting people. Others have noticed this about me for a long time. It has stuck out to more than one person, how I didn't seem to trust other people. They seem to see it as some kind of unnecessary personality quirk. It doesn't seem that way to me, as I approach 43 completed years of living on planet earth. It seems to me that not trusting people is extremely rational and is the appropriate thing to do. The biggest hardships of my life have come as a result of trusting people.

I talked to my provider yesterday. He says that if my physician isn't concerned with my blood pressure, he is not either. I have done the right thing. I had felt bad about not saying more about going to this cardiologist, but I would have only been wrong if my cardiologist told me that I needed to do something about my adderall. My cardiologist wasn't the least bit concerned. I directly and explicitly brought the issue up with him, and he didn't recommend any changes or think that there was any concern.

You may wonder why I'm telling you this. At the rate I'm going, you're going to get found out in not much more time. One of your tactics, I am sure, is to issue a propaganda campaign. I would hope that by now, you have seen the error of your ways and will try to be honest and contrite.

On the other hand, your propaganda campaign will necessarily involve taking things that I have said out of context, and using this as a means to deliberately mislead others.

You have plenty to go on, with this. I have sent you 100s of hours of audios and I have sent you emails that probably total in the thousands.

Among the claims you can make is that I have been dishonest with my provider, based on what I have shared about that. I am giving you the full information, so as to have my record with you complete.

Any propaganda campaign against me can and will be dissected and proven wrong. It will be a mountain of work for me, but will show you as being blatantly dishonest in the end. This assumes that you do not murder me or use your power advantage against me in any other way that would cripple me.

This explains a lot. I've got a lot of people in foreign nations living lavishly off of the money that I pay them. That's at least according to their standards. My worker can't get enough work, and there is something strange going on.

On the second to last job I sent him, not counting the one that I sent yesterday, I had between 50 and 70 people download the work. I asked him why I had so many downloads, and he said he had no idea. It was legit downloads from Pakistan. Might have had 2 bots or maybe 3, but that's the extent of it.

So on the next job, I told him to download the file so that I could delete it. I often send an instructions video and a file, but on this one, I just sent a file. He downloaded it and I deleted it, and there were no more downloads or attempted downloads.

I sent more work yesterday, and I've got 25 people downloading the instructions/how to video. If I ask him why, he's going to tell me that he doesn't know again, and maybe he's right, but I do suspect that I might be feeding a small village with this work. I am paying him more for the one I sent yesterday, because I'm still feeling bad about how hard he worked on the job before that vs how much he got paid.

He made way more than what he is used to, if the above figure is indicative of his situation. He's got a computer with windows 11, so he's more blessed than a lot of those people. The lady that had the children's ministry that I was supporting told me that the parents of those children provide them with food "with great difficulty", and that the children frequently had to go without food for multiple days at a time.

I told my worker that I'm a liability for the economy of the entire earth, and that if I get a lot of money out of my fight, things will get better for him. He replied "May God give you success in your case." He's a very nice and kind young man. I am really impressed with him and it will rip your heart out to think of how hard his life is and how hard he tries. He is very religious too, I can tell. He's recently replaced "Allah" with "God", when he wishes for blessings to come my way. He's figured out that I'm not a Muslim, I think, is what prompted that change. He's asked Allah to give me back my health on more than one occasion.

If you don't want NYT tracking where you got this link from, delete the question mark and everything after it, then copy it and paste it in a browser. That's a general rule when you get links. That question mark and everything after it is called a query string. Everything on that string is a candidate for getting saved in a database. You can assume that everything on that string is either used in a database query or saved in a database. You won't be wrong that much. Sometimes the query string, or parts of it, is necessary to get to the right webpage. It might have a parameter for the product id for a product or a category id for a page that displays all products under a certain category. Other parameters are just used to track you, and they will often be named in ways that give it away that this is what they are used for. You can delete individual parameters and leave the essential ones in there.

When you copy a link from another website and paste it into your browser, the website has no way of knowing where you got the link from. For example, if you click the hyperlink on this email, a header will be passed to NYT's web server that says you were "referred" by gmail. The web server can be programmed to capture that information and store it in a database.

This situation sucks, not mine but the situation in this article and the broader situation that it is a part of. When I was a child, up until about age 16, I attended church services pretty frequently. This was in the 1980s and the 1990s. Especially in the 80s, there were a lot of businesses that refused to be open on Sundays. A lot of people also refused to work on Sundays. The people in the churches would debate this. The big point on the side of the businesses that were open Sundays, and the individuals who worked on Sundays, was the Bible verse that says "the sabbath was made for man, not man for the sabbath."

I have had an attitude for a long time that laws are made for man, not man for laws. In other words, laws have utility for our lives, and that is the only source of their value. If following some law is going to crash the whole world, it is an extreme form of insanity to follow that law, particularly when no one suffers when you don't follow that law. What you don't do is crash the whole world. Who on earth can defend crashing the whole world over anything, when you have the power to stop it.

The answer to that last question is some substantial portion of every lawmaker in America, quite possibly a majority. The qualification is that they don't see the world crashing ahead of time. They don't understand this machine called the economy. To be fair, no one understands it all that well. It is far too complex. I don't think that there is anyone who has called what will happen in the future with a great deal of accuracy, not on a consistent basis. The possible exceptions are these people who pride themselves on making predictions, except they aren't exceptions. Their strategy is to make as many predictions as possible and to then overhype the ones that come out right.

The thing with first republic seems to be not too big a deal. There were some panic peddlers online saying that it could set off a wave of bank failures. This situation that we're in is absolutely terrible. I can't tell you how much that I hate it.

I want to go back in time, to before I met Jenny or maybe before she conned me out of a link to my Facebook profile. I was treated as a person who matters and I didn't have a brain that is so terribly damaged. Among the outcomes I am contemplating as possible are some that are a complete nightmare on steroids for the other side. However I handle this, my intention is for outcomes of that nature to not occur and more generally to have this work out in some way that everything works out. In particular, I want to avoid any shit storm banking failure panic, end of the world, etc. outcomes. I don't want any such thing to ever cross anyone's mind. We need something that's fair to me but also is a positive step for the bank. And that's one problem we have, I have ideas of what is fair to me, but at the end of the day, there is a limit on how much better my life can get and there is ultimately nothing that can be done for me. It makes the whole thing seem purposeless. It seems like a terrible thing for people to have to go through, with the media, congress, etc. etc. etc. for the sake of me just continuing to suffer. My life would be a lot better if I had a lot of money though. I might be surprised as to how good it can get. I for sure need a very large amount of money, due to how handicapped that I am. I can't do anything. Adderall helps me. If I get my dose upped I can do more, but the problem is that I have not retained all of my abilities. I can work on my computer, type word documents, surf the internet, and things like this. More adderall increases those abilities, but I still have enormous trouble cleaning. Things like cleaning, making a can of soup, or cooking chef boyardee, more adderall just barely moves the needle. The needle moves so slightly that, in most cases, I still can't do them, pretty much not at all. I will never be able to live independently. I will have to pay people to clean my house, do my laundry, drive me to the drugstore, shave my face, all sorts of things like this, I will be paying people to do for the rest of my life.

I also need a house that is very large. Not a Mansion, not necessarily, but very large. The purpose of this is so that my furniture can be spread out, with big gaps. My bedroom can be large, with a lot of space in it and on both sides of my bed. When things are spread out and wide open, it lessens my mental paralysis.

I have found that clutter and constricted spaces have a profound paralyzing effect on my mind. It seems like constricted spaces are the worse of the two. This tiny bedroom that I'm staying in is paralyzing me very badly. I could also shave more often in my apartment in Charlotte. I moved to this apartment on November 29th, 2021. Since that time, I have shaved my face twice or at the most, 3 times. I think it is twice. Every other time I have paid a barber to shave my face. I have extreme difficulty forcing myself to shave. Most of the time I can't do it. It partly has to do with it being more complicated in the bathroom of this place.

I've had over 13,000 profile visits on twitter in the past 3 months not counting may. My complaint gets clicked quite a bit, but I have no way of knowing who saves it. I think the safe assumption is that 97%+ open it in a browser and then close it within 3 to 5 seconds. I get about 20 to 30 clicks per thousand visits, with a small portion being bots. The majority of my clicks come from a mystery source with an empty user agent string in the headers. The clicks from the mystery source are correlated with how many views my tweets get. More tweet views = more clicks, and it's like a perfect correlation. The mystery source comes from t.co, and I can't tell if it's some kind of crawler or actual people using a VPN or what.

"Almost half in new poll concerned about their money's safety in banks"

This is The Hill. I have been watching some of this news outlets videos on YouTube. They are pretty impressive. They seem to have a high degree of objectivity.

What I wish that they and other news outlets wouldn't do is post stuff like this. This gives me a very uneasy feeling. It's not the poll that makes me the most uneasy, it's the fact that this headline is being posted.

People do what other people do. That's how people work. That 50% that isn't worried about their money- guess what, a large part of them will be now. People use this faulty logic that "if people are worried about the safety of their money, they must have a good reason to be worried about the safety of their money." That's how their minds work.

I say that this is faulty logic, because it doesn't take into account that the largest part of that 50% never went to school for finance, never went to school for economics, and don't know much at all about how banks work (like the occupy Wall Street kid who went viral over his brilliant assessment that included "when you give banks your money, they make 9X the initial investment").

What happens now is there is a substantial fear of banks failing that is manufactured out of thin air. There is no underlying reality to base this fear on *until the fear itself exists*. The baseless fear becomes its own justification, because it itself is a credible threat to the system.

This is terrible. I do not like seeing this at all. It appears to me that people are numb to the idea that the world as they know it could cease to exist at any moment. We are fooled by good times, and by an illusory sense of safety, into assuming that prosperity, or at least some level of stability, is a feature of the universe. That this is just how life works. It's as if to suffer an irreversible collapse would be a violation of some law of nature. Such a possibility doesn't feel real to us.

This banking crisis + these politicians about to let us default on our debt while they squabble, this is playing with dynamite. These 2 factors are a major threat independent of one another. Having both of them at play at the same time is a disaster waiting to happen. That these politicians don't have sweat beads bubbling and veins popping out of their foreheads leads me to believe that they don't get the gravity of this situation.

It is also possible that I am overstating the gravity of the situation. There is plenty that I don't understand. I do think that I get the broad strokes though. It's like if I've got a Jenga tower that has been built up really high, and there are corners of blocks poking out at the edges all over the thing, I don't get out a ruler and a scientific calculator and start doing physics calculations, to fine tune my understanding

of every detail of this particular Jenga tower and what might happen to it. I just do everything I can to not rock the table it is sitting on.

This situation with me that we are in is a nightmare. I'm still thinking about how to do this. I have no good answer. To give myself something to do, I continue with my fight like I'm on the aggressive. I may stay on the aggressive, but whatever that I do, my plan is to do everything that I can to avoid third parties being harmed and I am not sure that I will do anything if I see a possibility that my actions will cause panic peddling headlines.

I have been damaged very very badly. I deserve Justice of some sort and I will never make it if I don't get it. The other problem is that it will take a whole lot of money to make my life worth living, after what I've been dealt and what I've suffered and how I continue to suffer and be impaired. That creates a problem because if I were in a position to take a lesser sum of money, Wells Fargo could just make a note in their financial statements about "settling a legal matter about xyz for an immaterial amount" and be done with it. This is coincidentally (or maybe not coincidentally) exactly what I have said, over and over, since may of 2019, after my symptoms had their first massive uptick.

It's been a long time since I mentioned this, if I have at all. If I have, it was probably in early to mid 2021.

I have this way of behaving that is extreme and that I'm sure confuses you. It would really help you if this behavior would go away. You most likely think that it has something to do with me.

To be specific, I am referring to things where I'm in almost constant and never relenting distress, where I constantly complain that I want to die or that I'm mad that I can't die or that the best thing for me is to die, or where I speak of nonstop horrific suffering. Then I speak of extreme impairment, where I cannot do simple things like make a can of soup, and where even thinking of making a can of soup is extremely distressing.

I talk about extreme emotional pain and hostility that results from what others would see as trivial provocations, and I tell you how I feel like that I have to massacre the person or persons who cause this feeling of extreme emotional pain. I say that for these and other reasons, I am a ruined human being.

What has happened to me never leaves my mind for any increment of time greater than 90 seconds and 90 seconds is extremely rare. I would seem to have a quality where I am obsessed with this situation and my handicap, and it seems that it is impossible to get me to think about anything else, and I sure as hell can't forget about it.

You are essentially 100% incorrect in thinking that it has something to do with me. What I mean here is that, if you (or me or anyone) got a top notch team of experts on traumatic stress disorders and the neurobiology and neuropsychology of traumatic stress disorders and the brain in general, and this team did a detailed interview of me and also did a protocol of brain scans, like an fMRI, a PET scan, and/or whatever else they find appropriate, they would come back with a conclusion that I am very severely injured.

My behavior (like the behavior that I have described to you and that you have witnessed for years) would not be a surprise to them. It would make sense to them and they would tell you something to the effect of "this type of injury is something that will cause nonstop, very severe pain." They would most likely have some oversimplified explanation of the mechanics of the brain and what happens when things go wrong like they did with me, just like when you go to any doctor and they try to put it in words that you can understand, without you having to go to school for 10 or 20 years.

Counter to what you would expect, if there was anything exceptional to note, it would be how well I have kept it together and how incredibly hard I have fought to stay above ground, even while dealing with the ungodly injury that I have incurred. They might wonder how the hell that I have done it.

This is based on my understanding of what has happened to me, my symptoms, all of my knowledge of psychology and my other research, and my experiences in life. There are certain things that have

consistently stuck out about me. One of them is how hard I am on myself and what a perfectionist that I am. Another is that I seem to be an unusually and quite extremely strong and resilient person.

What I said here is completely accurate. If there is ever an opportunity to put it to the test, things will go essentially exactly as I have said that they will. There is something about my intuition that causes my perceptions to be extremely and even sometimes uncannily accurate.

My blood pressure is going down. I've been exercising every day. All I do is take a walk 2 or 3x a day. The road leading up to this apt is very steep. It will have me out of breath just walking up it one time. After I walk up it, I walk on the level ground that is up at the building or I come inside for a few minute, then I walk back down the road and up again. It is intense exercise, at least for me. I've got to get my diastolic blood pressure down, and I'm doing it. I have been taking propranolol for EPS, but for the longest time I didn't take my second dose in the evening. It is one of many things that I have trouble doing because of my impairment. My provider says that he can increase my Adderall if I get my blood pressure down. My Diastolic was at 89 last I got it checked in his facility. That number was artificially high, because I damn near had a heart attack 50x on the drive there. It is my startle response and my hypervigilence. It had me amped up. I just measured it and my diastolic is down in the low 70s. I think it is possible that I had an error with the arm band position, but if I didn't, this is a very good thing.--

Among the things that I've yet to tell you is that whoever it is who has told you that I have borderline personality disorder is dead wrong. Most likely this is a PhD with experience and competence, but they're wrong. I have just a tinge or maybe a tinge and a half or two tinges of cluster b traits, without considering the things I inherited from my father, but they're almost all under narcissism, and I don't remotely come close to meeting the bar for BPD. I can follow the thought process this person is using, but they're still off by a million miles. I have less traits of narcissism than what these online results give me too.

When I take these tests, I answer the literal question, without adjusting for what is normal or what is normal for someone with my particular circumstances. There are some questions too that, on reflection, I'm answering completely wrong. You have to remember that narcissism is a universal quality that exists on a spectrum, and that until you get to the extreme end of that spectrum, it is a neutral quality. There is no opportunity to break your neck to make me out to be some bad person there.

It's the same with this Robert Hare checklist. I have trouble scoring myself accurately because I don't have the manual. I also don't make adjustments for what is normal. For instance, the checklist has a trait called shallow emotional responses. I have had this, to some degree, for my whole life, but this changed when I developed ptsd and my emotions became more labile and less regulated.

So what do you do here? 0 is nothing, 1 is sort of, 2 is I have this trait. As of the past 4 years, I am a 0. Before that I'm a 1 or quite possibly a 2, except you have to adjust for some things. The child abuse that I suffered from a young age and for years has the effect of deadening your emotions. This is visible on certain brain scans, and as I understand it, for abuse as severe as what I experienced, this deadening of your emotions is a universal effect. So here, what would seem to be appropriate would be to measure my shallow emotional responses relative to the emotional responses of people who have also experienced severe child abuse. Among those people, I would stick out as having somewhat more pronounced emotional responses. I think that is most likely the case, before my ptsd and obviously after. So it seems that I would be a hard and unquestionable 0 on this one.

Other items have to be taken in context and amount to nothing. For example, juvenile delinquency and early behavior problems. For one, there is some connection to behavior problems and child abuse. I never have fully understood this and I don't have a whole lot of insight into how this happened with me, but I've had many, many psychologists tell me this. Even still, for these items, it is probably not appropriate to adjust for any adverse home environment, unless someone didn't have food to eat as a child and shoplifted grocery stores or something like this. So here I would seem to get a 2 and a 2. This is for bringing Tylenol to school and telling other kids it was a drug, and for being a generally mean and unruly kid for several years in middle and high school. I didn't tell the kids the Tylenol was a drug out of an attempt to make money, or anything like that. I was just being a little bastard. It's a far far cry from the crime of the century, but still was very wrong.

The reasoning that you have to apply here, in the analysis, is who cares? I've lived as lawful a life as your typical person, quite possibly more so, for now over 22 years. Before that, I was on a steady upward trajectory, and to compensate for the mostly petty wrongs I have done, I have went out of my way to help people on many occasions. I am extremely kindhearted and like to help people.

There isn't a single person that I have known in the past 2 decades who wouldn't feel comfortable leaving me alone with their wallet or their personal belongings. People correctly size me up as an unusually honest and trustworthy person, as it relates to telling the truth and as it relates to never, ever, ever even thinking about stealing from someone. I have stuck out as the hardest worker who works the longest hours and (most often) does the best job to every employer I've had since I was 15. I have done so most consistently and most dramatically since age 23.

In light of all of this, who cares? Why should anyone give a shit that I committed a felony involving Tylenol at age 13, for no personal gain whatsoever. Why should it matter to anyone, in year 2003, or in year 2011, or in year 2017, that I did things like throw paper wads on the school bus when I was 11 years old. Doing an analysis like this is pointless. It's going back to stuff that happened in grade school and middle school for no reason whatsoever and with no possible benefit. It's a waste of time.







I don't want to be in the public eye, but I am so incredibly damaged that it is going to cost a fortune for me to just be able to live. I will need people to help me with everything. I can't do anything for myself and never will be able to, except work on my computer and type on my iPhone and tablet and surf the internet on both of those. I can't clean to save my life and I will need to pay people to drive for me. All of this will be for the rest of my life.

On top of that, I suffer so extremely that it will take a fortune to make it worth it for me to live. If I am to live, I need to be able to offset this suffering and have something.

The best thing is for me to go overseas and die. That won't cost nearly as much.

Every offer I've given is Pennies on the dollar but I don't want to set the bank back with a massive amount of money. I would feel bad about that, probably. I'm speaking here of my figure of \$10 billion that I threw out. That would put them way behind.

I don't know what to do. If my behavior is a mystery, pay for me a team of experts and pay for me all the brain scans that this team needs to evaluate me. There is something extraordinarily bad wrong with me. I am extremely ill and I don't think it's anything that could be considered normal. I may be a one of a kind example of the type of damage that I have suffered. Whatever it is, it is extreme. The experts could find the reason for why I suffer so bad and am so out of control. I do believe they would tell you that we are dealing with something extreme.

We live in a place that is so full of opportunity that it's not completely off the table that he has all of that one day. There are not many places like that and there have not been many in the history of the earth either.

Think of the young soldier who promises his young wife and his 2 year old daughter that he will make it back to them, and then isn't able to keep that promise. Multiply that by some figure in the 10s of millions and you will have some sense of the incredible price that has been paid for us to have this opportunity, and this is what people make of it. I don't know how for this situation to be over when I suffer every single day and when I need a very large amount of money just to be able to live.

I will need to pay people to cook and clean for me for the rest of my life. I will also need to pay people to drive me places. I will need to pay people to shave my face and my hair. I will need to buy a very big house to live in. When it deteriorates, I will need to buy another one. I don't need a mansion, not exactly. It depends on your standards for what that word means. I just need a house where every room is very large. This will allow the furniture to be spread out with big distances between everything. Constricted spaces and clutter tax and paralyze my mind and make my impairment worse. Then I will need to buy a car every 3 to 5 years, even though I won't be driving myself places much. If I have a woman, which seems to be something that isn't doable, she will want me to take care of her, so I will have to buy her nice things and make a life for her.

My little woman from the Philippines is going to want a bunch of kids, if we stay together. I already see that coming. I doubt that I will do that. I do not like the idea of having kids because I care about kids more than anything and I cannot bear the thought of letting my children suffer. What this means in practical terms is that if I have children, I will be tethered to living. At all times, I will have no choice but to live, no matter how much I suffer, for the sake of my children. It is a horrifying thing, to think of how life could get and me not have an option out of it. But if any woman does talk me into this, I will have to take care of my children, and I cannot make a can of soup. The bottom line is that pretty much all I will have in life is what is given to me, and it's obvious who ought to do the giving- the people who did this to me.

This is the bare minimum, and doesn't factor in that I need to offset this suffering. My brain has been damaged and it causes terrible suffering. It makes life not worth living. It makes me crave death constantly. Even in the extreme case, where I get the most I have asked for or more, I will find it hard to find the will to live for a good part of the time.

I am in a position now, where I am very worried about our country. At the same time I need justice. I am also concerned for the justice department and how this situation is probably causing you all kinds of stress and frustration. I worry about Wells Fargo too, at least at times. I do want Wells Fargo to fix its business. I would hate to see that not happen and I don't want to cripple them to the point that they can't do that. For my own sake, I am absolutely horrified, at least most of the time, about the prospects of me becoming widely known, which is exactly where this is going on the current route that I'm on. I don't know what else to do but to continue my fight. Im at a loss for other options. What has been done to me is terrible. I'll add that I've got enough to knock the living hell out of this bank, and by the time it is said and done, I just might do it. It will require me to be widely known, which is my worst nightmare and is especially my worst nightmare in the condition that I am in. If I do that, I'll ask the world to have mercy on the bank, after the bank makes it right for me. This assumes that the world cares, which I think a lot of it will. The story I have to tell is the story of a very kindhearted person who worked very hard his whole life and who was then massacred in a very cruel fashion, over absolutely nothing. It's actually even more than that, too. There are profound lessons to be learned from the story that I have to tell, for

individuals and also for societies around the world. You will see what I mean if it comes to that. I will get more than my 15 minutes of fame, and my life will be even more over than it already is. I will have accomplished something, however, and that will be satisfying. I'm going to be thinking about what the hell I'm going to do. This situation is not what I did. It is what they did. Their actions created this.

It will take me at least another month to get everything ready for the media, before I go to whatever reporter I'm going to use. I've got 2 from WSJ, 1 from NYT, 1 from Bloomberg News, 1 from LA Times, and I'd have to think of who else I've talked to. Washington Post had assigned me a reporter at one time, then it fizzled out. These are people who I have their number and/or email, and have talked to, and who recognize me. I've got other TV networks, magazines, and things of this sort where someone has responded to me but I don't know their name. I had CNBC on the line for several days a while back, but then my explanations of how I figure stuff out got too far out there. At least that's what I think happened. for whatever reason, they no longer respond but it appears that my emails to them do get read (I put links that I can track in them, and someone/something clicks them). They stopped responding to my signal chat and then eventually their signal line was terminated or something. NBC news appears to have a bot and/or some people who don't get paid much reading their tips. They read everything that I send them, but I had a friend test them out by sending a "news tip" that was just a single period, and as soon as they came online the next time, they read her message, not long after they read mine (I can get a timestamp on the read receipts).

The month timeline is overly ambitious and extremely not likely to happen. I think it is more likely to be 3 to 4 months. That assumes I don't change course at some point. I'm a wreck and I need something out of this fight and I just keep on the same track that I'm on, in terms of my day to day life. It's a constant battle to escape feelings of torment, and what makes me feel better is to get something done and in particular to do something that advances my fight. But I'll be thinking and hopefully we can find a way out of this that minimizes the hell for all involved.

I try my best but I’m only human and I’m all over the place. They did this. I am very sorry.

What the hell to make of my little woman though? I've never been so genuinely confused by someone's behavior in my life. I am leaning far towards that she is just too busy. - the above is a message I sent a friend in a conversation earlier. Sometimes I can't figure people out. Usually I am being gaslighted. I think that would be the case if I compiled examples and looked into them.

I am very susceptible to being emotionally manipulated. That's what I've found over the years. My dad played mind games with me for over 8 years. He did this over and over, and it never worked. Most often I would know exactly what he was doing, as soon as he does it. I would know his exact thought process, in real time. I'd be thinking what he's up to and what he's thinking, to myself, as he is talking. There were other times that I'd have to guess at his end game, but I still knew roughly what he's up to. In those instances, it's possible that he had no end game for me to sense. He's just moving ahead one step at a time. He can decide his next move when he gets there. When he got sick though and switched to emotional manipulation, he pulled my heart strings with ease.

It was like having a relationship with him was not much else than torture. That's how I started to feel. His manipulation attempts for that first 8 years got him nowhere, but it ripped me to pieces that my own father would do this to me. It hurt worse and worse as time went on. Then all of the sudden, when I've already had more than I can take, he's deathly ill and he turns it up 1,000 notches. God what murder it was.

I got off on a tangent, but I'm sad about my little woman. I'm not cut out for conflicts and misunderstandings like this, not in my condition. People do not understand how severely damaged I am. Every day that I'm alive is another miracle and I suffer more than 99.9% of people can begin to imagine.

The other thing that really helps me is adderall. It medicates this neurological impairment and makes me able to get stuff done. Money + more adderall are probably the 2 things with the greatest capacity to make me feel better.

People try to say this ridiculous garbage that I'm addicted, and that is bullshit. When you suffer like i do and a medication makes you feel better, of course you're going to take it. It's the same thing with my life collapsing. I was in Charlotte and my life there was all that I cared about in the world. It was collapsing right in front of me and I couldn't fight back. The exception is when I take 60 mg of adderall instead of my 40 mg that I was prescribed. My impairment was greatly lessened and I could fight back much harder. When your whole life is collapsing right in front of you, what do you think you're going to do? How do you think it feels to be helpless due to being disabled, and yet have such a strong desire to fight? If a medication gives you the ability to fight back, of course you're going to take it. That's what medication is for. People who are addicted to medication take it to get high. I had no desire to be high and the thought never crossed my mind. I just wanted to save my life in Charlotte.

During my bankruptcy, I wanted to save my life in Charlotte + 100% of everything I had worked so hard to have, meaning everything that I owned. I repeat this part every time that I talk about this, but it's because it is what most vividly conveys the condition that I was in- when they take everything that I own, they're going to take my bed, and I need my bed because I need a place to die. Those were literally my thoughts. I knew that there was a chance that I didn't make it. If not making it became a reality, I wanted to die as peaceful a death as I possibly could. Above all else, I wanted to die on my bed in my apartment in Charlotte. I had these terrifying thoughts of them taking my bed away, almost every single night for months. It felt so ruthless and so cruel just to think of it.

Listening to me is the crucial step that everyone involved has failed to take. When I say that my adderall helps me work, you're supposed to believe me. There is no reason not to. You have all behaved as if you have no humanity and as if you only care about yourselves.

The reason adderall improves my condition so much, or one big reason, is that I can do things like I used to could. I can't do them at the same level, but I get closer. I can write software. I can write books. I can make videos. I can read. I can do all of the above to a limited extent even on 30 mg or 40. But 60 gives me another big improvement. I like to focus my intensity on learning and mastering stuff, and creating things that are masterpieces. For instance, making a perfectly or near perfectly programmed web application.

Maybe 2 or 3 months before April 2019, I had started a project where I wanted to memorize a 1,000 page book I had bought. It is a comprehensive book about CSS. CSS is part of developing websites and web applications. It is the main driver of the visual appearance of a website or web application UI. The CSS is written by the developer and then the web browser compiles the CSS in order to render the visual appearance of the website. If I memorized that book, I would be like a human compiler. I could calculate how a web browser or other client would render the page, exactly to the finest detail, in real time as I am writing my CSS. This is another example of the type of thing that I like to do and that gives me satisfaction in life.

Before all of this, I was for the most part an unusually happy person. I have this thing where I can go off the deep end in an instant, but those times aside, I tend to be happy and excited about life. It is because all of the things that I want to learn about and all of the things that I like to get good at.

I was so happy playing billiards when I was young. I had the job at the gas station starting at around age 22. Not long after that, I got a job at a resort, most often working one 12 hour shift a week. I would work 50 to 70 or 80 hours a week. Then I would play pool all day on my days off, and I would read books in my spare time after work. Then I got my building built and got my own table. I was a rockstar at my job and with my customers. I was a ladies man too. All the women that came in there were very fascinated by me. I'd have married women in their 30s come in and self-consciously tell me about how they can't believe they came in there with no makeup on. I was so happy for so long.

Then at age 26, things started to go downhill when I started going to bars. Not long after that, I went back to school. It was in these years that all hell broke loose, in terms of my suffering. My soul was crushed and I was destroyed, over and over. I was glad to escape it. And now look at what has been done to me. I look forward to the day that I die, more than I look forward to anything else.

I need to get a neurologist to vet my neurological impairment and vet the need to up my adderall to 60 mg. My provider is on board with going to 40, if my blood pressure comes down from 89. I take a medication for EPS that also lowers my blood pressure. It is a PRN, or whatever that is called. I am prescribed 2 a day. I have very often only taken one and probably sometimes not taken even one a day. I've been taking 2 a day for weeks now, and it puts my blood pressure at around 79. It also sedates the hell out of me when I take it twice a day.

That's more evidence of my heart being fried. I had near perfect blood pressure for years and very consistently at atrium when they measured it. Then in February or so of 2021, I started having heart problems. Then my body was fried in July and August of that same year. And we have the evidence of it, that I am bordering on mid level hypertension without the aid of a beta blocker that I wasn't previously prescribed. My numerator is jacked up too. It pushes towards 129 to 133, without my medication.
