I need medical care that is extremely expensive, to document my impairment with the social security administration. If she doesn't pay me back, I won't be able to afford it. DDS is fairly likely to cut my benefits for the future, the next time they review my case. This is because that the documentation of my impairment is kind of weak, according to their rules. I experience impairment and I report it to my different doctors. They record it on the healthcare records that they prepare for my file, which will go to DDS. What DDS will then have is an account of my impairment that is barely better than me just calling them up and telling them about it. I need something objective, namely a brain scan and neuropsychological testing. Brain scan is out of the budget at current, but neuropsychological testing will also document my impairment objectively.

I have reported to my current provider a 700% improvement in my condition, since we started working together. This is accurate but could give the wrong impression. The reason I give a figure of 700%, and I do kind of just wing that figure, is that before he gave me my medication back and did some other things to help me, all I did all day is suffer like a terminally ill person. It was nonstop, horrific suffering that never went away for as much as 1 second. I suffered like this for 273 consecutive days. My suffering would go down at certain times, but never went away and was absolutely horrific at all times.

If you go back in time to when I had my medication, a time at which I was still profoundly disabled, my improvement at the current time is probably more like 10% or 20%. It is a big difference but I'm still not anywhere near capable of going to work.

Now you've taken my little woman and my mother has taken all of my money and my soul is crushed. I am in such despair and am reeling from the effects of this cruelty.

I made some audios earlier that I might not even send to you. If you listened to them, I might sound like I'm doing fine. That's how it sounds to me, when I listen to my voice on these audios. Do not be surprised if I am found dead at any time, in the near or medium term future.

I was using it with my learning courses site, and some of my interface clients have coupling with other components of the learning courses site. I need to make a new set of clients that aren't dependent on or coupled with anything outside of my PayPal components. Then I could plug it in to any application I built. I'd also have a mega client that wraps up my smaller clients and could be used as a single interface to do every type of PayPal API request or response processing.

My soul is crushed that I have to send you this email. This situation is about to get horrible. You don't care because you are murderers. It is getting extremely dangerous.

I'm going to take 1 month off of my fight and relax. While I'm doing this, I will try to think of a way to make this work for us all. Wells Fargo doesn't want to pay \$10 billion for many obvious reasons. Among those is that Wells Fargo needs to pretend like this never happened, and they can't do that and explain a \$7 billion quarterly loss at the same time.

The problem on my end is that it will take an enormous amount of money to make it worthwhile to live for me. If I get some much lesser figure, the chances are pretty high that I move to Switzerland. The chances are quite high that I do that if I get \$10 billion too. Part of it is that I suffer so horribly, and another part of that is that \$10 billion or some similar monster sized figure comes at a cost, that cost being me being widely known by millions of people. \$10 billion would alleviate my pain but it would also come with some horrible pain attached. It is horrifying to think of.

What's likely going to have to happen is I am going to have to get pulled into the scam. I can collude with you to keep quiet about this, and we can work out what ways we might have to make this better for me. I need the most money that we can get away with giving me. I will tell you, however, that under no circumstances will I lie to congress, if this is ever before them. If you want to portray me as crazy, that is fine and would probably work for you. But I'll tell congress about being kidnapped and about Wells Fargo and the justice department taking over 2 hospital corporations and running a healthcare fraud based cover-up. They'll probably go along with you in thinking that I'm crazy and that will suit your purposes. For the media, I don't like lying to anyone, and if they contact me, I will just say that I'm not interested in talking or something like that. I've got it worked out that when I want my story to go to the media, I will be able to do it. I've figured out how to do it. At the current time, however, they're not much an issue.

I need to research how this works with immaterial legal settlements and get an idea of what I can do. I am handicapped and will incur expenses for basic life tasks for the rest of my life. I need a huge house to live in, because of my brain injury. I will probably have to buy several huge houses over my life, because of wear and tear and maybe other reasons that I can't anticipate right now. I tend to not want a mansion. I don't want something that big because it is horrible to upkeep. I can't upkeep a home of any size, but if I had a mansion, I would have to have house cleaning people, plumbers, etc. coming by constantly. I want to be alone and not have hassles like that.

Actually I have changed my mind. I will take a month off of my fight after my next drs appointment. That's on the 10th. From now to the tenth, I will put together my stuff for the media. If you corrupt my provider and take my medication, you're toast. If you don't, then I'll make one last effort to negotiate with you in a way that is remotely fair to me.

My new M.D. costs a fortune and if you take away my medication, I will have to go several days without it. I'm so about to break right now, that I worry what I will do if that happens. It is creating a very

dangerous situation. I said "right after" in my last set of emails, referring to that appointment, but that's not literally right after. I've got about a 9 day gap, because that's the earliest that she had available. I'd run out before then.

If we can get me a suitably large figure, even if it is paid over time, then this can be over. Most likely I'd want a large figure upfront and smaller payments over a period of many years, possibly for my expected natural life. When I say large figure, I'm not referring to anything like what I've talked about recently. You will possibly save on the small payments over years, because I'm very likely to move to another country.

I'll add one more disclaimer, that when I say I'm taking a month off of my fight, what I mean is that I'll be working on my personal websites, primarily my website for Leonardclintonwilliamsiii.com, and also studying software development. The other website is my learning courses website, and it is possible that I don't even work on it at all, and devote all my time to the other one instead. That website has a bunch of stuff about my case, and so it's not exactly taking a month off from my fight. I won't put it online with the stuff about my case as long as you settle. It is just to give me something to do and a project to try the stuff that I learn on. I have mechanisms that I can use when working on a website that will prevent anyone other than me from accessing it. This is not a login page, but the use of cookies and ip address checks that are far more secure and essentially impossible to bypass. I will work on my website(s) on my local machine, and then if I upload them to a server, I will block everyone else. Then when I decide to go live for everyone, I can take all of the stuff about my case down.

The qualifications will be something like this:

1. I can talk about my victimization and share my evidence with any healthcare provider, as long as I have a right to privacy with that provider (in the U.S. I obviously do, and I'd assume in most other countries). This is mainly for the purposes of therapy, but will also come into play in other settings.
2. You can forget me signing any contract that has a bunch of requirements for me. All that you will get is me being quiet about this, and if asked, saying that I wish the bank well or something similar.

The reason for this is that I am handicapped. I cannot meet a big list of requirements and it would be hard for me to even read a contract to know what I'm getting into. I don't want you ever having an excuse to pull me into court, and a big list of requirements would be murder on my mind to try to keep track of.

Obviously, you will also escape further civil liability as part of our settlement.

Another qualification is that I will get to write a book about my life, and have it delivered to all the people who are a part of this situation. This will be the people at the justice department, Jenny, my former managers Shana and Courtney, and others like this. It may be necessary for it to be only in electronic format, so that no one who isn't already privy to the situation will ever see it.

I'm going to me moving to another country and part of the agreement will be that you don't interfere with me moving or interfere with my life in my new country at all.

I'm literally about to snap.

I'm calming back down a lot. I'm starting to feel a little bit happy about the prospects of this situation being over and me getting a good sized amount of money from it. It is very soul crushing that I will not get actual justice after this. I will very likely die in the not too distant future. I will be glad to die, because the people in other countries have humane assisted dying programs.

I hate the way that in America, if you want to die, you have to take huge risks. Your poison might not be real, and they have goons who try to come and save you. It's similar to outlawing abortion. You don't stop people from doing it; you just make it more risky.

So you could get found and resuscitated and end up with terrible brain damage, as if this is somehow helpful to you. If you want to die, you're not going to be any happier about living when you're a vegetable. These people that come to save you are not helping you. They are being selfish and also naive. Most people are naive when they talk about assisted dying. They do not know how bad this life can hurt, and how realistically hopeless someone's situation can be. They do not know this and they do not know that they do not know this.

Life hurts just about everybody very, very badly. People have a hard time believing that they themselves have not experienced the most extreme depths of pain and suffering. And so out of ignorance and this naïveté they have a bunch of garbage about "people who want to die need help" and "wanting to die is a result of mental illness." They assume that there is somehow magically help for everyone, as if planet earth is some magical place, where it is woven into the fabric of nature that every problem has an attainable solution.

I am able to work a lot better on 60 mg. Working is what makes me most happy.

I am thinking of \$20 million instant payment and \$5 million a year for the rest of my life, except that I get \$5 million for at least 5 years, even if I die within those first 5 years. I like to help people a lot. It gives me a lot of satisfaction when I am able to help people. I would be happier thinking about my life if I have money to help people when I die.

This makes me want to cry, though, thinking about it. I have not been treated anything close to fairly in this situation. My soul has been murdered and your cruelty never relents.

I moved my appointment up to today from the 10th. It was obvious that you have not contacted my provider or my provider's facility. This makes me feel a little less under attack. I don't know why you do this to me. You are such rotten and horrible people. Starting the 10th, I will take one month off, as I have promised you that I would. It's total bullshit. Your rotten asses ought to be in the news, where I could put you on a whim. I am also very scared to negotiate with you or to enter into any kind of discussion about this without there being widespread knowledge of what has happened with me. That has been the main purpose of getting you in the news for a long time. I have a legal matter with someone else where I could get a decent sized amount of money that would help me, but I'm scared to death of even trying.

What's going to happen is I'm going to get nothing like what I deserve out of this, or I'm going to get criminally victimized, and then I'm going to move to another country. I won't budge on the final terms that I come up with, and some of them you are not going to like, I think. This is things like I am allowed to keep my evidence and to make new evidence analysis materials for my healthcare providers. I have to be able to show people why I think what I think, or I will be permanently subject to being hospitalized for no good reason. You would most likely want me to destroy all of my evidence.

If we settle, I could take it all off of YouTube and what I would do is make a web portal (mostly by using the code I already have for my old portal) and have a login system + IP address checks and possibly cookies, with the videos hosted on AWS.

I have means to stop people from downloading my videos, even when the people are authorized to view them (through the login, ip address, etc. checks). I have tested my security protocol and it is pretty darn solid.

I have tested it against commercial video downloading software, which is designed to swipe videos from websites. This software can get videos from just about any website, as I understand it (I'm curious to try it on my Netflix subscription, because if anyone knows how to block people it is them). When I tried to download my videos on my old web portal with this software, I got error that says you are denied access. This is when I had the videos on S3. I eventually moved them to youtube and of course anyone can download anything on YouTube. By the way, I won't try it on Netflix, for risk that they cancel my subscription, but I am very curious if they have blocks for it. If they don't, that makes me pretty badass. I'm a beast on all counts, based on the objective evidence.

If you care to know, one easy tactic to stop people from downloading your videos is to first have your player not feature a download button, then you disable the persons right click with JavaScript. This prevents them from right clicking and choosing "save video as." If they're savvy, or they're good with google, they will figure out that they can bypass this by disabling JavaScript on their browser. For this, you get one step ahead of them and have your server send out html that doesn't have any of your content, but that has a JavaScript function that loads your content through an Ajax call. If they disable JavaScript to try to be able to download the video, they will find that they don't have a video loaded to download, because JavaScript is what loads it in the first place. It's a catch 22 for them. You either have a video that you can't download or if you try to get around that you don't have a video at all.

This won't stop this commercial software though. It stops people who don't have this software. It also stops ordinary people who can't execute http requests programmatically. Those people who can are a real problem and you have to do things like implement the rest of my security protocol, which I obviously do not share with others.

I'm getting long winded, but the point is that I can very reliably keep anyone but my healthcare people and me from seeing evidence and videos. Most of the evidence they will have to download, but it is still very tight security and it would take extraordinary circumstances for my stuff to be compromised. My healthcare providers would have to be extremely dishonest and also unusually skilled at hacking websites. If I get a lot of money, I could also buy an account with these pdf security providers, like Adobe, where the pdf is tied to a license and has an authentication processes.

My mind is exhausted from typing.

- these people at these hospitals are pathetic. Every time I have been to one of these places, it's the same shit. You will have some doctor who won't listen to a word that you say. He/she will be your main problem, and if there's any reason for you to actually be there, you will find it hard to get help. In any event your life is at risk of being destroyed.

I had a great doctor at UNC Health Blue Ridge, when I checked myself in for homicidal ideation. His name was Dr. Francesca or something like this. He was extremely kind and seemed to know his stuff. He told me that I was an excellent historian. I felt like I could get a lot of help at this hospital, because of him. I wanted a brain scan and he said that he could get me one but that it would be a "basic" brain scan. I hoped that he had fMRI available in his hospital, after he said this. I don't know if this counts as basic or not. He said they didn't have a PET scan.

I stayed there for a couple of days and then on one day I had another doctor who was taking care of Dr. Francesca's patients for one day. I think he was full time on the unit I was staying in. He comes to my room and talks to me for about 45 seconds. At about 20 seconds in, he tells me that what he's seeing is pressured speech and that he's going to order me some lithium. I tell him that speaking fast is my normal way of speaking, and I tell him that I've been on lithium before and that it doesn't help my symptoms much and also causes me terrible and debilitating side effects.

I tried lithium in the mid 2000s, probably sometime between 2004 and 2005. It puts me in outer space and gives me the most uncomfortable agitation. It was close to handicapping me and if I hadn't discontinued, it most likely would have. I was having some trouble doing my job because I was in a fog. One female customer in her mid to late 20s told her boyfriend that something is wrong with me. Lithium is not what I need, ever.

How does this doctor respond, when I tell him that I'm being normal with the way that I talk and that lithium doesn't work and causes me hellish side effects? He restates that he's ordering some lithium for my evening medication and walks out of the door. This is again the result of a 45 second interaction.

I can't help but wonder if this guy, and perhaps some others, are in a competition with April Morciglio to see who can diagnose someone the fastest. I had a similar 20 to 45 second evaluation with her. I mean what is this bullshit. In any event, this was my cue to get the fuck out of this hospital.

When the lithium makes me go to shit, he will up the dose, citing how I don't appear to be responding to anything. The fog and the agitation that this causes will have me behaving very bizarrely. He will put in some paperwork to compel me to stay long term and he will base this on my serious mental illness symptoms (which are actually just a reaction to lithium, and which I told him would happen in advance. I said this to one of his ears, just so that it could fly out of his other ear at the speed of light). God only knows how long I would have to stay and what a nightmare I would have lived through.

I've got a SQL query API that I designed. With it, you can write a fully executed database query in about 20 seconds or less. It parameterizes every query that has a where clause. I can use it to design database APIs for my applications. It is also designed so that you can write queries dynamically. I had a similar api for an old clients site. He had 7 filters for his products. It created the possibility of thousands of unique query strings (WHERE filter\_1 is thisValue AND filter\_2...). I think it might have actually been hundreds of thousands or millions of possible query strings. Most people that have a faceted search like this will either do multiple queries or they will fetch the entire product catalogue and then filter it. With the api I built, I could fetch the filtered product selection in one single query every time. This api was kind of tailored to his store though. The new one that I built can be ported over to anything. I intend to master SQL and update my API. Right now, there is a lot that it cannot do. I might start on that after the 10th. I have some books on SQL, if they haven't been stolen, but the way to master it is to go through the documentation you get online from the MYSQL website. It is 6,000 pages, if I remember right. MYSQL is the flavor of SQL that I use. When I started my web development business, I didn't know much at all about web development. I knew some stuff about html and css, but had never written a line of programming in my life. I needed a project to learn on. Someone I went to high school with commissioned me to do an ecommerce and informational site for her family's small business. I had to learn as I went and it was murder. At that time (and probably now), if you go online and look for books on how to build ecommerce sites, you get result after result on how to do it with php and MySQL. So that ended up being my backend stack. I want to learn python. I could learn any language there is at present. They are all much more the same than different, and if you've spent years working with any one language, your learning curve for the next one will be 100x faster. Learning to program with your first language is always the hardest. Python is good for machine learning and data analysis, and I want to build a model of the US economy or possibly the world economy.

But my SQL api has a block of code for an update query, a block for a select query, and a block for an insert query. You write the block for each one time, and then anytime you need to write a query, you just copy and paste the one you need and edit a few values and you're done.

I think I was busy with my job at Wells Fargo, or something, because I didn't start the e-commerce until June 2017. I bought some cheap udemy courses and was off to the races.

My process, up to September and October 2018, when I finally finished, was to work on the website, get something working, then get something else working, and so on, until I hit a snag. I would typically hit a snag after very small increments of progress. I would buy books and videos and do google searches, until I got to the next step. It was like I would know what the next question is when I got to it. I'd have to guess as to where the answer would be, and I'd just add to my pile of books and videos.

It was brutal as hell. I was learning at warp speed, compared to the learning track a college student studying computer programming would. What I mean is that I was moving on to more and more difficult problems at a very fast rate, and I was learning the hard way. I would get stuck on problems that would have me ready to scream and to pull my hair out for 20+ hours straight. I'd do this for days in a row.

At one point, I had the store working, except every item that anyone on any computer put in their shopping cart would all go into the same shopping cart. It was like there was a shared shopping cart for every customer. I found this out when I put it on a remote server and tried shopping different devices that I owned. It was murder finding the error, with me not being an experienced developer.

Part of my problem was that at first, I knew no better but to write one big script for everything that I had to do on a given page. I'd have to go through one line at a time, trying to figure out where the bug was. I'd often mess up my mega scripts, editing the wrong thing. I did figure out eventually that the way around this is to write a tiny bit of code and see if it works, then write more, etc. Doing this, I would still end up with a mega script, just one that was written a little at a time. It is very easy to have unintended bugs in your software.

But I did it. Shortly before I finished the version of the site that would go to production, I hired a guy to audit my code for security flaws. He lived in a foreign country that has a lot of programmers. He spoke several languages and had developed award winning software for Fortune 500 companies. He charged me only \$48 an hour. He found some things that would be security flaws, like database queries that were not parameterized, but when I pointed some things out to him, he said that for me this wasn't a problem, but that I should probably fix it anyways. I asked him if someone who was fresh out of college with a 4 year degree could do what I had done, with having this working e-commerce website. He said that they could not.

I would end up going to the [authorize.net](http://authorize.net) developers forum and teach and solve the problems of developers who had been writing software for 10 or 20+ years.

-this is according to the requirements of jobs that are posted online. I'd qualify as a "junior php developer", with what I could put on paper. This is actually kind of stupid, and the corporate working world seems to be stupid in general in this same sense.

I am a badass software developer. I'm in the top 20% easily. Probably better than that. There is a lot that I don't know, in terms of frameworks and things like this, but those can be taught. Creativity for the most part cannot be taught. Nor can schooling inculcate an intense mind like that I have.

I started my web development business in January 2017, doing it part time. By mid to late 2018, I was teaching and solving problems for people who have been to college for this and who have been developing software for 10, 20, and probably 30+ years. This was why I was still wet behind the ears, as a software developer.

After finishing my first client's site, I got more clients and I solved problems that other developers had told my clients were impossible to solve. I did this first for a woman named Belinda, who had been talking to a development firm that was going to get her fined about \$1 million with their fix. She needed the hash validation on her payment form backend fixed. They told her that it was impossible, and said that what they could do is have all of her payment processing forwarded to \*their\* website. I can't remember all the details, but the whole thing was batshit insane and a PCI fine waiting to happen.

All these developers had to do was find the code that did the hash validation for her site, and then copy and paste some code that I had posted on the authorize dot net forum for free into that script. After that, you make a few tweaks and you're done.

Following her, I had some people that found me on the authorize dot net forum and hired me to fix a rental reservations web application. They had a website where people could rent houses in a place called Walla Walla or something like that. They needed their payment form upgraded. They first wanted me to help the guy that was working on it, \*who was the developer of the plug-in software that they were upgrading.\*

They then hired me to do the job, without telling him. It was brutal figuring out the backend. I had never worked on this particular CMS type before. But I worked on it for 7 days, while he was also working on it. On day 7, he sent them a message on Skype informing them that authorize dot nets new payment form had broken the software, and that this wasn't fixable. He advised him to get his other plug-in for another payment form.

I told them that 1) this other payment form is a SAQ-D scope integration, that will cost them a fortune to keep in compliance, and 2) to ignore him when he says that the thing was broken. I had already figured out, days earlier, how to fix it. I was busy writing a set of brutal scripts from scratch. One day later, on day 8, I had it working. This was one day after the developer of the software himself said it was broken and impossible to fix.

When I say brutal, what I mean is that I had to code everything from scratch, without using any of the rental application's preexisting classes. The guy that built the rental application had designed it to be compatible with any number of payment processors, and he had one class that would have saved me 80% of the code that I had to write, if I could figure out how to load the session file into that class. To this day I am not sure if it was even possible. It seemed to pull the data from the session itself and to then create a session file.

But the point is that I was wet behind the ears and I was kicking ass everywhere I went, left and right. In terms of raw talent, I am probably in the top 1% or better of software developers. Might be in the top .1% or better.

- for my first clients, I programmed a bin packing algorithm that packed wreaths and garlands into boxes in a way that minimizes the shipping cost. It would pack the boxes and then price them according to usps and ups rates.

I was too wet behind the ears to use the UPS API or the USPS API, both of which, at that time, relied heavily on sending XML to endpoints. XML is mostly simple, but at the time I knew not one thing about it. I was already working on being a year past my first estimation, and I didn't want to get stuck on yet another thing.

So instead of using the API, I downloaded csv files and pdfs from each delivery services website. These were files about their fees and their pricing for each zone. I loaded all of this into a database. Having the stuff loaded into a database and working with it from there was in my repertoire. Building XML documents and then sending them to an API endpoint was not.

The final result was that my calculated shipping prices matched usps and ups down to the penny. It was very rare that it didn't pick the most cost effective packing method too. I found extremely few instances of that. It is hard to be perfect with bin packing algorithms.

My therapist said that, at some point, she would like us to talk about "moving on." This was about 4 sessions ago. She doesn't understand, or didn't then, just how badly I am damaged. "Moving on" is not an option, not without getting a load of money out of this fight. I will literally end up dying in the street. That's the medium term outcome for me. It depends on how fast I run out of social security money and how long my mother lives or is able to work.

My money was all that I had to save my life, and I gave my little woman at least \$1,000, if I were to estimate, and now you have taken her away. It makes me hurt so much and so mad. I didn't anticipate my mother going to town on ATM machines. That has murdered me that much more. Every time she asks me for money it feels like an act of cruelty and makes me feel like I want to die really badly. I never turn her down. I give her my debit card so that she can get the money. The purpose is to avoid any remote chance of an in-person conflict, because I will end up in prison or institutionalized for life. That's my worry. I have terrible feelings towards my mother, but I would still cry so hard and feel so bad for the rest of my life, if she died in an argument with me. It is a terrible outcome.

And I have been damaged so badly that there is a big limit on how much I will be able to "move on." In any circumstance. Getting stuck on the traumatic event(s) is part of PTSD. I am pretty sure that I have read this. My case is so extreme and the resulting brain damage is so bad, that I will never escape this for more than a handful of hours at a time. Even that is hard. Most of the time I find it nearly impossible to not think about what has happened to me for as little as 90 seconds at a time. It dominates my life, right down to just about every second.

And another thing is there is a sort of compulsive element to it. Not exactly a compulsion, but there is this strange thing where I'm not interested in disconnecting. It is like I have intrusive memories at times, and those are pure hell. But outside of that, I don't have a lot of desire to talk about anything else. It is not something that I can help. I am trapped in this badly damaged brain. It's not like I make a conscious decision to not move forward. It's like there is some drive that I have no control over, and it pulls me in with this huge power. Kind of like a gravity. If someone told me that I needed to forget about it and started being forceful, I would get extremely distressed. It would be horrible.

I know, and I have known for a very long time, that if I got the right type of brain scan, that would show the damage I have sustained, and the doctor ordering the scan was an experienced expert, he'd come back saying "I have never seen anything like this."

But back to dying in the street, I literally feel impaired by even thinking of making a can of soup. I cannot think through all of the steps involved. I don't have the mental power to do it. I do know one trick that will allow me to think all of the way through it, and I think this trick would be illuminating to a well versed neurologist. I won't give you the whole thing, but if I picture myself in a really big house, not a mansion, but maybe a 3,500 to 5,000 sq ft house with a big, wide open living room, with plush furniture that is spread out with a lot of distance from one piece of furniture to the next, with the furniture and the house being very clean, like spotless. And then having a huge kitchen, with a big, long white rectangular table.

I can't think about it anymore. That was starting to get overwhelming, but there are times that I can finish out that imagination exercise, all of the way to the end where I have a hot bowl of soup.

If I try to imagine making a can of soup in this apartment, I get overwhelmed very very fast. But the elements that change, with there being huge wide open spaces, and the rest of the elements in my other imagination exercise, there is some clue in there about what is wrong with me.

For sure, I have very significant, I'd say severe is the right word, neurological damage.

I got a lot of enjoyment, in 2020 and part of 2021, out of working on my learning courses website. I was studying software development and I would rewrite the code that I had over and over. I might have rewritten it 3 to 5 times. I would learn for a while and then I would apply what I learned by starting from scratch. I did this mostly while taking some of the extra adderall I was given each month.

I would estimate that 70% to 90% of the work that I got done towards anything during that time was done while I was taking extra adderall. It would most often be 1 extra. On rare occasions I would take 2. AU girl got me extremely frustrated one time and it caused me such horrible distress that I ended up taking 3 extras or possibly more.

But my learning courses website was the project that I created my PayPal API software component and also my MySQL API component. My PayPal API component takes PayPals SDK for the PayPal API and simplifies making an api call. It is something great, especially, for beginners.

PayPal requires you to nest arrays in a json style of formatting, when you make your API calls. It is the type of thing that would confuse a beginner. My classes for their API allow you to build the request one part at a time, largely using setters. It is a no brainer. You build the components of the request and then load them into the class that executes the request. That class constructs the nested array for you and then executes the request.

I have a separate set of classes that capture and process the response. It is something that I could build on and eventually have one big client that makes api requests with just a few lines of code.

- I say this to you, and I say it knowing in advance that the smoke flies off the gears in your head as soon as you hear this. My therapist is still new to me and I have a complex case, in terms of my ptsd. Once I am able to fully explain to her how I am impaired and the limitations that I have, and all of the rest of the details of my illness and my handicap, she will be fully on board with me. She will vet everything that I've told you, about how just pretending this didn't happen and going on with life is not an option. It will make perfect sense to her, as well, how I am stuck in this situation.

I have told her recently about my hostility and how it creates impulses to murder my mother. I've told her some other stuff, since then, too, concerning the way that I am handicapped. Any assessment of my situation that deviates from my assessment of it, in a material way, is dead wrong. Any explanation for my condition, how it developed, etc. that substantially deviates from the explanations I have given is dead wrong. What remains is for someone with extreme level of expertise, and actually it will probably take more than one person, but for an expert or group of experts to fill in the details of the account and the explanation that I give. Brain scans, etc. will aid in this.

People who do not agree with me, pretty much completely, on everything that I have said are lacking knowledge and expertise on the subject matter, or they are lacking in the ability to reason, such that their capacity for reasoning falls short of mine, or they need to talk to me and iron out the things that they do not understand. They need to tell me what they think that is different, and then allow me to flesh out the picture for them, at whatever place they are not fully on board with me.

I've been down for the count for a very long time, in terms of working on my letter. I had an appointment with my therapist at 9 am. A little before that I took a 5 hour energy. I am getting my sleep back turned around. What I do is stay in bed longer, and then try to stay up as long as I can. I will do this repeatedly for days, until I start to wake up in a sweet spot. 1 am is a pretty good sweet spot, so is 3 am, and so is 5 am. The 1 am to 5 am range is ideal and my target. At different times I've had different preferences within this range. Last time I was at 5 am and very happy.

Once I get to a time that I like, I stop screwing around with my sleep, and I try to keep to a regular schedule. The point is to have the hours I am awake overlap with the hours that my mother is either asleep or not here. This keeps my mind from being taxed and keeps me from being tormented. I am much more often able to do productive things during hours like that. This is even though I still have strings of days where I cannot do anything except lay on my bed and surf the web or type on Twitter and Facebook.

I am a ruined human being. I am not fit to be around people. The slightest thing will set me off and I will lose it. You don't know what you've done to me. I imagine things all of the time, life scenarios of how life might be if I get something out of this and can have a life. Sometimes I will having imaginings where I have a house and someone breaks the rules and lets someone else come in without planning it with me first, and without them being debriefed about how to be around me. In these imaginings, I always picture this uninvited person belittling, mocking, or teasing me. I picture them as taking me lightly in some way, such as one or more of those. Imagining this immediately causes me terrible pain and a palpable hostility. I start to think to myself of how I need to sneak and buy guns, if I'm ever able to live in a setting like this, so that I won't have to be put through this horrible pain and not be able to stop it. And god damn you people I am crying as I type this.

I am so sad. But I will often imagine, also, in these same imaginings, the scenario that I do have a gun. I picture the person who has taken me so lightly becoming horrified and overpowered with fear, and having a panicked reaction and trying to reason with me, when things instantly escalate and I point a loaded gun straight at him. I picture it as something like him saying "I'm sorry.....I'm sorry....please....I'm...I'm...sorry." Sometimes I will picture shooting him and then dousing him with gasoline or lighter fluid and catching him on fire. I would just massacre him unrelentingly, out of the terrible pain he had caused me and the need for it to go away.

I have doubts sometimes, too, about if I would ever do any of this, even in the worst case scenario. My thoughts about this are always triggered by hypothetical situations that I run through my mind and imagine how I would react. This isn't always voluntary either, by the way, having imaginings of people belittling or mocking me and of me becoming hostile and being violent. When I have these imaginings, I will have a sense of the pain I am caused and the extreme hostility that comes with it.

In any case, I can manage my situation. All I need is my own place and to live by myself, like I lived in Charlotte. I could have kept a life that is safe for me and for everyone else going indefinitely. I kept such

a life for over 2 years, before I was evicted. It is not safe for me to live with anyone other than my mother. It's scary for me with her here, and she's a complete pushover who never gets mad and acts like has no needs. If someone else moved in with me, for me and them to live together, I'd be surprised if they made it two months. I wouldn't be surprised if they only made it two days or two hours.

My condition has improved, though, since 2021, when I would be pacing the floors. Back then I had more frequent and more intense shell shock. It never occurred to me that people might not know what I mean, when I say shell shock, until my therapist asked for clarification the first time that I mentioned it to her. Shell shock is just an old fashioned name for PTSD, but when I use that term, I mean something specific.

It is this feeling of being pounded with trauma, emotional pain, and distress. It is horrific. When I get this, it is obvious to me that something is going on in my brain that causes it. It will often trigger a physiological reaction where I tilt my head and my upper torso backwards. I don't think that my upper torso always moves, but my head does and in 2020, this reaction would be so extreme that my whole body would kind of seize up. I would be pacing the floor and getting hit with this trauma, over and over, and when I would pace by the standup mirror in my bedroom and it hit me, I would see myself and I would be in this bent shape, and my head would go way back.
