I can't remember when I started on this letter, but as of now I'm on page 24. This is single spaced. When I am not impaired, I can write this extremely fast. It is largely because these are thoughts that have accumulated in my head over a good sized time period. There is no creativity involved. I don't have to think much at all about what I am going to write.

Another factor is that I am a very fast writer in any context. This is especially before I became disabled. I used to write Jenny's sermons. Sometimes it would be more me giving her corrections and ideas, and sometimes I would write very large sections of the sermon that would be included close to verbatim. There was one in particular that really sticks out in my mind. Jenny had been working on it for hours and hours and hours. She was panicking because nothing that she could come up with sounded good to her. She emailed me the sermon at about 1 am. It was a wreck. I asked her what the topic was supposed to be, and she explained it to me. I just said "here" and with her sitting on the phone with me, I typed her a complete sermon, with just a few things left for her to add. It took me about 30 minutes to write it from scratch. I formatted it as a bulleted list of sections. She then did our typical thing where she takes my suggestions and what I wrote back to the drawing board. She will add her own stuff and reword some of what I provided.

This particular sermon was important, because her pastor wanted her to write something that would convince the very stubborn elders of the church to agree to a buyout from a larger ministry. I think I have that right. It was the only way the church would survive financially, but they needed votes and these people wouldn't budge. Our sermon worked. The stubborn people lost their stubbornness. I am like my madman cousin. I'm charismatic in my preaching.

- I've got enough for any publication or network to do a story. The evidence for the crimes I have been subjected to is blatant. Of all of the crimes, the crimes related to your coverup are the ones that I have the most powerful evidence for. I have 2 folders on my computer where I keep my evidence. A lot of it is duplicative, but I've easily got 700 to 800 unique files. This is evidence and evidence analysis materials. It's likely that I've got over 1,000 unique files. It takes me a long time to organize this evidence and to make analysis materials on it, due to my handicap. That's why in 2020, I only had 33 files to send you. Those 33 were all that any law enforcement agency would need to get search warrants, etc. and take these people down. The 700 to 1,000+ files does not include many of the videos that I make and post to YouTube. It for sure does not include my latest series. I worked on it up until just a few weeks ago, when I told you I wanted to settle this out of the media.

I'm up to 170 videos, maybe on that one. I've got a bunch that I haven't uploaded to YouTube yet. I'd have to upload them to youtube and then put them on my list to tell you exactly how many. I want to say 167. Different news media outlets have links to these videos and my evidence in their email inbox or on WhatsApp or signal. I sent them at different times, so how many in the series they have will vary. For sure there are versions out there that are waiting to make you toast.

I've got all of this backed up on cloud accounts, most often multiple cloud accounts. Some of it I may not have access to, if I have forgotten the password for a cloud account. Most likely I'd be able to think it up. I turned off the password recovery feature on a lot of them. This prevents anyone with access to my email from getting a code sent to them. I use AWS and then I use the freebie tier or the \$2 a month tier on other cloud services.

Even after all these years, now over 4 years, of collecting evidence and preparing evidence analysis materials, I've still got enough that I have yet to analyze to make for many months of work. Possibly a years worth of work, even, or more, in the condition that I'm in. I've also got plenty of stuff that I've made that I could do over and include more incriminating details. There is so much to this and I'm just one person.

All this does is beat this thing further into the ground. I don't know why we had to get to this point. It's all senseless and I never did anything to any of you. And now that I think of this, I'd say it might be 2 years work left in putting together evidence analysis materials. I wouldn't do it that long though. There are diminishing returns at some point.

I start thinking that I need weapons, sometimes, when I'm walking down the sidewalk at the complex where the bar is at. I constantly anticipate someone coming from some direction and belittling or harassing me. I feel threatened and think to myself that I need to never come here again without bringing a hunting knife. I never bring a hunting knife. I know better than to put myself at risk like that. But once I get there, that's what I think.

You have destroyed a human being for absolutely no reason, and you need to cut your losses.

-this may not jive with how you see me. The fact that I talk to the people like you, who seem to think so well of themselves, like they're garbage- this might lead you to think that I think so highly of myself. I do think highly of myself but not in a way that I am better than anyone else.

I talk to you like you're garbage because you are. I intended to explain this in my letter. I may get back on my letter at some point soon. There is no one who is above getting told exactly what I think of them. If the United States Department of Justice is a pack of depraved conmen and liars, I will tell them to their face that they're a pack of depraved conmen and liars. I'll put the truth in your faces too, no matter how comforting your lies are to you.

I judge people on how good they are at perceiving and discerning reality. This ends up with me not thinking that there are many people above me. No one is exactly below me either, even though the majority of people cannot perceive and discern reality with the acuity that I can.

I have no awe and reverence for people who hold office in some high up place or who have otherwise acquired some status or prestige. I have nothing against them either, not by default. I am typically very happy for them and their success. I look at them and I want them to be happy, and I feel like I want to help them, if I ever can. But people who are in high up places are quite often out to lunch in what they believe. Their understanding of the world is inaccurate and often kind of feeble. I spot this pretty readily and it makes them seem all too human.

It doesn't bother me, but in the case they do get in a debate or an argument with me, I'll tell them that they're dead wrong and I'll tell them why. I'll put it into plain terms how ridiculous what they think is. I'll never concede that they're right unless they are. They may be shocked that Leonard Clinton Williams III would contend with someone so high and mighty as them. Who do I think that I am, to challenge (insert whoever the big shot is). That's what they think. I am a humble human being who is good at seeing this as they are, and who is also conscious of his ignorance in the vast number of places where it exists. In most of these vast places, my ignorance outweighs my knowledge. It is not typical of people to think like this.

A tendency inherent in ordinary human nature is to be given to a false sense that we understand things. I am much, much less given to this than others. I believe that it is partly due to my being autistic. I have a profound impairment in my intuition. It is an impairment that just happens to double as a gift. The fact that my intuition malfunctions seems to get in the way of me thinking that I understand something that I do not.

I am murdered from typing this and can't do any more.

-here you are thinking that this is an unfamiliar experience for you. You don't readily recall any time when someone put something very complex in front of you and you felt like you understood it. You do this all the time, most likely. Most people do. For sure you've done it 100 times in your life, probably closer to 1,000.

It is the way that this works. Complex things are the definition of things that are hard to understand, in how you think. When I speak of things that are complex, it brings to your mind all of the things that you found hard to understand, and none of the things that you found easy to understand.

What I'm telling you, is that in the latter category, of things you found easy to understand, there are a lot of very complex things that you don't actually understand. These complex things didn't seem complex to you but they were. You felt like you understood them but this feeling was an illusion.

The doctors at this hospital, and the doctors I saw after that, they \*are\* each more than a beginner, most often far more than a beginner. They correctly \*did\* determine that I am a very kindhearted man.

Let me dumb it down for you. You are law enforcement. You tell the world that you enforce the rule of law. Those healthcare records are smoking gun evidence of a very serious crime. Title 18 US Code will have it listed and you surely knew about this. This is something that you are more than a beginner at. For future reference, you'll want to arrest people that obtain people's healthcare records like this and then waltz into your office to show them to you.

You have done it this time. I try to think of you and then you do this to me.

And let me tell you something else- these people that keep getting victimized for wire fraud are pitiful. It is absolutely horrible. For this, I see 2 steps you could take that would cut this problem by at least 90%, probably more like 98 or 99%.

1) is when you send out a code to someone's phone to authorize a wire transfer, make it a two step process. Don't just send the code. Send them text in all caps that says something like "SOMEONE IS TRYING TO INITIATE A WIRE TRANSFER OF \$24,500 FROM YOUR CHECKING ACCOUNT. IF YOU DID NOT REQUEST A WIRE TRANSFER FROM YOUR CHECKING ACCOUNT, YOU ARE BEING SCAMMED. IF SOMEONE CALLED YOU SAYING THEY ARE WELLS FARGO FRAUD DEPARTMENT OR ANOTHER SECTION OF WELLS FARGO, THEY ARE SCAMMERS. NOTE THAT SCAMMERS HAVE THE ABILITY TO SPOOF WELLS FARGO PHONE NUMBERS.

IF YOU DID REQUEST A WIRE TRANSFER OF \$24,500 FROM YOUR CHECKING ACCOUNT, REPLY "YES" TO RECEIVE A FOLLOW UP TEXT WITH AN AUTHORIZATION CODE. DO NOT SHARE THIS CODE WITH ANYONE. ANYONE WHO ASKS YOU TO READ THIS CODE TO THEM IS A SCAMMER WHO IS TRYING TO TAKE YOUR MONEY. WELLS FARGO WILL NEVER ASK YOU TO READ AN AUTHORIZATION CODE OVER THE PHONE."

You could change the reply "yes" to something like "I approve this wire", to beef up your security that much more. Making them reply "I approve this wire" makes it obvious to them what they are doing. A good scammer could bypass the "yes" with some people, by calmly saying "your going to get a text. The first text is just to authorize me to talk to you. So just type yes in all caps to that one. Then we will follow up with a code for you to read to me, to verify your identity." This type of thing will work on a lot of people, who may feel urgency to address the purported fraud on their accounts and not have time to think. But when you make them type "I approve this wire", it will send alarm bells ringing in their head.

2) this one is harder, but I think it would help. I would have the Wells Fargo IOS app and the Android app, and whatever other apps that you have, detect when people get a phone call from Wells Fargo, particularly Wells Fargo fraud, since that's what these people always use. I'd have the app ping your systems when people get a call, and then have your systems watch for wire transfers that follow up. Ideally you'd have an automated check if the call really came from Wells Fargo. The automated check would use your internal records of the calls that you have made.

I'd put in a system that checks for things like this. I'd especially watch out for wire transfers initiated online, from a VPN or an IP that the person never uses.

That's just how it seems to me. It is absolutely maddening to have people who aren't as smart as you, often by a long shot, and who don't know what they're talking about, look at YOU and treat YOU like you're stupid.

I need to focus on getting money from the people on the other side. There is practically nothing that I can do for money. I've got a friend that I help with his web applications from time to time. I made \$72 last year and \$750 in the few years before that. I think that I made it in one single year. The company that he works for paid me to do some work on their website. I got \$500 for helping them with a script and then I got \$250 for an additional 2 hours of work. That's the highest rate that I've ever been paid, and it was because he felt sorry for me. He understands my limitations and we're never on a deadline.

If I am to make money, I need things that require the absolute least interaction with others as is possible. One idea I have is writing an extension to PayPal's SDK, and then selling it to PayPal once it is done. PayPal's API has the appearance of being put together hastily during the startup phase, when the company had to do what it could to get off of the ground. They could get a lot of capitalized value from an extension to their sdk.

If I do this, I would be writing code for probably a year or more. The extension that I would make would be for the orders API, not any of their other ones. But I'd write code for a year or 18 months or maybe more, and I'd only have to talk to people at the end of it. I cannot deal with daily interactions with people. It is hard enough talking to them once a year or 18 months.

I could make some learning courses, but that would take me forever, and I'd have to deal with customers. I might do it though. I feel helpless when I think of trying to work. It's like I just can't do it.

My remote database server is low end. I had to export some data from it the long way. I have a bunch of base64 encoded image data on one table. Trying to export the table crashes the server. I had to create a set of separate tables to each contain partial data sets, and then export each of them. It was a major pain. I had to write a script for the transfer from the main table to the sub tables. I had to manually run that script over and over. It is far too cpu intensive to just set a loop and run it one time. This is even for my new web server. It is an upgrade from what I normally use, which are among the top 4 or 8 cheapest servers you can get on AWS. I'm eventually going to upgrade that to a much more beefed up server. Probably will put it on a Cloudfront distribution at some point too.

I am probably going to move most of my development to my local machine. As of the time I bought it, it was the most beefed up HP 15.6 inch notebook workstation you could build. I got the fastest SSDs, 2 512 gb of them. Then I got the best hardware available for everything else except the display. I am not extremely picky on screens and that's one place where I will try to save money. I'm about the performance of the system, and not so much about things being as pretty as they can be. I got the 2nd or 3rd option up from the basic opinion for the display. HP threw a sale and my agent gave me a big discount after that. It was an almost \$6,000 build, before the huge discount HP gave and the additional cut my agent gave me.

I'm not interested in paying someone 30% for a case and a fight where I did all of the work. I also do not trust you to not pay off my lawyer and have him/her work against me. I feel like I'm taking a risk by even trying to pull you into the picture out in the open, but I've got to do what I've got to do.

For money, I want \$20 million immediately, and then \$5 million a year, paid monthly and adjusted for inflation. I want the adjustments to mirror the current social security rules for COLA, but not tied to the social security rules as any sort of index, meaning if the social security laws are adjusted to not pay COLA or have any other change, it will not matter for me. My "index" will be the current laws, as if they are frozen in time. I will add one more qualification, that I get at least 3% per year. So if inflation is less than 3% or is negative (deflation), I still get a pay bump of 3% for any such year.

I can limit who I talk to about this. I have some things to say to my mother and also to my sister about this. I also want to have the right to talk about it to any psychologist who is providing care or support to me. I will need to keep my evidence (remember that much of my evidence consists of my healthcare records, as they are a crime scene). I will also need to keep my evidence analysis videos and evidence analysis materials. This is because of the nature of what has happened and the threat that is posed to me, when I am not allowed to explain why I think what I think. But outside of any current or future psychologist(s) and mental health services providers, and the handful of people that I mentioned, I can keep this to myself. You may wish to pay the people I have told about this some money to keep quiet. I'd say \$10,000 a pop would be enough for them. I gave you a list in some of my audios from a long time ago. That list hasn't changed much. I could update it, if I thought about it. I will also add that I have to talk to this to any kind of healthcare provider, not just people treating me for mental illness or psychological maladies. This is doctors for my heart, neurologists, and anyone else who is addressing any problem or potential problem that I attribute to what has occurred since 2017 and particularly since 2021.

I feel like you've changed and are open to this being settled in a way that I can live with. I am not certain if this is another ploy to keep me on the line, however. You've conned me over and over, and I have very little information to go by.

I can live with \$20 million and \$5 million a year. It's not what I would call fair for me, but I still would have done good. I think that my despair will go down significantly once I get my own place too.

The alternative to this is being in the news and then me asking for something that is closer to fair, and I can justify figures in the \$10s of billions quite easily. If I ask for \$10 billion, it will be pennies on the dollar. I don't know when I'll have my terms written up. I've got to send you more Audios and my letter too. I

was extremely impaired yesterday and life is hard. I'm also enjoying working on my website sometimes, although it does cause me horrible distress from focusing.

If you want to hire me a lawyer, for some reason, like maybe that's better for you somehow, that is fine. This whole thing is kind of like being staged, and I will play along. I'm just not interested in any business as usual negotiations, where I have a lawyer who has leverage over me. In that case, I fully expect you to pay them off and have that leverage used against me. You hiring me a lawyer would not be anything like a business as usual practice, but nothing we have done is business as usual.

I am a hyper empathic person. I think that this is a result of my childhood. It surprises me, just a little, how low I scored on cognitive empathy. I inherited something from my dad that gives me an ability to read people, and the profession of psychology repeatedly states that acute cognitive empathy is the driver of things like this, in people like my dad. I think they are wrong. I think they are confusing a different phenomenon for cognitive empathy.

Cognitive empathy is the ability to see things from the perspective of others. This test describes it pretty well in the results. What I have, and what I'm sure that my dad had, is an intuitive sense of how people think. This intuitive sense is general and can also be specific. There are certain ways that people think that are kind of universal. Then, in terms of specificity, if I'm around people for a length of time, I will develop an intuitive sense of how they think that is tailored to them.

When I was a child, I used to impress my aunt (my mother's sister) by telling her what my mother is going to say next, before she says it. I'd be like "watch this, I'm going to ask mom..." and then I'd tell her exactly how mom would respond. When I asked mom the question, her response would match what I said, sometimes verbatim. I don't want to overstate the case. I don't remember doing this all that much, but there were still quite a few occasions. I don't recall ever being wrong.

And this is how my dad accomplished his deception. He knew how people think, and so he could predict their thought process in advance. He could get their gears turning and know exactly the direction they would take. People aren't used to this. Other people don't have this ability and so it never occurs to them that someone else might. I recently read an estimate that it's actually a fifth of a percent of people who are like my dad. That gave him and gives others like him a lot of stealth. He or she comes on the scene, and the people who are the targets of his or her scams, manipulation, and predation, have never met anyone like this. They don't even know that such people exist.

What I do, my paternal grandfather described as "analyzing what people are saying" or in his exact words "you're analyzing what I'm saying" which he told me, at age 12, is "exactly what your dad does." People's words reveal their thoughts and they do this even when (or maybe especially when) they're trying to hide something from you.

And I again don't want to overstate any case. My dad was only human and sometimes his deception and his ridiculous explanations for his immoral or unlawful actions were transparent enough that anyone would see through them. This is much more so the case for his excuses for his behavior. His ability to deceive people was many notches above his ability to make excuses for his behavior that people would buy. It's the kind of thing that people will eventually pick up on, that this person is full of shit and will lie to you. For instance, he gave one of more of his wife Mary's children beer to drink, when they were extremely young. This was brought up to him by someone (I think it was one of the the kids himself) when I was between 12 and 15 years old. I can't remember my exact age, but dad said "I was living on sin, and when you're living in sin, you don't know that you're sinning." I mean you have to think about this for about 3 seconds to realize it's a load of garbage.

And when I say young, I mean really young. I can't remember for sure how old this kid was, when dad gave him beer, but it does seem like he was younger than 5 years old. My dad gave me beer to drink when I was 3.

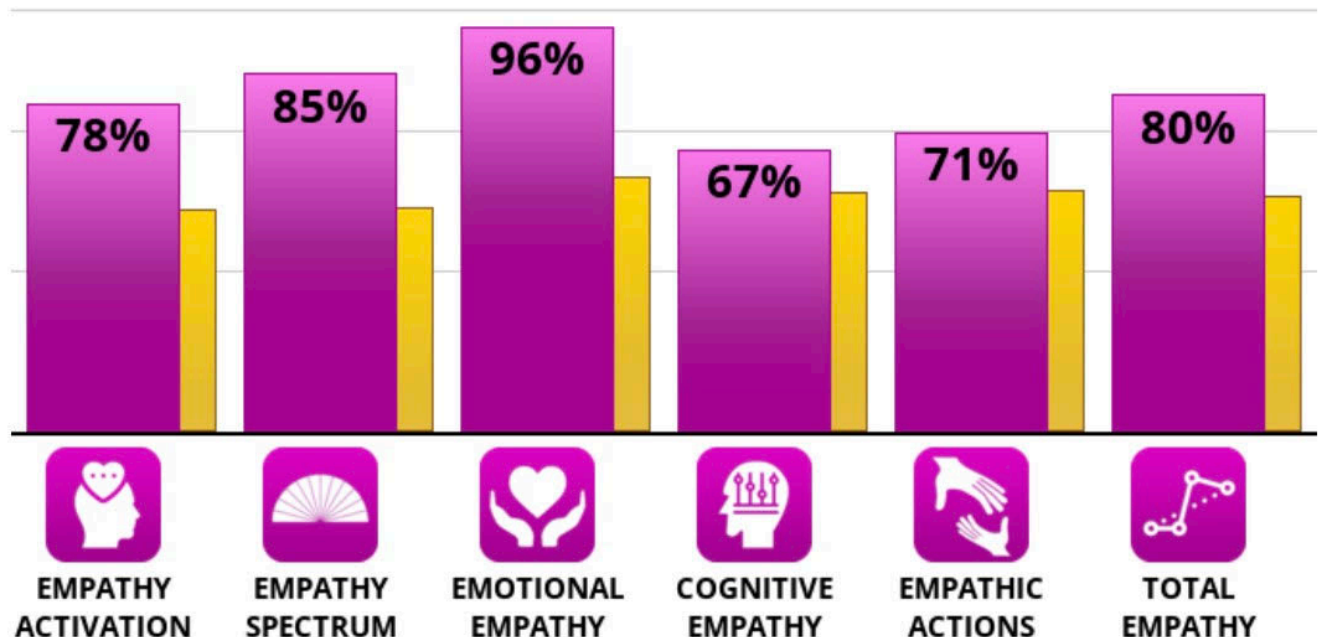

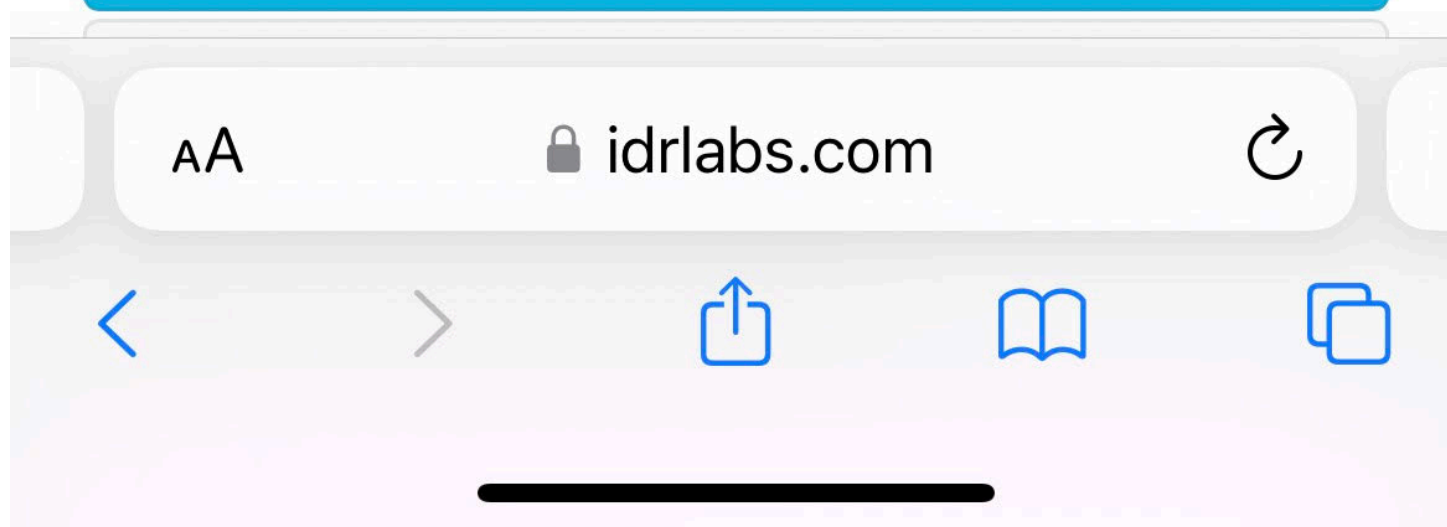

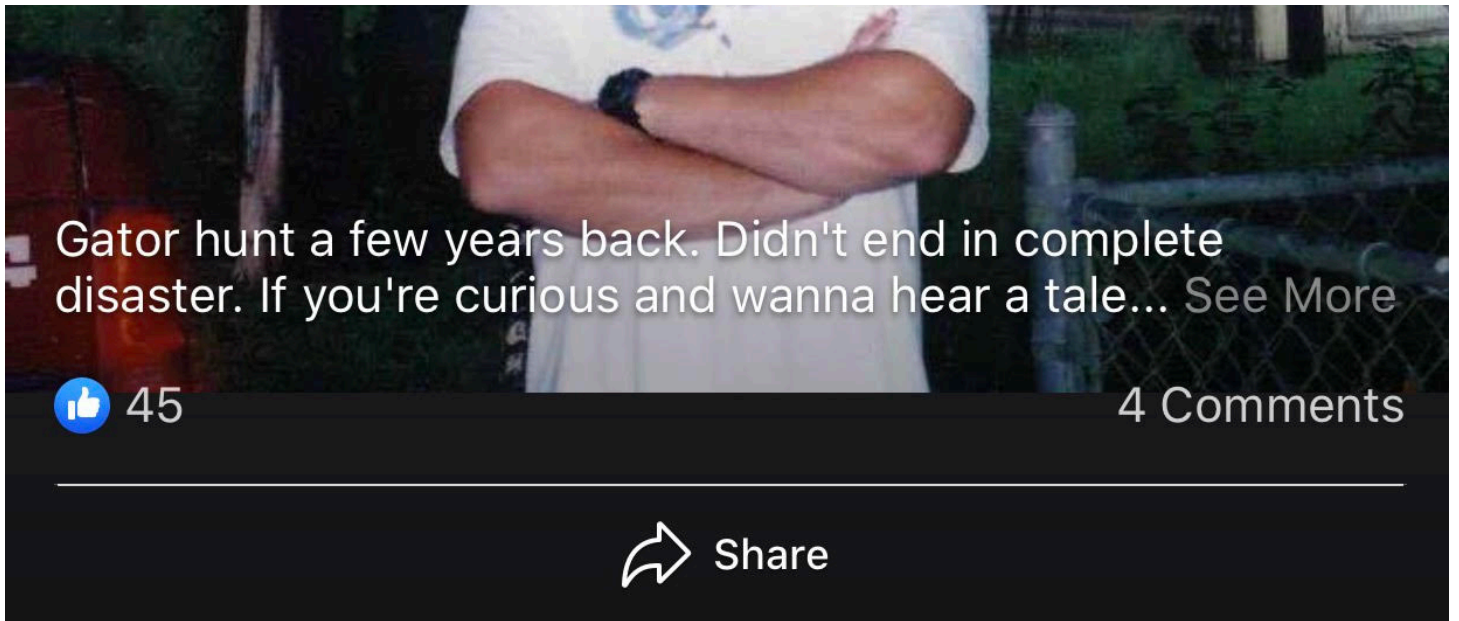
