I have thought for a long time, about writing a book about my life and what has happened to me. As handicapped as I am, I could do it. I am not aware of anyone who has reflected on his or her life to the extent that I have, not even close. I know of no more miserly accountant of his or her conduct than myself. I think about my life in terms of the details, and I also think about my life in terms of the effort that I have made. I'm down for a battle at the level of the details. Pick a detail and it's probable that I remember it. On more details than not, I will win the fight. On some details, I will lose the fight, and that is because, for those details, I refuse to even try to win. I will concede defeat, with no resistance. That's the right thing to do. It gives the other person value. It makes them matter.

Each detail is like a skirmish in war. I will win so dramatically, and so decisively, so many of these skirmishes, that the war will be a bloodbath. My opponent will not want to come back and try again. Part of it has to do with the trend of putting effort into doing what is right, consistently, for a very long period of time. There is no moral decision that doesn't weigh on me to some extent. I may do things that are wrong, and I may even seem cavalier to someone who is watching, but it always registers with me on some level. There is always a desire to do better. Most moral decisions weigh on me a lot.

And like a lot of things, there are qualifications. I'm not going to sit back and let people lie about me, even if I did do them wrong. For so much of my life, I beat myself up, constantly. In recent years, I have gotten better at this. What I have found is that, when you beat yourself up, other people jump into the dog pile with you, and beat on you some more. It is this pathetic quality that people have. You become an easy target for dysfunctional primates who have too much mercy on themselves and are looking for someone to take their problems out on. So I'm better on that one, at least much better than I used to be. I'll stick up for myself if people are being ridiculous. I'll acknowledge the wrong that I did do, assuming I did any, and I will defend myself against the rest.

It's also kind of ridiculous sounding to say things like "I've done right more often than I've done wrong." It's even more ridiculous to say "in my life, I've done more things that are not wrong than things that are wrong." That's not what I'm saying. I'm counting the details that matter, that happen in the moment. The game of doing right as a human being is played in the moment. If you don't make the right choice in the moment, you lose. There is no other time to make the right choice, and you can't plan ahead on what opportunity to do wrong and benefit from it might come your way. So much of this hijacks us from out of the blue.

It gets the job done and is maintainable. I am not aware of any design principle that it violates, and principles are just guidelines anyways. I don't know every principle by heart either.

What I am doing, over time, is building a framework that is specialized for my use case. It is designed for people (like me) who buy hand coded UIs and make them dynamic. My framework is different, in that it places no constraints whatsoever on what you can do with your website.

When you get Wordpress and buy a Wordpress theme, it's like buying a condo and choosing how to decorate it. You're pretty fixed in, with what you are going to have. Your choices are limited.

What I do is build everything from scratch, even if that means I buy something that someone else built from scratch and make it part of my project. It is like having raw land, to build anything you want, completely customized. No limitations at all. You are not limited by whatever plug-in comes closest to doing what you need to do.

I could never do this for money again. I am too slow and I can't deal with people at all. Still yet, I approach it like I'm doing it for a living, even as I make progress at a snail's pace. I want my stuff to be top notch.

I've got somewhere between 2 and 5 people who have downloaded my complaint in the past about 5 days. I've gotten rid of the Twitter scrapers, and my new pain in the ass is bots. I've had bots the whole time, but they're screwing me up in a new way now. In the past 24 hours, I've had 6 downloads of my various files. I've also had clicks on my Cloudfront domain's base url. 3 of the 6 are my complaint. I have 3 hits from bots. This makes it impossible to know which 3 of the 6 were bots, and thus I have no way of knowing how many times my complaint was clicked. It could be 3 or it could be 0 or it could be anything in-between. It may be that all 6 were legit users, and the bot clicks are all accounted for in the hits to my base url. I've done some analysis, and it looks like that there is most likely a 3 to 3 split among the downloads. 3 are bots and 3 are people. But again, I will never know for sure.

I just checked the visitors to my website. I'm getting the mystery of the twitter scrapers solved. It is remotely possible that I had it backwards, that when I get 70 clicks from [t.co](https://t.co) and 9 of them have user agent strings, my complaint is being downloaded 61 times and the other 9 are not downloads. I've got to run a test. In the past month, I've got 73 hits on my website from twitter. The ones with an empty user agent string have a different uri. It doesn't show up in Cloudfront. When I had a direct link to my complaint in Cloudfront, it showed [t.co](https://t.co) for all of the twitter referrals. With this uri that i capture on my website, it will be possible to run a test by manually clicking my Twitter link and see which uri my request triggers. If I do have it backwards, there are a LOT of people who clicked on my complaint, since I started my twitter campaign. This also means that there are a LOT of copies of my complaint sitting on peoples hard drives, at least those who didn't delete it. If they click it on a notebook or desktop, it automatically downloads. It doesn't load in the browser window. It puts a pdf in their downloads folder.

I mean I got a bunch of these every month. Probably 150 or 200 from this empty user agent [t.co](https://t.co) referral. Might be more than that. I've got all kinds of people reading my stuff on Twitter. 10s of thousands a month, I would say, before I stopped tweeting as much. I'd get 250,000 impressions a month and usually thousands of likes in the aggregate.

- I care about my life. I am not likely to ever put myself in jeopardy, by having a social life. I am vigilant and intense in protecting my life. It is the recklessness of others that causes all the damage.

When I say I care about my life, I mean that I am very concerned with my circumstances and I know what can go wrong. If I get in a fight with someone at a restaurant or a bar, especially if it involves knives or fire, it will lead to me being permanently institutionalized. I put that at a 70% probability, minimum. I want to live in comfort or I want to die in peace. There's nothing else that interests me. I want to live in comfort because of how ill that I am and how much I suffer. I can't deal with much hardship, as helpless as I am.

It is fun having a social life. I'm an on and off smooth talking bullshit artist who is fun to be around. It depends on the setting. The more unpredictable the setting the worse and the more socially awkward I am likely to be. It will be especially hit and miss. Same thing for a setting that is completely new to me. I'm always anxious when something is new.

If I get used to a place and the features of what happens at it are consistent, I will naturally start to take on the qualities of charm and charisma. This has most frequently happened in workplace settings, because I'm a workaholic and so that's where I'm most familiar. Bars and clubs are places that I can never fully get used to. I will be awkward sometimes, and then at other times I seem larger than life. The way most of the bars that I've went to work, at least the ones that stay busy, is you never come to the same place twice. It's always unpredictable, and if you have a social deficit like I do, it's like you get curve balls thrown at you very often, and there's always a new one. People and situations are hard to figure out.

This is one of many reasons that I have for thinking that my personality type, which is described by David Weeks in his book, results from a combination of autism and features of psychopathy. I took a test online, that was designed to assess someone for this personality type. The people who made it appeared to have a lot of knowledge about this personality type, and I'm not sure where they got some of it. They asked things that I didn't recall being in David Weeks book. It asked 30 or 32 questions, something like that, and I fit the profile on every single line item. My score was 100%.

One of the questions was something to the tune of "I have a gift of charm, whimsy, and wit." You ask people who have known me and who aren't facing prison time, or actually even some that are, and they will vet this. This is a recurring quality that I have in many contexts. Then another question was "I can be socially awkward", something like that. I'm another yes on that one.

Is it just me, or doesn't this seem strange? What kind of person is both charming, carefree and whimsical, and is also socially awkward? These would seem to be contradictory traits. People who are socially awkward aren't charming; socially awkward is the opposite of charming. Well one class of people who are charming is people like my dad. The most notoriously socially awkward people, I tend to think would be people with autism. This is because we have a handicap that is neurologically based. It makes perfect sense to me, that these overlapping traits and conditions have an interaction in one person, and this person turns out to be a person who is quite different than anyone you've ever met.

-this feeling comes and it goes. I get incredibly distressed and I have the most horrible despair, at different times.

I'm not settling for a penny less than my last offer. I will eventually write up my terms. I have things outside of money. Money is the main thing, because I need my own place and I need to pay people to do what I can't do, etc. All of the things that I have told you over and over. And I deserve a nice life, for what has happened to me. What I'm asking for isn't really justice, but it will count for a lot. I will have gotten a lot out of my fight for justice, when there are people all over the place that are dealt complete injustice and/or who get nothing.

What I will do, when I get to that step, is write up an agreement in my own words, being the best lawyer that I can be. It will not be the final agreement but an agreement for the bank and whoever else to "agree to an agreement with substantially the same terms." Something like that I will phrase it. The purpose is so that I can get a lawyer to type up the final agreement. I will pay the lawyer well, but they can forget getting 30% for doing nothing. This is my fight, that I fought alone, except for my old psychologist John. He's the only one who ever helped me.

You want to keep this under wraps, I am sure. The best thing for you is for no one to know the actual facts of what has happened. We can do that, with the exception of my medical people. This will be my current medical people and any future medical people. They have a legal obligation to be confidential (the irony here doesn't escape me, as I say this). I have to be able to keep my evidence & evidence analysis materials, and to also make new ones, for the purposes of my medical people.

For your purposes, I will try to keep my medical people at a minimum, in terms of how many that I have. I will try not to get a new set of doctors too often. I'm good at picking people out. I also ditch people who don't have sufficient competence, and that's part of the purpose of being picky and doing my homework. I know what to look for.

It is possible, just maybe, if you want, that I allow you to debrief my medical people on this situation. I can imagine you wanting to keep tight control of it. It is such a threat to you. I'll have to think about this, because a big part of this is for you to be out of my life, completely. I can tell you that I would be good at keeping it under wraps.

Another party that may be privy to what has happened is NC DDS and the social security administration. I've already told them multiple times, and if my case is reviewed again, it's very likely that they see my evidence. They did something weird. They acted as if they believed me and then, at the same time, they acted as if they didn't believe me.

I get extremely mad thinking about this. I'm getting something, according to what I have proposed, but it's still a massive injustice and it bothers me very badly that these people will get away with this. The Charneck police

officer deserves to go to prison. So do so many others.

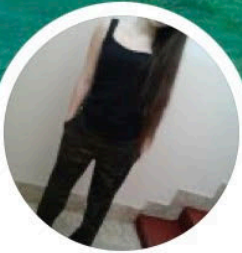

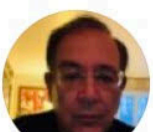

It really upsets me that these people will not suffer consequences. I know that it is hard to hear the things that I say. At least I imagine it is. I can't help it. I get mean when I think of this sometimes. I can't take a penny less than what I have proposed. The other concern is keeping my evidence, and making more materials if I need to, for my doctors. If I am going to be in the news, I need a hell of a lot more money. Being publicly know, the way that I will be if there is some announcement about this, would absolutely kill me. But I'll make do somehow no matter what. I think a lot about moving to another country. I want to live in a rich country, and Switzerland consistently sticks out as my best option. I mostly don't want to move, because I like my country and I have figured out how to get around and do things here. I get attached to what is familiar and don't like change.

Getting my sleep turned around is proving to be a pain in the ass. I'm going to guzzle some 5 hour energies later on. I got up at 6 pm, and I need to stay up until 3pm to maybe 6pm tomorrow. This moving my sleep around is terrible.

To give my opinion, this bank ought to have to pay no less than \$4 billion to me, and the people involved should be banned from banking forever, at a minimum. The \$4 billion figure I get by the simple logic that this is the worst thing this bank has ever done, and so it should have to pay the largest settlement that it has ever had to pay. CFPB hit them for \$3.7 or \$3.8, so you just round up from there. I've previously said that \$10 billion would be suitably fair, but I would be satisfied with less than that.

Of course, I have proposed less than that, for the sake of the bank being able to hide what they're doing. I would still have done quite well if I get that. My opinion on this climate emergency is that we need to get on it. Our entire capitalist system is at stake. The more the planet is injured by our activities, the more necessary it becomes to rapidly scale down economic activity. We will get to the point that we are between a rock and a hard place, and any option we take will be terrible.

Oil and coal are the perfect energy sources. That's why we've used them for so long. I'd say natural gas is up there too. These types of fuels can power our economy and power technology that is just amazing. I believe in human ingenuity. If we get on the case now, and make a massive investment in developing technology, we can save our economy and the planet. If we wait, our lifeline will be too short, and we will have to rapidly descale our economy and probably never use fossil fuels again. We will lose the possibility, that we likely already have, to fund energy intensive technology development projects, to develop technology that can put the global temperature under our control.

I have recently followed people who are either scientists or who are versed in the science of AGW, and there is science that even having cars is unsustainable and will lead to excessive damage to the environment and mass death down the road. Scientists have come to this conclusion.

If we can artificially offset the greenhouse effect, it would be within our power to initiate a period of global cooling. We could probably find measures to affect precipitation. The problem we face is that the atmosphere is going to destroy our property and cause mass deaths. It is our fault, for pumping CO<sub>2</sub>. We have 2 directions to approach this from, and the one with the best outcome is to take control of the atmosphere.
