My emails do not reflect my capacity to be rational, not perfectly. My capacity to be rational is something that for real exists. That's why there is more sanity and even mindedness in the letters that I write. In those I am thoughtful and deliberate in what I say.

That's not to say that there is no truth in my emails. There is some there, to be found. It's just that you've got to factor in what a firecracker I am, and how little self control I sometimes have.

For sure- getting in my business to any degree is counterproductive to ever settling this in any rational way. That's makes me mad as hell and makes me want to fight back and to die. Those are the 2 things that accomplishes. In that instance, fighting back is by far the dominant emotion. Saying unkind things about me to others is about 50/50 making me want to fight back, with every bit of intensity I can muster, and making me want to die. It hurts me very badly.

My self control has always been at somewhat of a deficit. My condition makes it worse. Another factor is that I am completely delusional or disconnected from what I am able to do, when I speak. I can let the whole fucking world get away with murder if need be, although that crushes my soul. You keep terrorizing me. If you put a firepoker on someone's skin they are going to react. They can't help it.

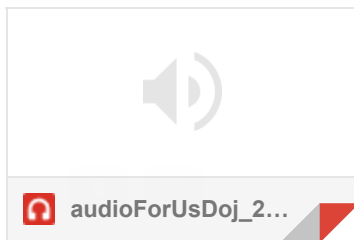

Sometimes, someone will cross their path whom they find extremely threatening, and they will become obsessed with this person. By threatening, I mean a threat to their ego. In my case, it was because I was smarter than him and intensely driven to succeed. I worked extremely hard.

He becomes obsessed with me, because he sees me as someone superior to him. That's what drives the invalidator personality type. They will seek to control the person they become obsessed with, and they will have a secret desire to annihilate them. They will act on this desire, in covert and devious ways.

He felt threatened by me and lost control of me, and I wounded his self-image + his image in the eyes of others. That's more than enough to trigger a passion against me, the likes that anyone with any sanity or rationality would have a hard time believing even exists.

Like she sent this one Analyst, who eventually became a QA, her spread back, and it looked like a football playbook diagram. It was like "this number that I've circled here goes here", indicated by a circle and an arrow that moves the number elsewhere. And then there would be comments "this is a 20 year loan!", when the analyst put certain debt balances in short term debt. There were comments like this and circles and arrows all over this spread.

It comes across as condescending but it's more a product of frustration. In this analysts case, things didn't have to be wrong. All you need is a financial statement, an example from the past where it was done right, and a telephone. If you make an effort, you cannot fail if you have all 3 of those. Often times, however, the other person can't really help it, and the fact that they can't help it is lost on the part of the person who is making the criticism.

It has been a hard thing for me to realize, and has taken me a long time to realize, that when others look at the world, they do not see the same options that I see. Their actions and their conclusions and their understanding of the world arise from this. I will see a better route or a more sensible route or a better and more accurate conclusion or understanding, and it is easy to blame it on them, particularly when their way of doing things makes life hard.

And I could have this in any news publication I want, pretty much, on not much less than a whim. It would take them time to prepare the story, because my video series covers a lot of hours. I lost count after video #136 or so, but I would say 40 to 50 hours would be close, although probably towards the lower end of that range. Actually it might be the higher end or more, now that I think of it. But the point is it's a lot and they would have to also look at my evidence. This doesn't change the fact that it is a blockbuster story for a news agency.

I could have the New York Times or the LA Times working on a story about this within 3 or 4 days. Bloomberg I could do it in just about the same, but I have a little bit of an uphill battle there. The uphill battle is a factor, but not nearly a roadblock that will put me out of the game.

Then I've got contacts elsewhere, and I could get this in their publications too.

It is no longer an uphill battle that I can't win, getting this in the news. It seemed that way for a while, but I've got this nut cracked. It is a story that is of international public interest. It is a news reporter's dream come true.

And maybe up 3 or 4 days to 4 to 6, because they would have to run it by their editors. I've got another strategy too, that would likely be on shorter timeline, possibly within 24 to 48 hours, but I like the slow and thorough approach. That strategy has a lesser degree of certainty, maybe a 95% to 98% probability. The slow and thorough approach is 100%, or extremely near it, like 99.9999%.

I would imagine that it would take someone who is very versed in the neuroscience and the underlying neurobiology of PTSD. I would say that 99% of people who are considered experts would likely find this to be out of their league, to understand or to issue any kind of definitive statement.

But the person is out there. Such a person does exist, or at the very least a team of people with expertise in different domains does. They could tell you that this is unmistakably a symptom of profound ptsd. And the question left for any skeptic to answer is how on earth did I come up with such a genuine account on my own, having absolutely nothing to go by.

The best way to judge people is by what they unintentionally let on and by what they cannot fake. This would fall into the latter category.

My app does the following-

It takes a long form tweet, up to 25,000 characters, and splits it into smaller, numbered tweets, that are as close to 280 characters as they can get, without going over.

You just type the text in my web form and hit the Post button on my web form. Your text will be posted to my backend, and my backend will process the data and return you the series of smaller, numbered tweets, on the next page.
