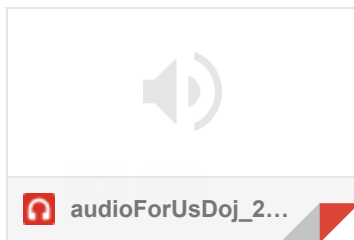

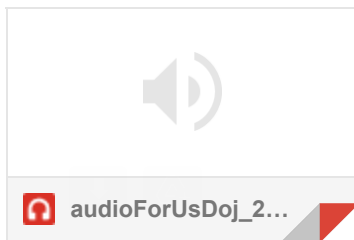

After that is done, or maybe before, I will send you an audio to explain. Once I'm done with the audio and ChatGPT, I need you to call me and set up how we work this out. We need to document things a certain way, for your purposes.

I'm also very concerned about my healthcare records and the snafu they create for you. I'm thinking you're not going to like having healthcare records that document a reason to crash the world being circulated, even if it's only among a handful of doctors. You have very big and significant interests, and this is a motivator for you.

On the flip side, I need my medical records to be accurate, and to be accurate they will document my condition accurately and they will document that my reasons for thinking what I do are legit. I need to live in the little world that I live in, in a way that is business as usual for me.

What we might have to do, if it works for you, is have someone in the Justice Department assigned to hover over my life. I don't want my privacy compromised, but if they need to explain the situation and keep it contained, that would be fine. I would prefer that it be someone high up, just because it is a serious thing and I need someone I can trust.

We may also need to have someone specially assigned to my social security case. I am a liability for some people with big interests, and it may just be necessary for them to take over some aspects of my life. I don't like that, not exactly, but as long as I am afforded privacy in a general sense, I think I could deal with it. It does bother me how I'm a liability for everyone that I know. It is a pattern that has went on for my whole life and that never relented.

But I'll deal with it, and it's better than having to manage this situation some other way. My life won't consist of all that much anyways. I have things I like to do and won't be around people much at all. I think I could overall be happy. Getting my medication upped has helped, and if my neurologist bumps it up again, I will be that much better off.

Part of this is that I have been confused the entire time. Or when I'm not confused, I am feeling confident, for some period of time, about an outcome that is totally in outer space. This is like me thinking that everyone had conceded that I was getting money out of this, and you were waiting for me to put it in the news so that I could get billions of dollars. This is nothing at all like how you think. But I have no idea what to do and why you're doing what you're doing for almost all of the time. I get anxious about dealing with you too. That's what happened after I proposed \$20 million. I was intent on settling when I said that, but then I got worried about being scammed. It's like the money goes in my account and I think I'm good, but when the federal reserve "illegally" siphons it out of my account, as some kind of tactic, I'm going to complain to who? I thought about things along these lines. Then there have been times that I've thought you wouldn't consider giving me anything that is remotely fair. That had me thinking about the media at times.

The way I work is I need to know what we're working with and how this works. When I know that, I can figure out how to get true most out of the situation for me, without compromising your necessities. It's like there's a deal to be cut, and there are certain limits, and that's what we work within. Sometimes we can get creative and extend the limits, but the functions the limits were in place for have to be kept intact. Like if the limit is "we can't possibly justify more than \$x for this", it may be that we can find a way to justify more, if we think about it, but the constraint still exists that this has to be passable to the auditors. Being passable to the auditors, in this example, is the ultimate constraint.

I'm a good investigator in contexts like this, but there are limits to what I'm good at. What my process needs to be is I turn over a complaint to the justice department, having good intentions, and the justice department tells me the process and how I get a resolution. I don't know the magic that you do behind the scenes or the mundane tasks or any of it. It's like you do this for a living, my territory is to turn you over a complaint, and your territory is to tell me what I have to do to get something out of this. I'm a peculiar person and I live in my own little world. I possibly miss the big picture quite often, and I fight back as a reflex. It's like I feel like I'm under attack and I don't think about much past that.

I am nearly dead.

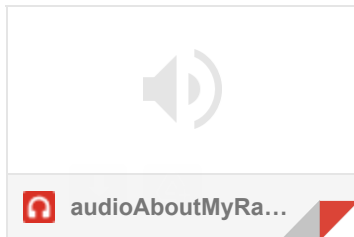

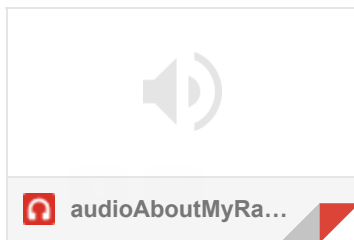

Sometimes I feel like I'm trying to crack the code, and there is no code to crack. You just want this situation to go away, and you really get amped up over it. I fight at this because I have no choice but to fight. I am a ruined human being and I am profoundly disabled. I can tell that this handicap will never go away. It is not something that is temporary.

This thing where I paced the floors 15 hours a day, craving death, going into depersonalization, having intrusive memories that pounded me with the most horrific trauma, that was temporary mostly. Some of that remains, just not nowhere nearly as frequent and the highest levels of intensity are extremely rare, I think. I'm not sure if I have even a period of a 5 or 10 seconds that is as intense as the highest levels I reached and often stayed at, back then, in terms of shell shock and trauma and the rest of it.

But this impairment, where I have this powerful inhibition that I describe in my letter to DDS, and the rest of it, it is continuous and always present and it is obvious to me that it is brain damage resulting from the repeated traumatic events in 2019. I had some sort of traumatic events after that, but the one that handicapped me was what happened in April, and then the ones that followed up had a compounding effect that obliterated me that much further.

On those 3 traumatic events, I felt myself being injured on each occasion. There was a delay in feeling the full effects of April 2019. That one started to crush me in May, extremely badly. It was a horrible feeling. Then the other ones worked kind of the same, in that they set off a process that hit me at once and then worse symptoms set in at time went on, eventually becoming permanent.

If you saw the reality of what has been done to me and the condition I am in, the only question left to answer is do you care about the consequences of your conduct and this bank's conduct on others? Your behavior adds up, in some possible interpretations of the facts, that you feel like the consequences of this bank's conduct are someone else's problem. Whose problem is that? Well rule #1 is that the consequences of the bank's conduct absolutely cannot be the problem of the bank. To allow that to happen is, in practice, the ultimate crime. Rule #2 seems to be that it also absolutely cannot be the problem of the regulators and the authorities.

Rules 1 and 2 mean that the consequences have nowhere else to fall but on the victims, who usually engaged with this bank in good faith, with good intentions, as I did.

You do everything you can for them; then they literally are willing to murder you when you want something from them, even when they rightly owe you 10x or 50x what you are asking for. 50x is by far an understatement, when you look at the whole picture. I asked for a conversation and \$0, after they destroyed my life and what I cared about most.

But we don't have to do this. We can do things differently. We can make this something good for everyone. I have also, very frequently, I am sure, lost sight of or trivialized the cost of this on you. The authorities and the regulators have paid a price for what has happened. This has been hell on you and hell on the people at the bank. I wish it didn't happen every bit as much as you do. I wish I could magically be better, but it will never happen. they asked me to fill out a page of paperwork at the clinic the other day. I couldn't and I am sure it was obvious to the girl who watched me that something very bad is wrong with me. When I get these automatic hostile reactions, that is another time that it is obvious something is wrong with me.
