Today has been a good day, as days go for me. I got up at 3 am and got to work on some of my various projects. I've been kind of in that flow state for a decent part of the day. I don't get in the flow state like I used to, before I was disabled, but I have something that is pretty close.

Life is going to be hell for the people at Wells Fargo in the near term future. I'm speaking mostly of the management at the highest level. It will be probably at least 3 weeks and likely more than that. These people did this to me and won't do nothing to help me, so I have to fight back. I'm fighting as hard as I can and I have been for years. I will be in the news almost for 100% sure, within the next year and probably a lot sooner.

I will keep fighting them until they help me and even if they do help me I'm going to write my book. If they help me, I will put in the front of my book that Wells Fargo did what they could and that I wish them well and want others to give them a chance. If they don't help me, I will include no such disclaimer, and no one will want to do business with a pack of soul murderers like that did this to me. I don't know why these people are this way.

I was the best employee this bank could ask for. I had the right education and credentials, I was talented, and I could and did work harder than anybody (although after my health got worse, that kid Patrick gave me a run for my money and actually probably out worked me many months.
