You have no idea how bad that I hurt. At times I feel a little bit bad for hurting. It's like I should be stronger, in the eyes of others, and I at times get a little bit conscious of this. Most of the time, however, I have mercy on myself and remember how strong I used to be. I can't think of anyone else who could have fought a Wall Street bank, who hits them with everything that it's got and is completely unconstrained by the law. Who else could do this, while being disabled and with \$0 income? And that was just the beginning. Anyone else would have given up a long time ago or would be dead by now. A ratio of 200 million to 1 is quite a ratio.

I have no idea what you aim to do about this, but if you help me, I will try to make this situation better for all of us. But if I get some help from this, I will have some money to do the things I like and to help people. There will be a lot of good times in-between the suffering, and it will be a life where I have happiness more often. Part of the reason that this is a better outcome for you is that if I start to get the idea that I won't

make it, I will make sure to write my book. My book will tell the story of my life and of what these people have done to a kindhearted man like me. The only way that I can write a book about the above topics and not have the whole world reduced to tears is to deliberately lie from the first page to the last. I may write my book anyways, but the difference is that I will be here to defend this bank and to say that it did what it could. This will be good for the bank, because people will listen to me and no one will care about this bank, after they read what it's done to me. What they have done to me will be the end of this bank. I cannot say for certain, but that is what I see as most likely to happen. If it does happen, then that's fair in the end. What this bank has done to me is supposed to be the end of it. Accordingly to the rules that's what is supposed to happen.
