Possibly you wonder why I haven't sent audios in a long time. More likely it never occurred to you that you should expect some or that you never noticed anything odd about the slow down. Making audios requires me to get up and be at my computer and also to talk. It is more than I am capable of doing right now and has been for a good period of time. It takes too much willpower. This apartment being tiny and my room being tiny has an effect on my ability to manage my life. The constricted space has a paralyzing effect on my brain. Constricted spaces and clutter enormously tax my brain. I can't get myself in order to use my kasina machine, not most of the time. It's what helps me a lot when I start to have symptoms.

I see the Justice Department's side of this just a little more today. This article about the bank failing and all of the commentary and panic peddling that is all over the internet, it will make you very uneasy and scare you. I can imagine the headline "former Wells Fargo employee alleges Wells Fargo had him kidnapped", this would be kind of scary to see. I think that what would need to preemptively be done is for the justice department to make an announcement. You'd have to speak first. Maybe get the federal reserve and other regulators to participate in some conference.

The scary thing about that headline is that it calls into question if Wells Fargo is going to be prosecuted or it brings forth the possibility that Wells Fargo might be prosecuted. That's what has the potential for panic. If you nuke that concern before it even starts, things would be fine. Make an announcement that you're resolving this situation and that Wells Fargo and the victim have worked it out. You could cite the fact that I want Wells Fargo to fix its business and that I'm too ill to endure a court trial as part of the reason that you are settling this the way that you are.

The terrible thing about this situation is that there is no good outcome for me. If I get a huge sum of money, that's the best for me, but I will still be in torment. Just maybe there is some super expensive, high tech treatment that I can get. I would do everything I can to keep the will to live. I am presented with alternatives that I do not like. Life is such torture, everything is so hard, and it seems like a waste. It would be murder for me to have to participate in a media shit storm and be in the public eye. People would say that this comes with the territory of being a public figure and a billionaire, and they're sort of right, except the money that I get has the function of barely making life worth living. That's the best that I can do. I don't need a bunch of burdens added on top because I'm some extremely lucky person.

It's a no win game for the justice department too, in a way. In the way that you have handled this so far, you have been as small as you can get. If you were to help me, which would involve making what has happened public news, you would be being as big as anyone could possibly be. There is no in-between, and I fear that I wouldn't be able to live up to this grand gesture, that I'm too bad off to do it any Justice.

Your problem is that I am suffering and you're going to get found out. I am making progress, even though I am doing so very slowly. I am all over the place on any given day or in any given week, but my general trajectory is to make progress in my fight. This is largely driven by my suffering and torment, and also my feeling of being dealt a terrible injustice. Human beings aren't rational creatures, and despite my analysis above and other analyses I have had, I continue to March on, even if I do it in a fumbling way. You can't pour gas on someone, set them on fire, and then expect them to sit still. It is the same with me.

Your problem is compounded by the fact that your behavior is completely repulsive. When I get this coverup in the eyes of the psychiatric and mental health community, they're going to very rightly be furious and they're not going to be the least bit concerned about panic inducing headlines, and a shit storm with the full contents of your worst nightmare just might ensue. You have been incredibly indecent and cruel. It hurts very badly the way that I have been treated and abused.

One possibility is that I put in place massive action to make sure that my new friend gets money if I die. Just to make sure, I might see if I can provoke a threat of collapsing the entire earth if you don't help her. That's a dick move, in a way, but I do it with the confidence that you will act immediately and carry out my wishes. You may not understand this, and my premises may be completely wrong. I do not think they are however, and I am dramatically the good guy and the other side is dramatically the villain. My life hurts. It makes me cry, and when I tell my story to the world, the whole world will cry, and as they cry they will hate you for what you've done to me.

I sent AU a little snippet about some of my life. It was a half a page or so and she cried. I posted something almost identical on my Facebook, and I had at least one woman IM me and say that she cried for a long time after reading it. And this is my life, the tale of a tortured and kindhearted man who has lived in such pain, who has tried so hard, and who has been so cruelly murdered. My book will be much longer than that half a page I posted on Facebook. People will find it hard to survive chapter after chapter, but I imagine they will be drawn back to it, over and over.

I guess the point is that I care about my new friend and she will have money so that her family will not have to suffer a lot of poverty. You might want to have a PR campaign in a can, for the circumstance that you have to put out that fire. I'm less likely to do that than not, by a lot, but it did cross my mind today. I care about my life and my priorities too. It's a big deal to me. I can't help but to want things to go my way sometimes. My new friend getting money is my main goal.
