My heart problem symptoms seem to be getting better pretty fast. It is the Wellbutrin that caused them to worsen, I am almost sure. I should have told my provider about my heart problems, but part of the issue there is that I am the only one who seems to think that I have heart problems. Every doctor I go to tells me panic attacks. You would think the thing to do would be to trust the doctors over me, and that's probably what he'd be required to do by the ethics of his profession. I'd bet my life against it though. My cardiologist said that he would run some tests and that panic attacks would be a diagnosis of last resort.

But what's happened, I'm almost certain, is this Wellbutrin generic medication has jacked up my blood pressure and caused me to go downhill. That's why the timing matches.

In re this situation, I want \$10 billion. I want it written out as one big check, with no strings attached. I will do everything that I can to help the bank, if that's what they want.
