

United States Department of Justice:

I desperately need your help. I have been and am being terrorized by my former employer, Wells Fargo. I submitted a complaint in March of 2020. It was not in sufficient detail. At that time, I realized that I had too much information to get across. I decided that the way to do this would be to create a web portal to house my evidence and my analyses.

It has been extremely difficult getting something done about Wells Fargo and the various entities that Wells Fargo has induced into criminal behavior. I have reflected on this, and it seems clear that this difficulty is a result of there not being detailed procedures to handle banks that behave this way. What has occurred isn't supposed to happen and defies reason. To communicate the extremity of the criminal behavior I have been subjected to, I allege in my complaint that I have been kidnapped in a scam that Wells Fargo participated in and was also largely behind.

I have all my evidence there. Much of it exceeds the file size limits set on your web portal. I am currently disabled. If you have some policy that prohibits you from collecting evidence from someone else's web portal, I ask that you consider granting accommodations for someone with severe PTSD. If that is not possible, please contact me and I will arrange some way to get you my evidence.

As previously mentioned, there is no detailed set of procedures in place to address companies like this when they get out of line. This necessitated my conducting an investigation of my own before turning it over to the authorities.

The contents and conclusions of approaching now 3 years of evidence collecting and investigation are tidily organized and streamlined on my web portal.

I can imagine the instant charge being leveled that I somehow intend to get "rich" from what has occurred. I will say that this is as of now the case. I want this bank to pay and there is no amount of money that is worth what I have been through and will now live. I am almost certainly disabled for life and I experience terrible and profound distress every single day. This was not my goal from the outset, however. Wells Fargo committed civil wrongdoing that had disastrous consequences for my life. I asked to be told the truth and to have a conversation. I asked for this dozens of times, under the condition of no consequence at all to Wells Fargo or anyone else. I at one point offered to sign a nondisclosure agreement. Wells Fargo responds by massacring my existence and permanently damaging me and my life in a way that is beyond repair.

I understand that criminal authorities have no interest in civil matters. It would however be helpful to have procedures in place that make it easy to catch them in the act when they pay off any lawyers I hire, payoff the judges, payoff the bailiff, payoff the appellate courts, and payoff everyone else. What we have is a tyranny that does as it pleases. In my case it is every bit as ruthless as Saddam Hussein's regime and most likely far better funded. This bank engages in crime to the extent that it would seem to me warranted to surveil everything they do 24 hours a day. I cannot surveil them and no one else cares to and I am thus in a battle I will never win. Wells Fargo is my government. It is what rules my life. I have every reason to believe it has the capacity to rule anyone else's life at its leisure.

We have an institution with such contempt for others and others' rights and such wanton criminal ambition that it takes this level of offense at the notion that it may have to tell the truth. The rest of the world knows Wells Fargo as Wells Fargo portrays itself in its public image making activities. I know Wells Fargo as Wells Fargo is when no one else is looking. It is quite a different picture and it is far from pretty.

Wells Fargo has induced into crime my hospital, Atrium Health. They have also induced into crime a local crisis line and the Charlotte-Mecklenburg Police.

At the point that I inform Atrium Health of the crimes involving Wells Fargo and Atrium's hospital, Atrium had a few options. One option was to turn in their corrupt healthcare professionals. Another nonexclusive option was to fight Wells Fargo. The easier option, in their minds, was to jump in the dogpile, violate my rights, and victimize me in an effort to evade consequences for what the hospital was involved in. The last option was the one they opted for, and I am now subject to a dogpile of a \$2 trillion bank, a \$12 billion healthcare corporation, and anyone within their budget who can be bought off, which I estimate to be my entire city if not half the globe. I am subject to this dogpile while being disabled and destroyed.

All of this is elaborated in my complaint. I am a kind hearted man who has tried very hard to be the best person he can be. I am also extremely different. I do not recall seeing any law that it is a crime to be different, but perhaps it is. I am suffering and they are not. The crimes that have been committed include white collar crime and a deliberate violation of my constitutional rights. This places many of them under your jurisdiction and the jurisdiction of the F.B.I. I request that you forward a copy of my complaint to the F.B.I. I am not sure who may want to help me, but I can tell you that I have been subjected to crimes that are sophisticated and which involve diverse subject matters. I am very conscious of the fact that I am asking for resources, and I will do what I can to help you.

I am also conscious that I am sending this complaint in the midst of a pandemic. I would like for there to be a win-win, meaning that America and even Wells Fargo comes out better in the end. Our economy needs Wells Fargo to act ethically and be the company that is once was, rather than the criminal enterprise it has mutated into. Atrium Health has many people relying on it during a very difficult and dangerous time.

I am fully aware of and of the opinion that my rights and my needs do not trump those of the rest of America, who may be collateral damage if Wells Fargo is punished harshly for what they have done to me. My rights and needs also do not trump the needs of the population where I live and in surrounding areas. The big players in these crimes have an arrangement where the consequences of their wrongdoing are disproportionately paid by innocent third parties. I am in a pickle, as it relates to all of this, because I cannot live like this. I did nothing to deserve this. My existence has been destroyed and my life as I am living it is not much at all preferable to death, due to the extreme pain I spend most of my days living in. Please help me if you can and I will help you in any way that I can.
